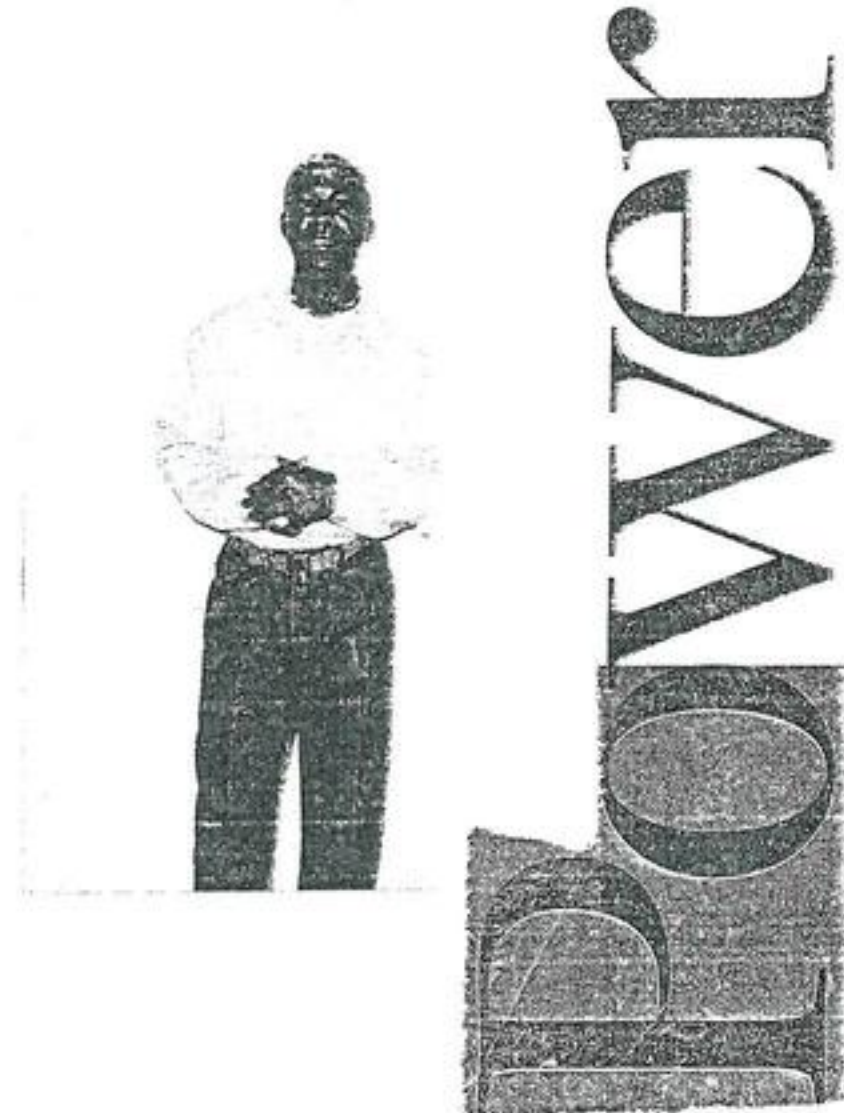
The present documents of title are:

- 2. BLANK INDORSEMENT-One which specifies no particular party to whom the indorsed instrument is exclusively payable, and which therefore authorizes negotiation by the bearer upon delivery alone. U.C.C. § 3-204 (2).
- 3. RESTRICTIVE INDORSEMENT.-One which is conditional, which places restrictions on transferability through the use of certain words, including " for collection " " for deposit " " pay any bank " Id. at 3-205

;and

- 4. SPECIAL INDORSEMENT.-One which specifies the party to whom or to whose order the instrument shall be payable; the instrument is then negotiable only by such person unless he makes a further indorsement.
