Thank you for the comments i'm real glad that you like my Posts. Since you like this story you will need to read more. I have Portal photo's etc along with the Pelican Bay Reports. Everyone needs to like all the Pelican Bay Story's. It was the worst 13 yrs of my life but it was interesting. I learned a lot there. That is a real California Prison. The point i'm at now is nothing like "PBS" Pelican Bay State Prison that was a level 4 maximum security Prison and this is a level 3 mellow point. Its a real old Prison and its still run this way today. In a way that's a bad thing due to it being 2013. They need to update everything. they do have computers but its still run like it did back in 1950's. The old Prisons in California are San Quentin, C.N.C, old Folsom, Soledad, Tracy i think that's the old ones. You mentioned the 3 strikes law to me i am in here under the 2nd strike law. which means that i was in Prison and got 1 strike then this one that i'm in here now is my 2nd Prison term and strike my 2nd strike doubled this sentence that the judge gave me. The 3 strike will give you 25 to life.

my Problem is this i was convicted of a 187 and a few other charges so the judge used the 2nd strike on me which means double your sentence so i got 50 yrs to life for the murder and the other charges he doubled them as well. I have 68 yrs to life. I cant do it Alex. By the way alexandria is a very beautiful name. I have done 19 yrs so far my Parole date is 2054 and my bday is Feb 28th i will be 43. The judge really fucked me over. He wasnt by California law suppose to double both of my sentences but they do what ever they want when all you have Representing you in court is a Public defender. They hung me out to dry. But the Bright Point of this if there is one is the laws in CA are starting to change and if im lucky i will get my Sentence Reduced who knows maybe ill get to be with my family again someday. So can they make you do at least 30 yrs on a 25 to life term so i need to get that First Strike taken off if i ever want to get out. without a Paid attorney i doubt i ever see the streets again. I have missed every thing is out there. If you need some of my posts you will see that we have experienced much in my life. I've been locked up most of it. ~~most~~

I have never been married, no children, never a drivers license
never had a ticket, never owned my own car. There is much
more i have never experienced "shit". I am street smart, wise
about Prison life. I know all about Prison due to the
Prisons i've done time at. I have over 20 total yrs in.
If you have any questions about the point get at me.
As far as Relationships we have lots of girlfriends
but like i said we been locked up 20 years of the 42
that we been alive. I have been single for 19 yrs now.
Its hard to find a good woman when your doing life.
There are a lot of females who see my Photo's and i would
guess they would want to get to know me but would
they really want to fall in love with a man who dont
get family visits. Think about it like this if a female
hooked up with me she would always know where i
am at. I couldnt cheat on her i wouldnt anyway. She
would get all the attention she would ever want though
the mail and visits she would have her life on
the streets i would never know what she was doing.
In a way it would be perfect for her. She would have
me all here and doing what she wanted out there
without me knowing. I would never want my girlfriend
out there doing who ever she wanted but how
would i stop her. Honestly a woman has to get laid
and in a life no they wont allow me to be alone
with my girlfriend. I couldnt expect her to not get laid.

With that being said now you know why i have been
single for 19 yrs. am i lonely yes of course i am but
i cant do anything about it so i just stay single
till some female reads my Blog and decides that
she wants me in her life. I will not try to find
a sl body through this Blog but maybe ill get lucky
and find the right body for me. I feel that day comes
i will spend most of my time in the Prison law
library trying to file to the courts to get a new
Trial or a Sentence Reduction. The courts are
charging in California, the Prison System is over crowded
and after 19 years i see some light at the end of
the tunnel for me. As soon as i can hire a attorney
to represent me i will get a parole date. Right now
i have a life sentence 68 yrs to life but if i get
a attorney he or she can get me out that's a fact. But
getting a attorney costs & and i dont have any. So far
now i will stay in this Hell Hole. The courts made
enough mistakes that a good attorney could get me out
but like i said i need a attorney to take a look
at my case. If i ever want to see the streets again
i will have to use this Blog to get a attorney. Its
going to be hard but i wont ever give up. I live
Hope that someone will help me.

Its crazy to think abt all tht is keeping me in here
is the fact abt i dont have the \$ to Hire a attorney. It
is keeping me from getting out of this cage. I pray tht
someday someone will read my Blog and want to help
me figure out a way to Hire a attorney. First i need
to set up a PayPal Plan and Raise the funds to Hire
the attorney. There is so much \$ spent down on Bullshit
out there and to think abt it could get me out. Its very
frustrating sometimes. I can Paint Paintings, Draw Cards things
like abt are the \$ to hire a good attorney. I thought by
now tht i would meet a female abt has a attorney in
her family and could get help that way no for no luck. I
make \$12 a month working here and after Restitution i got
\$5.40 to live on i cant even live on that. I cant even buy
a jar of coffee with that. Some day im going to write
about my case my Trial so people can see for themselves
abt i didnt kill anyone. The Problem is i have been told
to never talk about my case on my Blog due to anyone
in the world can read it so i wont. Im learning a
little bit about the law and i will file Paper work
to the courts to get my sentence Reduced. But im a
convict not a attorney how can i get myself a Parole dot?
my family dont have the \$ to hire me a attorney or i
would have get out by now.

I have a great family who love me and want me home
but we just don't have the \$ to make it happen. Its real
and i hate it when they cry over me being here. Anyways
the 3 strike law is what doubled my sentence and i have
to get 1 of my strikes taken off then ill have a chance at
getting out. If i can get this 1 strike taken off then
my sentence would be 25 yrs to life. I get 19 yrs in so
I'll have a real good chance at going home. If you
read my blog comments alot of people are starting to write
to me. Just think maybe a attorney will write me on my
blog and want to help me. It could happen. Someone
who is rich may write me and say Hey Donnie i hired
you a attorney he is coming to visit you. Someone may
take a chance on me. I'm not ever going to give up. I
will get out again. I just don't want to be in here no
longer than i am and cant make it out there ya know. I
am a optimist i have no kills. Its almost went time
so i need to get this in the mail. alexareina thank
you from the bottom of my heart for the comments on my
blog. I would like to talk to you more.
