IM ALSO HOPING / PRAYING THAT I CAN SALVAGE THIS 2013. ITS ONLY FEB SO JUST HOLD ON AND TRY AND ENJOY THE RIDE. WHERE DO I START? LETS START OFF BY EXPLAINING HOW THE HOLE POINT SYSTEM IN PRISON WORKS AND HOW THAT DICTATES WHERE A CALIFORNIA PRISONER DOES HIS TIME. THE BEST WAY TO EXPLAIN IT IS THE MORE POINTS YOU HAVE THE WORST MOSTLY WORST PRISON YOUR AT IN CALIFORNIA THE PRISONS ARE IN LEVELS / POINT LEVELS. MAX PRISON "MAXIMUM SECURITY" BEING THE MOST DANGEROUS ARE LEVEL 4 PRISONS. LEVEL 3 AND 2 AND 1 ONE BEING VERY MELLOW LOWEST SECURITY NO ELECTRIC FENCES & NO GUN TOWERS ETC. IF YOU HAVE A VIOLENT CONVICTION + ALOT OF YEARS TO DO YOU GO TO A LEVEL 4. LESS YEARS LEVEL 3-2 SO ON. I SPENT 13 YEARS AT PELICAN BAY MAX SECURITY LEVEL 4 DUE TO MY CHARGES AND THE AMOUNT OF YEARS I WAS SENTENCED TO. RIGHT NOW I WAS A LEVEL 3. CMC IS A LEVEL 3 MEDICAL FACILITY. I HAVE BEEN HERE FOR 4 YRS. WHEN EACH YEAR PASSES BY AND A INMATE IS DISCIPLINARY FREE / WRITE UP FREE YOUR POINTS DROP LOWER. I HAVEN'T HAD ANY WRITE UPS HERE TILL JUST RECENTLY, SO FOR 4 YEARS MY POINTS HAVE DECREASED. THEY HAD DECREASED LOWER THAN I THOUGHT AND NOW IM A LEVEL 2.

Which means I have to be transferred out to a level 2 prison. So look in 2013 I got a write up and in 2012 Dec I got a write up. Due to the fact that I got 2 of them in a 6 month period the prison has punished me to the fullest and beyond. I'll explain all the different punishments in a min. OK now when a inmate gets a serious 115 "write up" the prison ~~adds~~^{adds} points to you. I as I said got 2 serious 115. In Feb a few days ago the program called me in for classification. They looked at my points and said I'm ~~still~~ a level 2 inmate now even though I got points for the write ups. I was write up free "being good" for so long that even with the 2 write ups I'm still a level 2. So do I want to be a level 2 "NO". First of all I have lived in a 2 man cell for going on 20 years and now that I'm a level 2 they want to transfer me to a level 2 dorm living setting. Which is bunk beds in a shack. It's small no privacy. It's all short timer inmates. Always Gang Banger Youngsters/Black Ghetto and Hispanic's. I'm a lifer and I've been in a 2 man cell for almost 20 yrs I don't and will not be able to do the rest of my life in a dorm with disrespectful youngsters who have no clue about doing time. Who haven't never been to a real prison violent prison. + all of them are going home. It's a revolving door of short timer inmates. Why do I have to subject myself to that and everyone knows it's not going to work. I will end up in the hole when they put me in a dorm.

DO I WANT TO BE TRANSFERRED OUT? NO I WANT TO STAY here. I explained to classification that I won't do ~~fine~~ time in any dorm period ITS A WRECK WAITING TO HAPPEN. DO THEY CARE OF COURSE NOT. SO ANYWAY here is the punishment for the write ups. ① I'll be transferred out. ② NO PHONE CALLS FOR 6 MONTHS ③ NO "PACKAGES-CARE" FROM HOME. ④ NO VISITS 1 YR. ⑤ I WAS MOVED AWAY FROM MY CELLMATE TO ANOTHER CELL + A NEW CELLMATE. ⑥ THEY CAME AND TORZ UP MY CELL, TOOK MY TV/WALKMAN + ALL MY PROPERTY. LAST BUT NOT LEAST I HAVE TO BE LOCKED INTO MY CELL AT 1PM MON-FRI. WEEKENDS/HOLIDAYS ALL DAY LONG NO YARD. SO ANYHOW THEY HAVE TURNED MY LIFE UPSIDE DOWN. IM SCREWED. I LIVE FINANCIALLY OFF OF THE PACKAGES MY BROTHER ORERS ME. THE PACKAGES HAVE ALL MY TOOTH PASTE-DEODORANT SHAMPOO-COFFEE ETC. OW THEY ALSO FIRED ME FROM MY JOB. I DONT KNOW HOW IM GOING TO MAKE ENDS MEET NOW. IM VERY STRESSED OUT OVER ALL OF THIS. THEY PUT ME IN A POSITION THAT MAKES MY LIFE VERY HARD TO LIVE. IM IN MY CELL WRITING THIS BLOG ITS VERY QUIET. IS THERE A POSITIVE NOTE TO ANY OF THIS? I DONT HAVE ANY \$ SO I CANT GO TO THE STORE AND PURCHASE ANYTHING. ILL HAVE TO FIGURE OUT A HUSTLE TO MAKE ENDS MEET. THE PRISON TAKES 55% OF ANY \$ SENT TO ME SO IT WOULD TAKE 100 DOLLARS SENT TO ME JUST TO GO TO THE STORE FOR 45 DOLLARS. OW ITS SUCH A MESS IM IN. I DOUBT ANYONE SENDS ME A SAY PAY TO MY ACCOUNT DUE TO THE 55% RESTITUTION THEY TAKE FROM ME. LIFE IN 2013 HAS STARTED OUT SO BAD. I MIGHT AS WELL BE IN THE HOLE AT THIS POINT WHAT DO I HAVE TO LOOK FORWARD TO,

IF THEY TRANSFER ME TO A DORM WHEN I GET THERE I CANT HAVE MY FLAT SCREEN 13" COLOR TV. MY BROTHER BOUGHT IT FOR ME 2 YRS AGO. TV'S NOT ALLOWED IN A DORM SO THEY WILL GIVE ME THE OPTION OF PAYING OUT OF MY POCKET TO HAVE THE TV SENT SOMEWHERE ON THE STREETS. ITS A \$300 TV. LOOK THOUGH IF YOU DONT HAVE \$ ON YOUR ACCOUNT TO MAIL OUT THE TV GUESS WHAT I HAVE TO EITHER DONATE IT OR THE PRISON WILL DISPOSE OF IT. SO LAST BUT NOT LEAST I WILL NO LONGER HAVE MY TV THAT MY FAMILY BOUGHT ME. THE PUNK ASS PRISON WHERE I END UP WILL THROW MY FLAT SCREEN AWAY OR GIVE IT TO ONE OF THEIR "INMATE RATS." YES MY FRIENDS THINGS HAVE WENT DOWN HILL 4 ME. I DIDNT DESERVE ALL THIS CRAAP THEY ARE PUTTING ME THROUGH. I HADNT HAD ANY WRITE UPS FOR 10 YEARS OR SO THEN I GOT 2 WITHIN 6 MONTHS AND THEY VICTIMIZE ME. IN ALL THE TIME IVE DONE THIS IS BY FAR THE WORST OVER ALL THAT THE SYSTEM HAS SCREWED ME. ITS ALMOST DINNER TIME NOW SO I GUESS ILL LET YOU GUY'S GO FOR NOW. I DONT LIKE WRITING SUCH NEGATIVE POSTS BUT I WANTED EVERYONE TO KNOW JUST HOW BAD THE CA PRISON SYSTEM DOES US. "BRUTAL"

HERE IS THE BRIGHT PART OF IT ALL ILL NOW HAVE PLENTY OF TIME TO POST LETTERS ON MY BLOG. HOPEFULLY I GET PLENTY OF COMMENTS TO RESPOND TO. ILL BE DOING PLENTY OF CELL TIME.
