I THOUGHT IT STARTED OUT LIKE SHIT BUT WAIT TELL YOU HEAR HOW APRIL IS GONA WORK OUT. FUCK ITS ALL BAD AND IM NOT SURE THAT ILL BE ABLE TO GET MY ASS OUT OF IT. SO HERE IS MY SITUATION AS OF APRIL 1 2013. LAST WEEK MY COUNSELOR CALLED ME IN FOR A PRE INTERVIEW DUE TO SHE HAS DECIDED TO TAKE ME BACK IN FRONT OF THE CLASSIFICATION BOARD. SO SHE TELLS ME BAD NEWS. FIRST LET ME RUN THINGS DOWN SO YOU WILL UNDERSTAND MY HOLE SITUATION. A FEW MONTHS BACK I GOT 2 WRITE UPS AND MY COUNSELOR CALLS ME IN SHE TAKES ME IN FRONT OF CLASSIFICATION THEY PUNISH ME FOR THE WRITE UPS. THE PUNISHMENT WAS WHAT IS CALLED COVER C STATUS. WHICH MEANS THEY FIRED ME FROM MY JOB AND IM TO LOCK UP IN MY CELL MON-FRI BY 1PM. NO YARD ON WEEKENDS OR HOLIDAYS EITHER TOOK 12<sup>DAYS</sup> TIME FOR EACH WRITE UP. NO VISITS FOR 1 YEAR AND CONFINE TO MY QUARTERS CELL FOR 1 MONTH. NOW THIS COVER C STATUS ALSO MEANS THAT ILL HAVE TO LOCK UP AS I SAID 1PM EVERYDAY, THIS WILL BE FOR 6 MONTHS. SHE CALLED ME A PROGRAM FAILURE.

LEFT IT A MESSON MESS PAPERS EVERY WHERE COFFEE ALL

OVER THE FLOOR. THEY TOOK MY TV DIGITAL FLAT SCREEN, MY

DIGITAL ANTENNA, SET OF SONY EAR BUDS. SO ANYWAYS

THIS PRISON IS MAKING ME PAY TO SHIP THESE ITEMS TO

THE STREETS. HERE IS MY PROBLEM I HAVE NO \$ ON MY

ACCOUNT TO USE TO SEND MY SHIT TO WHERE EVER.

ON APRIL 29<sup>TH</sup> 9AM THE GUARDS WILL DONATE-DISPOSE OF

MY PROPERTY. THEY WILL MOST LIKELY JUST GIVE IT TO

SOME PRISON RAT. SO RIGHT NOW THEY SCREWED ME BIG TIME.

NOW LOOK THAT ISNT EVEN THE WORST OF IT ALL. YEA THERE

IS MORE TO THIS FUCKED UP YEAR. NOW ON APRIL 16<sup>TH</sup> I

WILL GO TO CLASSIFICATION AND MY COUNSELOR IS ASKING

CLASSIFICATION WHICH CONSISTS OF A AW. ASSOCIATE WARDEN

A CAPTAIN AND 2 COUNSELORS TO TRANSFER ME OUT

OF THIS PRISON TO ANOTHER PRISON WHERE I WILL GET

"WHACKED" STABBED FOR BEING HERE. WHY THEY WILL STABB

ME IS DUE TO THIS PRISON IS A JOINT THAT HAS

RAPIST/CHILDMOLESTERS, RAIS WHO WALK THE YARD. SO WHEN

I GET TO WHERE THE BUS TRANSFERS ME TOO IT WILL

BE A YARD WHO ALL THE WHITES WONT ALLOW ANY INMATE

TO WALK THE YARD WHO CAME FROM A PLACE LIKE IM

CURRENTLY AT. SO NOW I GOT TO TRY AND TACK

MY WAY OUT OF THIS TRANSFER.

SO MY LIFE HAS REALLY WENT TO HELL IN A HANKBY. SEE THIS PRISON I'M AT HAS NO PRISON POLITICS. ITS THE MELLOWEST JOINT IN CALIFORNIA BUT THERE ARE SEX CREEPS WHO WACK THE YARD AND WHEN THEY TRANSFER ME ILL GO TO A NORMAL YARD WITH NO SEX OFFENDERS THEY WILL NOT ALLOW ME TO STAY DUE TO WHERE IM AT NOW. IM IN A BAD SITUATION AND I DONT KNOW HOW TO GET OUT OF IT. IM GONNA ASK THE CLASSIFICATION TO LEAVE ME HERE AND PROMISE TO BE DISCIPLINARY FREE. WILL THEY DO IT PROBABLY NOT DUE TO THE GUARDS-STAFF. THINK OF ALL INMATES AS CATTLE. ALSO AS FAR AS MY TV-PROPERTY GOES ILL NEED SOMEONE TO PUT \$ IN MY ACCOUNT BEFORE APRIL 29TH OR MY TV WILL BE DISPOSED OF. MY BROTHER PAID ALMOST \$300 FOR MY TV-ANTENNA, SONY EAR BUDS AND THE GUARD WILL THROW IT AWAY DUE TO GM ON C-STATUS. HERE IS ANOTHER PROBLEM I OWE \$10,000 RESTITUTION SO CALIFORNIA TAKES 55% OF ANY \$ SENT TO ME. SO IF I CAN GET \$ SENT ILL HAVE TO SEND SOMEONE SO THAT AFTER RESTITUTION I HAVE SOMEONE LEFT TO MAIL THE PROPERTY TO THE STREETS. WHO ON THE STREETS WANTS A 13" FLAT SCREEN TV, A DIGITAL ANTENNA AND EAR BUDS. NO ONE WANTS THAT CRAP OUT THEIR. MY BROTHER DONT WANT THAT CRAP. HE WILL BE MAD AS HELL IF HE GETS THAT PROPERTY THAT COSTED HIM \$300. I FILED A APPEAL EXPLAINING THAT I HAVE NO \$ TO SHIP IT OUT. PLUS IM A C/FER SO I EXPLAINED THAT THIS IS MY HOME I HAVE NO HOME ON THE STREETS TO MAIL IT TO EVEN IF I DID HAVE THE FUNDS TO SHIP IT OUT.

HOW I WAS ~~DEAD~~ ~~DEACT~~ A BAD HAND ETC. I LOST MY LIFE IN 1994 DUE TO DRUG ABUSE AND A FRIEND OF MINE SHOOTING SOMEONE IN FRONT OF ME AND MY GIRLFRIEND. WE ALL GOT LIFE SENTENCES OVER HIM KILLING SOMEONE. I WAS CONVICTED IN 1995 AND A FEW MONTHS LATER MY MOTHER PASSED AWAY THEN MY STEP FATHER 2 MONTHS LATER. I WAS SENTENCED TO 68 YRS TO LIFE AFTER THAT AND SENT TO PELICAN BAY STATE PRISON.

I TALK AND NOT WRITE SUCH BAD UGLY POSIS ON MY BLOG BECAUSE IT JUST MAKES PEOPLE WHO READ IT FEEL BAD 4 ME. DONT OK I DONT WANT ANYONE TO PITY ME. THANKYOU SO VERY MUCH FOR YOUR KIND WORDS. PLEASE PRAY FOR ME I NEED ALL THE PRAYERS I CAN GET. APRIL WILL SUCK. I DONT KNOW WHAT IM GONA DO ABOUT MY TV AND I CANT THINK ABOUT THE TRANSFER ITS A NIGHTMARE.
