Citizen: As a member of a Nation or political Community one OWES Allegiance to, And may Claim Protection And Their Rights From the Government. 153 N. E. 13, 17 under the Constitution. All Persons born or Naturalized in the United States, and Subject to the Jurisdiction There of. ARE Citizens of the United States AND of the State in which they Reside. The US con. 14th Amendment.

Citizenship is the Status of Being a Citizen. In the U.S. there is USEFULLY a double Citizenship, That is, Citizenship of a Nation, and a Citizenship in the State in which one resides.

Generally in the U.S. one may Acquire Citizenship By Birth in the U.S. or by Naturalization therein S 9 S. c + 884.
