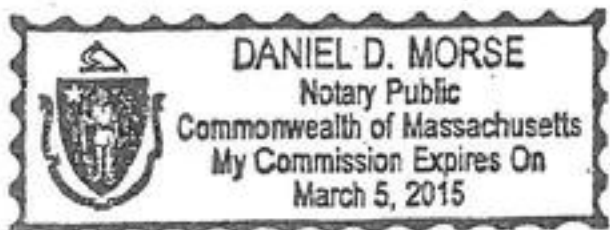



I have received your letter dated May 28, 2013 regarding inmate Frank Soffen and your request to visit him one hour every other week. Your request is denied. Inmates are not permitted to visit in the HSU. Be assured that Mr. Soffen has available to him the assistance of the MCI-Shirley Librarian, as well as that of the inmate law clerks, whose job assignments and training are specifically designed to meet the needs of inmates such as Mr. Soffen. No inmate may specifically request that an inmate, not assigned to an inmate work assignment pursuant to 103 DOC 450 and MCI-Shirley work assignment policies, provide assistance to him.

I trust that this letter addresses your concerns.
