

## AFFIRMATIVE ACTION : A Masonic Injustice

Sometimes we innately perceive an injustice being committed, yet lack the clarity of insight to understand what, exactly, is the source of the problem. And our inability to expose the underlying principle that leads to the injustice leads us to fall prey to powers and groups of men who seek to pass off error as Truth, leaving it to spawn further bitter fruits of injustice later on, never realizing that they ooze from the same rotten and diseased root. Affirmative Action is just another example of the falsity of Masonic ideals that have been zealously indoctrinated into the minds of the American people and thwart our ability to accurately react to the world and creation around us.

Affirmative Action is implemented by and at the instigation of the American Government, allegedly to "erase inequalities caused by past injustices". The assumption ~~that~~ is that anywhere inequalities between racial, ethnic, or gender types may be found, it must be the result of some past crime, no matter how remote. That no other cause for such inequalities can exist. This is quite a presumption. For a modern, secular society that criticizes Catholics for Faith in Dogmatically revealed Truths, it appears hypocritical, at first glance, to blindly accept the Doctrine of Equality on sheer faith alone, without vigorously testing it's veracity.

Affirmative Action has been challenged repeatedly in the Masonic US Court system by various groups and individuals who feel that they have been the victims of injustice by such practices and policies. It governs and controls the selection and promotion of individuals in Government and military positions of authority, positions of power in Academic Institutions receiving federal funds, college admissions, and even the so-called free-enterprise system of private businesses as varied as the National Football league. To be an Equal Opportunity Employer in 21st century America means no such thing. It means, rather, that said employers will impose double and triple standards of unequal hiring and firing criteria to achieve an artificial racial/gender/ethnic/sexual preference balance imposed on them from above.

For the uninitiated, such inequalities as this are common: Suppose X college has 5,000 openings in a semester, yet 6,000 applicants. Some selection process must be implemented to decide who is accepted and rejected in that year. Historically this was done by S.A.T. or T.A.S.P. test scores- the highest scorers being admitted and the lowest rejected for that semester. However, government hawks noticed that when such non-biased criteria are implemented, sometimes the Asian and Caucasian demographic groups are admitted at a higher rate than Mexican or black ethnic group members are. So to achieve, for instance, a flat 13% black college admission rate to coincide with a 13% black US population rate - various unequal race based criteria assistance is given to boost their admission rate at the expense of higher qualified Asian or Caucasian group members. It is not uncommon for blacks or other underrepresented minorities to receive bonus points on admissions exams for no other reason than that they are the member of an 'under-represented minority'. So a situation results in which an Asian may be denied college admission even though he/she was higher qualified than a black applicant. The complaint is that this is unfair as the Asians higher test score may be the result of more effort to study and learn being applied in his part at the sacrifice of

his indulging in more partying or other recreational activities.

But Affirmative Action is not limited to college admissions. The less qualified are given higher positions of authority in Police Departments, in the Military, in School systems and any other organization under the influence or control of Washington. A common rhetorical question exposes the dilemma: Who wants a doctor to operate on them or their children that is unqualified or underqualified to even be a doctor, and simply is one to fill a government quota to hire more black doctors, no matter how unskilled he may be? No one does.

Interestingly, Affirmative Action as coerced by Washington only extends one way. A few years back it was brought to the attention of some desk jockey in a Washington think tank that black quarterbacks in the NFL were severely underrepresented in a minority dominated sport. Amidst cries of racism, the NFL submitted to alter policies concerning the hiring of quarterbacks to comply with Affirmative Action. Now, when an NFL team desires to hire a new quarterback, before they can make a final decision, they must waste precious time and resources soliciting and interviewing 3 minority candidates before they make the final decision, or else, suffer the penalty of heavy fines. It doesn't matter if they are pressed for time and wishing to start a newly acquired quarterback that coincidentally happens to be white, nor does it matter if they have spent countless dollars and time acquiring the best man for the position if he happens to be white. It doesn't matter if the white candidate is highly experienced, qualified and has been in the league for 20 years...nor if the minority candidates are unqualified, untested, and right out of college...

The flip side, however, doesn't apply. One could argue that blacks, who make up roughly 13% of the American public are severely overrepresented at around 80% of NFL runningback positions, or conversely, that whites, who constitute roughly 64% of the American public, are severely over underrepresented in Runningback positions. Will the government next force the NFL to hire underqualified white runningbacks to erase any semblance of inequality? Can't we see how this destroys any competition or excellence?

Equality is a Masonic doctrine and a Communist dream. It has no basis in reality. The entire order of creation is governed by "Differentiation" Everything is created unique, and with varying potentials to realize a specific purpose in the world. We are each designed and molded for a specific mission. It's called job specialization in the workforce, without it creation, as we know it, would fall apart as no creature would have the ability to excel in anything at all. This is not limited to humankind. Even beasts of burden reflect this basic immutable Truth. If every horse was created equally- where would the potential of the racehorse be found? Or the workhorse? The superiority of each would be destroyed.

The myth that such inequalities exist because of the past crimes of the American people or their ancestors will neither be held up under the scrutiny of cross examination. Such demagoguery is imposed to induce feelings of guilt in Americans and erode their opposition to such clearly unjust policies of Affirmative Action. It's not the fault of any people that inequalities exist in the world, despite the accusations of the masonic educat-



ional (or more accurately "indoctrination") system of the Dept. of Education. Such inequalities simply are.

In fact, given that 1 out of 8 Americans are foreign born, the black or Hispanic minorities which are overrepresented by such immigrants, were not even present to experience such "past crimes" that caused such inequalities in the first place. Some other reason for those inequalities must be sought. Nor have the 'past systematic injustices' failed to hinder or prevent the equally newly arrived Asian immigrants, who appear to be overqualified for numerous positions, from prospering. A little reflection will reveal that the accusations of foul play being the result of Differentiation in human potentials and abilities is a farce. A little reflection will reveal the folly of accepting punishment for past fictitious crimes. A little reflection will reveal that accepting the delusion of equality results in numerous other delusions being implicitly accepted as correlated facts that result in further injustices and lies being accepted by the American people.

Our Lord told us that He was the Truth. He teaches us Truth through His Holy Church. Anything opposed to the Truth, no matter how appealing it may sound, or good it may be presented, or even how much we wish it to be true...is simply not true. When our perceptions of reality conflict with reality as it actually is, reality does not, and will not, suffer or yield; we will! Just as God acts and teaches and works through His people, The Church, Satan also uses men and organizations to do his will. We can distinguish who his followers are by the bitter fruits they produce and the ways they go about achieving their ends. The Freemasons openly admit that they accomplish their ends by means of deception. We can know this by the thousands upon thousands of books that their own high ranking members have written.

Admittedly, getting to the truth of the matter is difficult, if not impossible, as many of them contradict each other, and even accuse their own ranking members as being pathological liars, and openly boast of the numerous instances in which they have set events in motion that led to the executions and destruction of their own Masonic brethren in the lower degrees, or the fools that believed they had their best interests in mind and naively trusted them. But even these facts are indicative of the god they serve.

Jesus clearly told us that the father of lies was the devil.

The motto of the Freemasons is "Liberty, Equality, and Fraternity". Ideals that sound alluring to the ears, albeit in direct contradiction to the Truth. Catholics have our Dogmas which we are criticized for having. Believing in Truths wholeheartedly and molding are actions and lives around them, but our critics are no different in that regard except that the truths they hold are lies. Nowhere is this more evident than in the Masonic American Constitutions opening words: "We hold these truths to be self evident: That all men are created Equal" The evidence of the Freemasons role in the construction of the early American government is beyond dispute. Almost all of the founding fathers were known and admitted Masons. This was in direct contradiction to most of the American citizenry, who were unaware of Masonic goals and agendas.

The Catholic Church and basic human reason expose the utter falsity of the Doctrine

of Equality. We are all created differently, uniquely and with varying potentials, that we may or may not realize. The Bible supports this, especially in Romans 9 verses 20-24. It realtes how God creates us each for a specific purpose in His Providence, a purpose He has for us alone, that cannot be compøeted by another. Other passages of the Bible relate that He scatters His gifts around so that we will each need each other and have some way in which to serve and love each other, ways so that none of us can be completely independent and without need of others.

Science teaches the same. The "Tabula Rosa" theory of psychologists has been relegated to the dustbins of academic thought long ago. Under this medieval theory each child was born as a "Blank Slate" into this world and that if a person could control the entire environement of a child, he could shape it into anything he desired...an engineer, a nuclear scientists, a world leader, or a prostitute or junky, etc... This theory completely denied the influence of genetics or the existence of natural aptitudes and abilities or DNA hardwired genetically acquired behavioral patterns and traits.

WE know today that genetics play a major role in who we are, and that they cannot be controlled or selected, or modified, once born. Some people are born with the ability or potential to teach, others to lead, still others to invent and create...we are all different, science even teaches us this irrefutable fact.

The Chuchr teaches us the error of the Doctrine of equality. Saint Maximillian Kolbe, who was executed by the Nazis, teaches that "Truth alone can be and is the solid foundation for happiness for individual beings as well as all mankind...Even if their were two people in all the world, still in no way could they be able to observe absolute Equality. There are in all the world no to things that are entirely equal" AIM HIGHER, (emph. added) p.124.

Belief in Equality, we can see, is an error, and an error is bound to create injustice and misery.

As Saint Thomas Aquinas, The Angelic Doctor, tells us, "The first fruit of error is injustice." and as we will see Equality, as an error, can lead to nothing other than injustice. It's what errors are designed to do. It's what the Liar, Satan, who comes to steal, to kill, and destroy, delights in.

When we, or our government 'leaders', accept such errors as Truth, it affedst the way they govern and set policy on. Affirmative Action is but one example. On the very basic foundation it accepts the gospel of Equality as an inviolable aspect of creation and then when it looks around at the real world, which is full of inequalities it draws the inevitable conclusion that if A holds true, 1) foul play must be involved...or 2) that such injustices must or can be corrected by government intervention. However, in truth, no injustices exist in a world governed by differentiation. Their warring against Phatoms and delusions, waging a witch hunt against an innocent people accused of the most heinous of crimes.

Not confined to Catholics or even Christians of various other sects, but even Muslims,



particularly the learned Shiites, recognize the falsity of the doctrine of Equality. Ayatullah Sayyid Mujtaba Musavi Lari describes inequality this way: He related the common fact that ~~any~~<sup>any</sup> business owner will not pay the same wage to both an unskilled and a skilled worker. Or as Marx, the founder of Communism, states, "From each according to his ability, to each according to his need" \* This would violate the Virtue of Justice, which means simply: giving to each what they deserve. As in the case of the unequal wages, Ayatullah Lari relates, "Doubtless there is a difference involved here, but we cannot call it discrimination...to make distinctions in such cases is an eloquent and practical form of justice, not to do so would be the equivalent to oppression, discrimination and injustice, it would result, or be the result of an inadequate appreciation of the relative value of things in their differentiation" The Attributes of God p. 151. He continues, "Discrimination means making a difference among objects possessing the same receptivities and existing under the same circumstances. Differentiation means making a difference among capacities that are unequal and not subject to the same circumstances... It would be discrimination if two phenomena had the same capacity to receive perfection but it was given only to one of them and denied to the other..." ibid 155. Affirmative Action constitutes such discrimination.

In conclusion, the Principle on which the justification for Affirmative Action rests is shown to be a false principle. It is a lie. It's not racist to say so. It's not bigoted to say so. The error has been exposed by Arab and European, by Christian and Muslim, been refuted by scientists and theologians of every race creed and color. Until we return to and evaluate the beliefs and principles which we unquestionably accept as true, we will continually fall victim to powers that have hidden motives and agendas to advance. The first fruit of error may be injustice...but it is only a 'first fruit'. Historically, as injustices compound and evolve, spawning further injustices, they cause unrest and wars and sectarian violence. That's the fruit of injustice.
