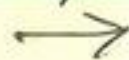

WHEN AN INMATE RECEIVES AN APPLIANCE HIS NAME IS ENGRAVED ON IT, ALONG WITH HIS PRISON ID. NUMBER. IM SAYING THAT IN THIS SAME WAY WE COULD PURCHASE AN I-POD FROM A VENDOR, THAT IS ALREADY MODIFIED FOR US INMATES. FOR EXAMPLE, IT WOULD ONLY DOWNLOAD & STORE MUSIC FILES, OR SINGLE SONGS. IT WOULD HAVE NO RECORDING MIC, OR CAMERA, OR VIDEO SCREEN OR CAPTION, ETC. AND THE ONLY PERSON THAT WOULD EVER GO ON THE INTERNET WOULD BE THE 100 ASSIGNED 2 DOWNLOAD MUSIC 4 US.


I AGREE WITH U THAT A LOT OF FOLKS BELIEVE PRISON SHOULD STILL BE ONLY 4 PUNISHMENT NOT REHABILITATION. I BELIEVE ONLY SOME ASPECTS OF OUR LIVES SHOULD BE "ONE SIZE FITS ALL". OTHER ASPECTS ARE (OR SHOULD BE) ON



A CASE BY CASE BASIS. BUT I THINK IT WOULD BE MORE PRACTICAL 4 AN INMATE 2 HAVE ONE APPLIANCE WHEREBY HE CAN HAVE HIS ENTIRE MUSIC COLLECTION - AND THIS, BECAUSE WE ALREADY CAN HAVE A MUSIC COLLECTION - RATHER THAN CDs TAKING -UP SPACE IN HIS TINY CELL, OR HIS FOOT LOCKER (IF HE LIVES IN A ROOM SETTING).
