But I'm fixing to bath and then lay down and call it a day.

Wednesday, Sept 11, 2013 5:49 AM. Just finished eating breakfast. Got up at 4 AM. Watched the news they have Bill scheduled for October 15, seen that on ABC Channel 20 WCJB-TV. I'm fixing to write to an attorney to try to stop this. then I'm going to write a few people about sending Bill some money, try to make his time over there a little easier. I need to write this attorney

8:06 AM. Wrote 2 letters asking people to help Bill out to make his time over there a little more comfortable. I also wrote this attorney and pleaded for his help in finding an attorney to file this lawsuit, cause that's Bill's only chance.

10:06 AM. Just spoke with Chaplain Dale who will be seeing Bill next Tuesday. Guy's he was over there yesterday seeing Marshall Gore when Bill was brought over. I wrote another letter trying to get some people to help Bill. I'm going to lay down for a bit.

10:34 AM. Just sent the legal letter out. Maybe I can find an attorney to help end this death penalty.

11:13 AM. They just called recreation, so I'll be going outside from 12:30 till 3:30.

It'll be nice to get out of this cage for awhile. Bill didn't go out yesterday, he wanted to stay in and write letters. He thought he would be going out later in the week, just never know what the future holds. He was hoping to get some money in at Christmas and get some new music for his MP3 player. Now unless a miracle happens he won't see October 16,

3:23 PM. Just got back in from rec, it was raining. I had a rain coat and about 7 or 8 of us stood under it. Need to wash some clothes by the time I'm done, dinner should be here. Most of us guys were talking about Bill. We're hearing there's another warrant going to be signed any day now.

5:00 PM. After dinner washed clothes, got showers tonight. After that I may watch Big Brother and then go to sleep. Didn't work out today.

Not only with this situation with Bill, but this 9/11 stuff is just depressing.

8:34 am. just finished writing another org. asking them to help Bill out and for help in filing this suit in court. signing Bill's warrant really motivated me. I'm fixing to listen to some music and walk.

9:52 am just finished to replies to go out tonight with this. I was just walking and thinking, which is what I'm going to go back to listen to music walk and think, cause somethings got to be done to stop these executions.

10:51 am. just sent out the legal letter to Holland & Knight. Canteen showed up a few minutes ago. I still need to workout and write a few other letters.

12:16 PM. wrote my Dad, we just got approved to write at TMC. I'm putting off my workout, I have to go out and see the nurse at some point. I don't want to be all hot and sweaty.

5:08 PM. Wasn't a very productive afternoon. Nurse never called me out. I

didn't work out I've got to hit it hard tomorrow and get my mind back in it. This stuff with Bill just messed the last couple of days up for me. Hope he's doing alright. I was thinking about him a few minutes ago. His cell is empty and willies been quite since Bill left. I'm fixing to lay back watch the news and call it a day. Hope to get some mail in tonight. I haven't received any in the past couple of days.
