In the name of justice, I should have been allowed to confront the five trial level attorneys over twenty-five years ago when the withheld favorable evidence disputing every aspect of the case against me was discovered. Instead the legal system was manipulated to prevent me from vindicating myself, and continues to be manipulated to this day. Which becomes evident due to my not being allowed to confront the five attorneys with evidence they will each have to admit prevented me from receiving a fair and impartial trial...

I have reached the conclusion, the only way I will be able to confront these five attorneys, is to achieve a mass public outcry to bring it about. The integrity of the law will continue to be violated until I can stimulate a mass public outcry to allow me to play on a level field. Where simply allowing me to confront the five trial level attorneys with the favorable evidence withheld from them will bring an end to the miscarriage of justice I have, and continue to suffer for over thirty-one years...
