

Chapter IXXX

Some time last year a prisoner approached me and told me of how he was undergoing dialysis for kidney failure here at the prison. He told me s story of how he was on a transplant waiting list at one of the major hospitals in Boston and that he had recently been removed from that list due to the failure of the DOC contracted medical provider to submit his yearly information as required by policy. He was devastated by this news, reduced to tears as he told me, and went on to say that his family was getting a lawyer for him. For me the story was just another aspect of the very real sadistic abuse that the men here at ShirleyWorld are subjected to by the medical provider and the prison officials. The man that reported this story left the prison, and I know not how his sga turned out, but recently a very interesting document fell into my hands and I wanted to share it with the readers of this blog.

The document (which I will attach to this chapter) is a letter from the "Transplant Center" at the Boston Medical Center in which they are notifying a ShirleyWorld prisoner that they have to determin that he should be "deferred" from the transplant listing due to the fact that they cannot ensure that the DOC will transport him to the hospital within the three (3) hour time frame required once a kidney is found. They go on to say, "... despite multiple requests to the administration at MCI Shirley...", that they could not get the agreement to transport this sick prisoner, who's life is in the balance, within the three (3) hour time frame. Now we all know that the "adminsitration" in charge of the HSU is Deputy Denied-Oh and now she has taken her pattern of denials to the level of conspiracy to murder! This man, who will DIE without a kidney transplant, is being denied this life saving treatment due to a lack of a "transportation" agreement??? Are they shittin me? I hope readers are realizing why we expose these fools here at this shithole. Men's lives are truly in the balance. How about this man's family? They were so relieved that he made a transport list, they knew he was getting barbaric and substandard care at ShirleyWorld, but now that hope has been ripped away from them all because Deputy Denied-Oh cares little if men live or die. What crime did this man's family commit? This Hanibal Lector of a deputy probably wants to eat the transplant kidney with a little cianti as she is as much of a killer as Dr. Lector.

I am going to delete this prisoners name from the document as I don't want the deputy to put some type of lethal injection chemical in his dialysis treatment for speaking out: it is not out of the realm of very real possibilities. You can trust that we have started doing our homework on the dialysis treatment offered here. They have used some of the same drugs that are on the TV commercials refered to as "bad drugs" and seeking clients for lawyers. They just fired the only dialysis nurse who was kind to these poor men: you see the prison views them as a "burden" not as patients. They make their lives miserable all because they have gotten sick. It has been brought to my attention by one of our "moles" on Deputy Denied-Oh's elite crew up there that the nursing supervisor also quit. I don't know why but when I do I will report it here. They won't let us go back there due to possible "germs" but they do nothing about the mice infestation that plagues (it could literally "plague" them) the HSU. The guards name the mice: they have Mickey, Minnie and Mighty, but I can't

go up there to see my dying friend due to "germs". Get real Deputy Denied-Oh. You don't want us up there because we will report the abuse you daily visit upon these men. You are now PROVEN to be an "executioner" (see attached document) and we all thought they outlawed the death penalty in Massachusetts???

Lt. Whirlwind is still "walking the toughest beat in the state" (i.e. clothesline patrol, water bottle task force, ID wearing squad, etc.) up at the minimum security facility or ShirleyWorld "light". We recently learned that part of the reason she was banished from the confines of ShirleyWorld was that she had an inappropriate relationship with a married civilian worker here. Now I am not going to reveal his name or position as he is not a cop (for the most part) and has a family that could be hurt, but I will say that Lt. Urine (formally Whirlwind) has absolutely no morals and adultery is far from a shocker where she is concerned. We all see daily (well not for the past few weeks) her hatred. I'm not an educated man but 50 years on the planet have taught me a few things. Anyone who is that angry is not angry at external things: they are angry at self. They hate themselves but cannot allow themselves to cognate that, it is too painful to grasp, so they employ the defense mechanism of displacement. Their anger is displaced on those they force themselves to view as less than. This can lead to suicide and murder. The internal stockpile of hatred, anger and despair has to burst out someday. My hopes are that Lt. Urine does not harm anyone here. We will pray that she seeks help and we will pray that she does prey on any other men who are weak in matters of the flesh. Have you ever known a pretty girl that turned you off because she was a fully reprehensible human being? Lt. Urine is not pretty but I cannot see how her bile mind did not scare off this man who must have been thinking with the wrong head. Please keep the men up at ShirleyWorld Light in your prayers as there can be no doubt that Lt. Urine will do all she can to make their lives miserable until she can return to us here and have her revenge. This is today's corrections.

The DOC plans to start using the "drug sniffing dogs" on visitors this week. Are they going to have the dogs sniffing the guards as well? The propaganda bulleting they put out says that drugs come in by "visitors and mail". Well I guess they missed the cops who brought in an ounce of heroin at MCI Norfolk (he is doing 10 years for it) of the cop who brought in suboxone, creatine, anabolic steroids, and take out food at a price for a couple years. How about the one here they fired last year for bringing in T-shirts for guys in exchange for suboxone. He actually snorted in cells with prisoners and then ran around the block high as a kite! No dogs sniffed him. How about the medical staff who steal pain pills out of prisoner subscriptions and give them to their boyfriend guards? Will they be sniffed? Again the DOC is treating a "symptom" rather than treating the problem. Men seek to get high as there are no meaningful activities for them here at the prison: no college courses, no job training, no family reunification events, NO HOPE! Men choose to numb themselves so

that they can hide from the doom of a life sentence on the installment plan. MOST men, when they first come in, want to get an education, learn a trade, and mend bridges that they have burned: and they think that prison offers those opportunities. When they get to ShirleyWorld and find out that the DOC globally and the facility locally cares not about change or rehabilitation these men take another tact: and as we learned long ago it is almost always a bad path. This is why we have a steady 47% recidivism rate. The drugs are NOT the problem. The prison climate IS the problem. Until you change the climate, until you reel in the Denied-Ohs and Urines, you will ALWAYS have serious drug use issues. Drug sniffing dogs means MORE JOBS: That is the bottom line: MORE SECURITY EQUALS \$\$\$\$. Dont be fooled. Don't believe the hype. The DOC is stealing your hard earned tax dollars and there are no better thieves than these con artists here at ShirleyWorld.

The next chapter of this series will be Chapter XXX. That will be the final Chapter in this short "book" of abuse. Now don't you think for one minute that I am going to stop my regular reporting of the "madness" as I am NOT. What I am going to do is start a new format with a new title. I am going to balance the reports of abuse with stories of the GOOD things men here are doing without the help (and in many cases in spite of) of the DOC. By the time I post Chapter XXX I will have the name and format fully mapped out but I want to start to give a bit of a more balanced picture as best I can: it will be difficult as the scales are certainly tipped against us (Deputy Denied-Oh has placed a fat butcher's thumb on our quest for self-realisation) but we still managed to wade through the mire on many occasions and they need to be reported. The guards here at ShirleyWorld operated in a secret world for far too many years. I have only dented that veil of secrecy with this blog but it has had an effect. The guards know that I will fearlessly report their foolishness, and they also know that their bosses read this blog. The Superintendent "The Boot" told me to my face she reads and even quoted from it, so these guards know that their abuse will get out there. The time has come for them to just do their jobs and quit complaining. I cannot imagine these guys out on the boat me back in the day: bunch of cry babies. I would have loved to take the "Little Chicken" out to Stellwagon on a brisk December day back when the lobster traps (4 brick wrap-arounds) weighed 85 pounds each. 25 MPH winds and a 4 foot chop would have made him wish he could just be a "bread policeman" seizing rolls at the bottom of the ChowHall stairs! Guys like him oftentimes went on "one way" fishing trips where you told the captain, "One minute he was standing there on the deck next to me - the next minute he was gone. I don't know what happened to him?" (-;

This letter is to inform you that the Transplant Multi-Disciplinary Committee here at Boston Medical Center reviewed your recent kidney transplant evaluation on August 27, 2013 and determined that you should be deferred for Transplant listing at this time. The concerns considered at this time is the need for our team to have a firm contract in place that allows for us to call you in for a transplant and for you to be brought to Boston Medical Center and be here within 3 hour's time if a kidney becomes available for you. We do not have a guaranteed way to ensure that this happens despite multiple requests to the administrators at MCI Shirley for the information we need to feel comfortable to list you and transfer your wait time from Tufts.

We will be happy to re-present you to the Transplant Committee for listing consideration once we have this contract in place. To that end, your administrators should contact our Transplant Administrator, Ms. Aldophe, at 617-414-8064 to discuss the conditions that must be met for us to consider listing you. You will receive the results of that meeting in a letter from me.

It is important that you notify the Transplant Office if there is a change in your health or your address or telephone number. **Our office telephone number is 617-638-8430.** If it is after business hours, there is an answering service that can take a message.

Please be aware that it may be necessary for you to undergo further testing in the future to ensure that you will be an appropriate candidate to receive a kidney transplant. You will be notified if this situation occurs. Please schedule an update visit with the Transplant Team every six months.

Attached please find a Patient Information Letter from the United Network for Organ Sharing (UNOS). This letter provides you with educational information along with a toll free phone number you can call for Patient Services.
