We must work to keep hope alive in here as the Denied-Ohs and Urines of the system are doing all they can to stomp out any glimmer of life it may present. At least now, with the miracle of cyberspace, their many failings can be exposed to the light.

No sign of Lt. Urine here at ShirleyWorld and by some modern miracle the place has still been able to operate! My information is that she is still roaming the hill at ShirleyWorld Light but I have not been able to get any information on her antics up there as of yet. I am working thru sources to get a regular and reliable contact up there so that I can report any abuse she visits upon the men up there but I am certain that she has caused a lot of misery among the men up there who are trying to prepare for their return to society. Her insane action up there may well ensure that someone who was looking to give themselves a chance is stripped of that chance so close to the gate. I just know she does not go from the consummate unprofessional and hatred fueled rogue down here to some layed back turnkey up there. The one true story I do have to report about Lt. Whirlwind/Urine is that she was assigned to a transportation trip for a man here at ShirleyWorld. She was caught outside of booking glaring intently into her former realm. How satisfying for us to know that she was "on the outside looking in" like we are on the inside looking out! Let's hope that she never returns to ShirleyWorld but we don't have luck like that.

A dear friend dictated some facts to me about the rodent infestation up there and I will attach that story to this chapters posting.

Turkey Day was a real banquet for the screws. They got double portions of turkey, stuffing, mashed potatoes, cranberry sauce, etc., which was all made out of food paid for from the prisoner food budget. You should have seen Honey Boo-Boo, giagantic hips struggling containment by her man pants, carrying her tray of glory back to her block for a personal feast. We got a real dry portion of white meat with the saem fixings but no way were we getting any double portions. I was thankful for the good friends I shared my meal with and got a lot of laughs at how angry the Sgt. Messy-Hers and Lt. Washme's were that they had to work. Even getting OT they are bitter. The search for life's meaning ends at the gate for them: so sad.

A guard who works in the unit next door to mine stopped me on the walkway the other day. He said he was reading my blog and got a huge laugh out of it. He said he thought I was wrong about something and asked if he could give me some "advice". I gave him a wise remark, not worth reliving, but let him speak his piece. He said he thought that any "stalker" disignation I had leveled against Sgt. Messy-Her was misplaced. He said the Stalker award must go to Captain Shebert as he had to put up with the captain stalking two seperate female screws he worked with on two seperate blocks. He said that the captain spent as much time as possible chasing young female screws in here. I told this guard that it was not me that gave Sgt. Messy-Her the stalker disignation but that it was a former partner of his. He laughed. I also told him that I would ask my "team of eyes" to watch Captain Shebert to see if they could confirm this alleged behavior. The guard looked a little scared then: it seemed like he did not like the fact I have men watching behavior(s). After some days of covert surveilence it is confirmed: Captain Shebert stalks the young female guards like a desert lion drooling over a young spring buck! CO Wasborne dies her hair darker for him. CO Sucko tries to hide her zits to no avail. The real targets are the couple of new "fresh meat" female guards they have hired. It does not appear he is "gettin any play" but he is "puttin in the hours". too bad this is workplace sexual harassment as he is in a position of power over these young and dumb butchs. Why a woman would want to be a screw escapes me

but it seems ironic that they have to tolerate the seemingly teenage exuberance of a ranking O2 waster. I don't feel bad for them in any way but I do suggest they bring charges against this new owner of the "ShirleyWorld Stalker" title.

Deputy Denied-Oh's reputation as the "Queen of Denial" (I must sweep from my mind any vision of her floating on a barge) has forced her to start to approve some programs here. She approved the "Insanity Work-Out" program (I am not kidding - actually true). Now this program will allow the prisoners who are NEVER getting out of prison to leave a good looking corpse! So sad. Men are overly focused on physical appearance (it is a real good escape from the need to change your mind) that they forget that they are entitled to FREEDOM! Deputy Denied-Oh has also approved a "Long-Termers Group". Now they men who put this together asked for it to be called a "Lifers' Group" just like at Norfolk, Bay State and Gardner, but Deputy Denied knew the histories of those groups (they fight against abuse and seek betterment of confinement conditions) and she would have none of that. This "Long Termers" group is destined for failure as it is a "Denied-Oh" approved program and will be limited. Also, she has allowed men who DO NOT represent the prisoner population to portray that they do: this is another DOC "divide and conquer" tactic and these Stockholmed Syndromed "inmates" on Denied-Oh's team cannot see this. The good news here is that the "shouts from the rooftops" we made about the "Queen of Denial" have forced her to change her ways. She has to approve something and maybe someone might just slip one past the goalie someday, as far as a worthwhile program is concerned, but thus far she has blocked all shots.
