HAPPENED, THE LYING WHITE RACIST DOG PROSECUTOR DEBORAH A
LUCKY SIMPLY LIED AND MADE UP THESE CRIMES.

HUMANITARIAN APPEAL: NEED ASSISTANCE TO INVESTIGATE, TO
EXPOSE THE CORRUPT RIVERSIDE COUNTY, CALIFORNIA, DISTRICT ATTORNEY
OFFICE FOR DOMESTIC WAR CRIMES, MALICIOUS/VINDICTIVE "RACE-HA
PROSECUTION WITHOUT JURISDICTIONAL "STANDING" OF A LEGITIMATE, I
FIDE VICTIM. RACISM, GENOCIDE, UTILIZING A SIMPLEMINDED ILL-EG
MESS-IKAN ALIEN SANDRA [REDACTED] UNDER THREATS OF DEPORTATION
HAVING TO LEAVE HER MANY ANCHOR CHILDREN - TO COME TO COURT TO
LIE AND COMMIT PERJURY AGAINST ME - TO WRONGFUL CONVICT.

THE FACTS: 1) ON 7-15-01 SANDRA [REDACTED] VOLUNTARILY
REPORTED TO 911 SHERIFF'S DISPATCHER BARBARA [REDACTED] HOMICIDAL THREAT
MADE AGAINST A BLACK JANE DOE BY A BLACK JOHN DOE, RODRIGUEZ
ANSWERED THAT SHE HAD NO VISUAL AND THAT SHE SAW NO WEAPON
AS IS CONFIRMED BY THE DATED 911 TAPE AND TRANSCRIPT.

A) ON THE SAME DATE/TIME OF RODRIGUEZ'S EVENTS, ARRESTIVE DE
GARY [REDACTED] POLICE REPORT OF WHICH INDICATES HE INTERVIEWED [REDACTED]
AT THE ALLEGED SCENE AND SHE RESPONDED THAT SHE HAD NOT BEEN A
OR THREATENED WITH A FIREARM. (SEE POLICE REPORT)

2) ON 8-22-01 DDA LUCKY IN RICO CONSPIRACY, FIVE WEEKS AFTER THE F
SENT HER MESS-IKAN INVESTIGATOR RAMIREZ (A / A. RAMIREZ GARCIA) TO INTERVIEW
RODRIGUEZ ALONE IN THE PRIVACY OF HER HOME AND AS A RESULTS OF THAT I
TETE-A-TETE, RODRIGUEZ REPORTED "THE SUSPECT WAS HOLDING A HANDGUN

IN HIS RIGHT HAND AND HAD IT PRESSED AGAINST THE WOMAN'S HEAD" (SEE INVESTIGATOR'S REPORT)

3) ON 6-26-03 [REDACTED] TESTIFIED AT TRIAL INTER ALIAS "I AM SURE -- IT WAS A GUN." (RT-139:12) "... BUT THE MOST IMPORTANT THING IS THAT HE HAD THE GUN TO HER HEAD AND HE WAS TELLING HER HE WAS GOING TO KILL HER." (RT-145:11-13) "BUT THE THING THAT I HAVE ALWAYS SAID IS THAT I SAW THE GUN TO HER HEAD," (RT-151:11

A) ALBERT, IN SELF-IMPACTMENT [REDACTED] TESTIFIED THAT HER HUSBAND CONTRADICTED HER SAYING: "HE WOULD TELL ME TO GO TO SLEEP THAT THAT THEY (COUPLE) WERE JUST ARGUING." (RT-176:4-5)

4) IN UNDISPUTABLE REBUTTAL 911 SHERIFF'S DISPATCHER BARBARA [REDACTED] TESTIFIED INTER ALIAS THAT [REDACTED] WAS A PECCURIAS LINE bec she had WITFULLY told her that she had "NO VISUAL" (RT-302:20) AND "SAW NO WEAPONS" (RT-306:7-8) SEE 911 TAPE/TRANSCRIPT.

A IN COLLABORATION DEPUTY BOWEN TESTIFIED THAT HE HADN'T RECEIVED ANY INFORMATION THAT A GUN WAS VISIBLE/PRESENT (RT-224:27-28, 225:1).

5) ON 6-26-03 AT TRIAL DEPUTY [REDACTED] TESTIFIED INTER ALIA THAT THE "UNAVAILABLE NAMED-VICTIM JOYCE R, had told him ON THE DATE/TIME: Those events that she had NOT been THREATENED WITH A FIREARM OR AS by me (RT-211:19-28, 225:28, 226:1).

6) IT SHOULD BE DULY NOTED THAT JOYCE R, TESTIFIED TWO-YEARS P TO TRIAL UNDER OATH ON 8-30-01 REPUTATING THE WICKED WHITES LIES OF DDA DEBORAH [REDACTED] OF HER VICTIMIZATION, DENYING THAT SHE HAD BEEN ABUSED, THREATENED, NOR WAS SHE AFRAID OF ME (RT-34:1-35:5-9, 43:6-7) AND THE POLICE GAVE HER A RIDE HOME, THE RIV-RICO CONSPIRATORS ARE:
