THE SCHOOL HALLWAY IN THE SMALL TOWN OF TWINSBURG, OHIO.

WITH DEFINITE BEHAVIOR, ACCOSTING/KISSING A WHITE GIRL IN THE HALLWAY
TRAUMATIZING HER, FELT PERSECUTED SINCE SHE DIDN'T RECEIVE DISCIPLINE

HAS BY HIS ASSOCIATION WITH A WHITE GIRL VIOLATED BEHAVIOR CODE. "GENERAL
FEARS, ANXIETIES, PREJUDICES" "COULD IT BE THAT SINCE OTIS HAS IN A NUMBER
WAYS IGNORED THE CONCEPTION OF WHAT IS PROPER NEGRO BEHAVIOR AT CHAM-
LIN THAT THE FEELING PREVAILS THAT HE SHOULD BE PUT IN HIS PLACE OR THAT HE MUST
BE SICK" ALBEIT TO DR MILTON SHAME HE DID RECOMMEND (8) UNCLE TOM
NSW RULES AND ACTIONS THAT I NEED LEARN.
