Here in T.D.C. (Texas Department of Corrections) in high security, the un-necessary noise caused by prison guards is a form of Torture, at all hours of night or day. Some will walk by the prisoners cell and look in to see if he is still there, then hang a steel bar on the cell door to make the prisoner "move" to make ~~s~~ sure he/she is still alive, (Every two hours) you might think a person would get used to it after years of this type of abuse... no so. Each cell has four "4" four foot long bright fluorescent lights, that can be turned on anytime a guard feels like doing so, even though there is a bright night light within the fixture, when the big bright lights are turned off, the small bright night light comes on automatically, then if that is not enough light to piss of the prisoner, now the guards have these Laser-like flashlights which they use as crowbars to individually pry every prisoner's eyes open, many times per night, or day. Sometimes I wonder: Does this prison guard know what goes through my mind when he is playing with is Laser-weopen? How long would it take him to bleed to death? 2 minutes 45 seconds? after most prison guards fail to get a rise out of me, they move on down the line and keep trying until they find some one who has no patience - they get a bang out of the prisoner, man ... that dude is crazy, did you see how deep he cut himself - or man, look at all those scars on his arms, the slightest abuse can set him off... then the guards stand around and point

and laugh at him.. not knowing what made him that way. Prisoner's do something's to other prisoners - it blows my mind. The constant emotional abuse leads to permanently disturbed (ex cons) who then reenter society with needs for therapy or facilities to adequately "re adjust". Either way continue to cost the Tax payer's money, the Correction department is failing at its goals of correction.

The prison system is a sanctuary (High Security units) to preserve and proliferate the Criminal Mentality Syndrome. This is the very psychological disposition that guarantees the Tx state government to financially benefit from our period. Here in so called "high security" we have no educational facilities, no serious programs for Criminal rehabilitation. TDC fully understands that the absence of such programs would only increase the recidivism among its prison population's.
