On: September 24, 2013. Dr. Fitter claimed to have observed this writer on the (B) facility during the week of (09/24/2013) walking with waker for prolonged periods, as if he did not need it. and doing dips against his body, as basis to remove his walker for a cane (quad cane);

On: December 09, 2013. Dr. Marcello actually physically took the walker with a number of custodial personnel

standing by, and gave the writer a simple moint cane;

Though the writer was falling from the onae and moved exceedingly slow on the cane. Nothing was done. He was left to meander about exacerbating his right shoulder (A/C specation) trying to remove the weight from his right leng. Whereupon when he places weight, it causes shooting pain in his back;

On: jaruary 28, 2014. Dr. Marcello, had the writer summond yet again to the (D) clinic where he ordered the came removed and nemoved the writer from the disability placement program, based on a claim that, 'they' have videotape of the writer performing physical exercise. That, caused Marcello to believe that, the writer is able now to walk 100 yards without pausing in spite of his decemerative disk disease (D.D.D.) in his lumbar spine, with disk bulges seen by MRI to contact his nerv-root's, and, peripheral and occomany heart disease, that cause him claudication in his large's after relatively short distances.

This writer told the Dr. Marcello, if you do not have a videotage showing Me walking 100 yard's wothout pause.

You have no besis for removing My welking aids. To no avail.

CTCR is the greatest proponent for NO VIDEO CAMERAS in the pirson setting. However, they use them against the prisoner when it is to their bennefit, and that, in direct violation of the prisoners right's. The Title 15, CCR. § 3261.7(h) bers the prison from videotaping inmates without their excress consent, and holds that, any such videotape is to be discarded. But, the law is only applicable to the prisoner. CTCR does not follow its own rules.

I am not saying this because, I was caught doing anything wrong on Videotape. I was not. Disabled prisoner's have the right to physical exercise just as does the non-disabled, and, most California Prisons have areas designated for the disabled to exercise. However, CSP-LAncaster, does not. The prison officials here believe that, the disabled inmate should satisfy himself with just being disable. I'm not such a praigner. I do exercise. I have been advised by physical therapist to do so. To the extent that, I am able. Any exercise that, I have been viewed performing was not out side of My disablility orde.

I ask to see this videotane. But they will not allow Me to see it. Nor any of My family member's that have inquired. Yet, they have taken this action against Me based thereon? The CDCR knows that, I am indigent and, therefore cannot obtain counsel torepresent Me against them. They also know that, the courts will merely

defer to the prison officials, in my case. So, they are free to hully Me.

Since the nemoval of My walker, I have remained unable to access the services, programs and activities of the prison. Including the dimnimohall for My three meets a day, shower's, law library, official appointments within the prison, My antideoressant medication's, Fct. I have remained being starved, as a tactic to force Me to do what I cannot do, walk the distances required, without assistive device, to access the prison programs.

If there is counsel out there, please consider representing one who needs help, and, cannot aford it. Yet, needs a defender. I have no concern for the money. I just want My needed assistive devices back. So that, I may eat and bathe. I am loosing weight rapidly.

Even when prisoner's bring claims wherein the CLCR and its gurads are clearly shown to be in violation of the laws. The courts seem only to be interested in imposing the law on the poor Palck, mexican, white and other inmates. As to the other government officials, they have some form of un-written immunity. The courts seem to be in the business letting their fellow government officials off the book (proverbially speaking)., In my case.

While at Salinais Valley State Prison in the mid (90's) took My wheelchair and walker. I brought his conduct before the federal district judge WHYTE, of the fresno district court. Whyte simply defeed to Dr. Clark, that had done this. While later, I was reading the news paper and learned that, Dr. Clark had culled the same stant with another prisoner whose family retained coursel. Dr. Clark was fired and his license was revoked. There is much injustice within the prison setting. Put, its O.K. because, its only being done to prisoners. COCR and the curts know that, they are employing sadist and maschist as Drs. and quants.
