3:41PM. Been working on a piece of art. They took 4-wing to rec. Juan has 2:20 minutes to live. That's a hard case I hate even thinking about it. Guess I'll go back to this drawing.

4:26PM. just finished eating. I don't like this food. Too much processing. Juan will be dead in about 2 hours. Paul has 2 weeks to live. And the Governor will probably sign another death warrant if not by Friday then some time next week.

7:01PM. just got back from the shower.  
Going to bed.

Friday February 14, 2014, 5:55am. Got up at 4:26 washed up, cleaned up, ate oatmeal. Been thinking about Henry, haven't seen anything on the news. maybe at lunch 1200 noon news. I was looking out the window a few minutes ago at the full moon. I guess I'll start a letter and decide what to do from there.

8:17am. Wrote a letter, ate a PBJ sandwich. seen where Henry is set for march 20.

12:53 PM. The officer's are doing re count cause some officer, some where messed the court up. I've been working on a piece of art for a friend. Had sardines for lunch.

2:19 PM. Just got back from X-rays. I'm glad that's over. Hopefully I'll see the doctor next week and find out what's going on.

4:15 PM. Just ate a chicken dinner off the canteen. There good, just very expensive \$6.75 for a meal. Now I'm going to mess with this piece of art and wait on showers.

8:50 PM. Just got back from the shower. Going to bed now.

7:01 pm. Getting ready to go to bed.


Sunday February 16, 2014. 6:01 am. Got up at 5:00 am cleaned up, now getting ready to workout then bath and wait for mom.
