

Alida Lachelle Smith: A
SEVERE CASE OF CONFUSION AND
THE TROUBLING MISCONCEPTIONS
OF GOOD PARENTING.

IN LIGHT OF SMITH'S RECENT POST, THOSE FAMILIAR WITH SMITH'S HISTORY AND THE FACTUAL CIRCUMSTANCES SURROUNDING THE CUSTODY BATTLE AT ISSUE HAVE AGREED THAT SMITH'S COMMENT DESERVES MORE THAN THE CUSTOMARY REPLIES I HAVE MADE TO OTHER INDIVIDUALS' COMMENTS.

WITHIN 72 HOURS OF SMITH'S REVELATION, I WAS IN JAIL AND STOOD FALSELY ACCUSED OF THE AGGRAVATED ASSAULT CHARGE I AM PRESENTLY SERVING A PRISON SENTENCE FOR.

5.) BECAUSE OF MY POLITICAL AND PERSONAL CONVICTIONS, AS WELL AS MY RELIGIOUS UPBRINGING I HAVE "NEVER" CONSIDERED ABORTION TO BE AN ALTERNATIVE, AND THIS IS THE REASON I AM THE PROUD FATHER OF EIGHT AMARING CHILDREN WHOM I LOVE DEARLY. SMITH MUST HAVE ME MIXED UP WITH ONE OF THE FATHERS OF HER FIVE OTHER KIDS.

6.) NOT ONLY DOES MY BLOG'S PROFILE SHARE RELEVANT INFORMATION REGARDING THE CHARGE THAT I'M IN PRISON FOR, I HAVE WRITTEN ARTICLES ABOUT MY CRIMINAL CASE/CONVICTION, AND I'VE "REPEATEDLY" LISTED URL'S WHERE ADDITIONAL INFORMATION CAN BE FOUND. I HAVE EVEN ASKED THE READERS TO "SHARE THIS INFORMATION" WITH OTHERS. WHAT EXACTLY THEN DOES ALIDA L. SMITH MEAN BY HER COMMENT "WHY DONT YOU SHARE WITH THE PUBLIC WHY YOU ARE IN JAIL." ???

7.) SMITH "NEVER" FOLLOWED THROUGH WITH COURT PROCEEDINGS FOR PROTECTIVE ORDERS AGAINST ERIC D. GLENN.

IN CLOSING I HAVE ONLY THIS TO SAY. IF ANY FATHER EVER HAS SUFFICIENT REASON TO BELIEVE A CHILD OF HIS IS BEING

Following my release on bail in 2007 on the aggravated assault charge, I assumed full and complete custody, care, and responsibility for our daughter. This even included my being the person responsible for having potty-trained our daughter. Our daughter resided with me and my three other minor children until my wrongful conviction on April 22, 2008. (SEE: Reporter's Record Vol. 2 of 6; Vol. 3 of 6; and Vol. 5 of 6) Alida Smith's comments on or about January 22, 2014, demonstrates her obvious and severe confusion regarding critical facts. FOR EXAMPLE:

1.) In the February 15, 2012, sworn Affidavit of Child Protective Services Investigator, BRIAN BARNES, he confirms that CPS received a referral that stated there "IS" ongoing domestic violence between Eric, DONSHA GLENN, a registered sex offender and Alida Smith. (SEE: BRIAN BARNES sworn Affidavit below).

2.) According to Investigator BARNES' Affidavit, Smith stated that court case (# SF-09-7655) was initiated approximately 3 years ago by me for the purpose of changing our daughter's name and to have Smith relieved of custody. Truth is, as reflected by the District Court's

RECORDS, ON April 22, 2009, The Texas Attorney General initiated a petition to establish that I am the biological father of our daughter. And on August 16, 2012, The Texas Department of Family & Protective Services initiated a petition to terminate me and Smith's parental rights. The latter petition was initiated based on Smith's unwillingness to extricate herself and her children from the violent home environment caused by Smith's ongoing relationship with registered child molester Eric Donsha Glenn.

3.) Judge Lori C. Hockett stated on record during hearings conducted on September 26, 2012 and April 09, 2013, that "SHE" is the person who made the complaint to CPS that resulted in the August 16, 2012 termination petition filed.

4.) According to Psychologist Myraa Dartson's report to the court, Smith admitted that there has "NEVER" BEEN ANY domestic violence during our brief relationship. The domestic violence Smith has suffered and exposed all her children to has been perpetuated at the hands, feet of Eric Donsha Glenn.

A Notary Public in and for said County, State of Texas, on this day personally appeared Brian Barnes, who, after being by me duly sworn, on oath deposes and says that I am competent and qualified to make this affidavit and I have personal knowledge of the facts stated herein and they are true and correct:

I.

I am a caseworker for the Dallas County Child Protective Services Unit of the Texas Department of Protective and Regulatory Services and I am authorized to make the following statement: Based on my investigation of the following named subject child, I have determined that all contestants concerning the conservatorship of the said subject children reside within the state of Texas and respondent father Tyrone Franklin resides in the State of Kansas.

SEX: Female

I further declare that:

On June 21st, 2012, Child Protective Services received a priority two allegation of Neglectful Supervision of children Xavier Franklin, Bianca Miller, Imani Sharif, Eric Glenn Jr., King Glenn and Erin Glenn by their mother Alida Smith and her husband Eric Glenn Sr. The referral states that although Mr. Glenn does not reside in the home, there is ongoing domestic violence between he and Ms. Smith and that Mr. Glenn is also a registered sex offender. Investigator's initial visit resulted in a brief conversation at the front door with 16yr old Xavier Franklin, who advised that all was well. Investigator received no return call from Alida Smith as requested and subsequent visits yielded no response.

On July 27th, 2012 investigator received a call from Attorney Sandra Jackson, who states she has been appointed GAL in a custody case (Cause No 09-07655-S-255th) involving Imani Sharif. Ms. Jackson advised that Imani's custody case has been ongoing for several years and the judge on the case is now seeking immediate movement on the case.

On July 28th, 2012 investigator received a call from maternal Aunt Sonia Butler, who advised that Alida Smith was jailed July 7th, 2012 for Assault with a Deadly Weapon (vehicle). Ms. Butler states she has taken children Xavier Franklin, Bianca Miller and Imani Sharif into her home. She advises that Ms. Smith's three other children, Eric Glenn Jr., King Glenn and Erin Glenn reside with their father Eric Glenn Sr.

On July 31st, 2012 investigator Barnes completed a jailhouse interview with Alida Smith. Ms. Smith states she has been charged with aggravated assault with a deadly weapon and is uncertain when or if she will be released. Ms. Smith stated she was aware that her children were staying with her sister Sonia Butler. Ms. Smith stated she felt the children were in good hands with Ms. Butler. Ms. Smith signed a Child Caregiver Resource Form naming Sonia Butler and/or her mom Regena Patterson as her preferred choices for placement of the children.

Ms. Smith states she has had an off and on relationship with Eric Glen Sr. since 2008 and they have been married since 2010, but have not lived together since 2008. Ms. Smith states she and Mr. Glenn have three mutual children, Eric Glenn Jr., King Glenn and Erin Glenn, who reside with Mr. Glenn. Ms. Smith states there has been an ongoing court case involving her daughter Imani Sharif. She states Imani's father Lakeith Sharif, has been incarcerated for approximately three years but has initiated a court case seeking to change Imani's name and have her relieved of custody.

On August 2nd, 2012, Investigator Barnes interviewed Eric Glenn Sr. at his residence. Mr. Glenn acknowledged that he and Alida Smith have been married since 2010 but states they have not lived together. He states their three mutual children; Eric Glenn Jr., King Glenn and Erin Glenn have always resided with him and would visit with Ms. Smith on weekends. Mr. Glenn states in light of Ms. Smith's current charges and uncertain future, he will be seeking a divorce and primary custody of the children.

On August 10th, 2012, Child Protective Services and Investigator Barnes received an order from Judge Hockett of the 255th District Court to file a base petition in the interest of Imani Sharif and siblings Xavier Franklin and Bianca Miller as soon as possible.

On August 10th, 2012, investigator Barnes visited the home of Sonia Butler and interviewed her and children Xavier, Bianca and Imani. Ms. Butler had visited her sister Alida Smith at the jail earlier that day and Ms. Smith signed a Power of Attorney giving Ms. Butler the ability to care for the children Xavier Franklin, Bianca Miller and Imani Sharif. Ms. Butler was advised that Child Protective Services would be filing a base petition regarding the children and that my interview would be used to complete a Home Study which would be submitted to my superiors and the court for approval. Children Xavier, Bianca and Imani were interviewed at Ms. Butler's home and all indicated they were aware that their mother Alida Smith was in jail. The children expressed love for their Aunt Sonia and said they were comfortable being with her and living in her home.

Based on the mother's incarceration, the children have no parent to reside with so they are now residing with their Aunt Sonia.

The Texas Department of Protective and Regulatory Services is requesting Temporary Managing Conservatorship of children Xavier Tenez Franklin, Bianca Lachelle Miller and Imani Lynette Sharif. The department is also requesting that Maternal Aunt Sonia Butler retain actual physical custody of Xavier, Bianca and Imani. A Home Study has been completed and approved for Sonia Butler.

III.

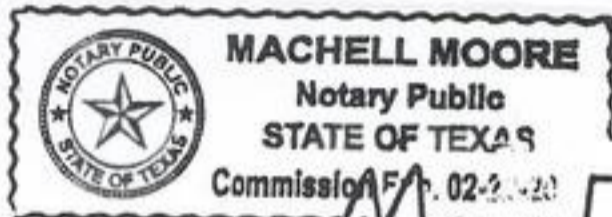
