Here we go again. It's Tuesday March 4, 2014 and I got served two Disciplinary Report's one for the Fight/Assault which was a result in the negligence of classification and the security. The 2nd D.R. was written by Classification, for a mail violation, for a pen pal ad that was clearly placed up when I was 31 years old, back in 1999. www. AngelFire.com. So my classification OFFicer on February 28, 2014 at approx 9am viewing mine and this other inmates record, who assaulted me noticed that there should have been a special Review to keep us seperated. But Classification took the special Review, as a joke. Although security staff had kept us seperated for many years, so Classification realized, when they looked at my records, and this other inmates record, they knew they had made a major mistake!!! so an hour after Classification looks over DR #213-140286 and #213-140285. my classification OFFicer writes DR. #213-140287 mail violation. Which their going to try to rail road me on, and find me guilty of, so they can put me on mail restriction; where I can not receive or send out mail to my blog. I need help at bringing attention to this. so every one who writes me, if you get letters returned or do not receive a letter from me, for several month's, then you know why. I do have some faith in this warden Diane Andrews, to correct this, she's about doing

Send her an e-mail stating that P-Dorm Recreation yard #4 video of Friday February 28, 2014 at approx 8am will show an inmate coming into the rec yard, where he heads straight for inmate Clark, who defends himself, attempting not to fight back. And when the inmate tried to place me in a choke hold, I bit him to prevent being put into a choke hold. But this incident should not have taken place to begin with. For this inmate and Ronald W. Clark jr should have been on special Review, you will find this in the inmate's records 2006-2007, so classification and security staff clearly made a mistake that resulted in this fight/assault.

Classification on this day noticing their mistake, wrote what seems to be a retaliator Disciplinary Report DR Log # 213-140287 mail violation that is written by classification one hour after the fight/assault. If this is not retaliation, it most certainly looks like it. Coincidence?
