I did get one letter in last night that I need to respond to. 9:50am. Wrote on these D.R. hearing papers to have them posted on my blog. Wrote a letter and then wrote out a poem for this art project that I'm involved with. Cleaned the floor and now going to walk as I decide what to do next.

10:48am. Robert Henry has 8 days left. I sure hope he gets a stay. Still haven't heard of any other warrants being signed. I'm just sitting here waiting on lunch. After that I'll do some writing. try to pass some time and do something productive.

12:05pm. Finished eating. I ate the veges and potatoes. I could not eat this Turkey meat. If it doesn't even resemble Turkey, if you gave it to someone asked them to eat and look at it ect, and tell you what it was, there's no way anyone could identify it. It's mystery meat.

2:44pm. Just been reading. Wrote a request to Classification. trying to get them to apply 33-602.222(8)(a) and let me OFF D.C. It won't work, but I figured I'd try it any way's.

4:37pm. Just finished eating. Going to walk for awhile. Then do some reading. Wait for shows and hope to get a letter from mom tonight.

6:36 PM. just got back from the shower. Feel much better. Going to write a short letter now.

8:18 PM. just been reading and waiting on mail. sure hoping to hear from mom.

10:01 PM. Got a letter from mom. wrote her back a short note. Tired going to sleep.

Thursday March 13, 2014 6:19 am. I'm so tired.

I was trying to go back to sleep this morning and couldn't get to sleep.

At 6 am. I finally got out of bed. I'm going to do some reading then writing William. just got lunch, sardines, I'll eat later. wrote a long letter to mom. and two short letters.

11:17 PM. just wrote killing for my blog. Going to walk for awhile. Henry has seven days to live. I hope he gets a stay.

3:40 PM just waiting time. I'm extremely tired. I'm going to sleep early tonight. at least I hope I am.

4:06 PM. just finished eating, that was nasty.

6:03 PM. wrote another letter. washed some clothes. Fixing to lay down and see if I can sleep.

FRIDAY March 14, 2014 6:12 am. Finally got a good night's sleep. woke up several times, but still the best sleep I've had in about 2 weeks. Got some mail in last night, so I'm fixing to do some writing.

10:10 am. wrote 2 letters, fixing to do some reading and decide what to do next.

11:25 am. just ate lunch a banana with Peanut butter on it and some sardines. Got to

get me something better to eat. And we have Turkey later tonight. I can't eat that. I need to write some request.

1:33 PM. wrote a blog more about the Disciplinary Report and then a Request. seen Chaplain Campbell, he called my mom and came and talked to me. He's a nice guy. Fixing to do a little bit of reading.

4:58 PM. Ate dinner, nasty turkey potatoes and mixed veges. I do not like that meal, and we have it, Sunday for lunch, wed for lunch and Friday for dinner. just waiting on the shower now, then do some reading and go to bed.

7:15 PM. just got back from the shower, feel much better. washed some clothes fixing to eat an orange, then lay back and read. Go to sleep hope I get woke up for mail call.

Saturday March 15, 2014 6:06 am. Been up since 5 am washed up, made my bunk, still haven't eat breakfast probably eat about 7 am. Didn't get a single letter last night. Henry has 5 days to live. was laying here thinking about him last night. Guess I'll write a grievance or two here in a few minutes and see what else I can do to pass the day. oh McCray's down here talking to his self. I've tried to talk to him, he will not answer me or anyone else. I seen his shower slides are broke, so I'm going to buy him a new pair. Wish I could do more for him. He's forgotten. Doesn't get canteen, doesn't get mail. He sits in his cell.

America is a sick society, for they either lock the mentally ill in prisons where they are abused by other inmates or staff, or kill them in the death chambers. We're real civilized over here. Not!!

9:42am. They just did cell search, looking for extra food, took one orange from me. That's all I had. I opened my sardines and drank my milk. And I've got a stomach ache from that. I was writing my mom. Need to get back to that, and write a couple of organizations.

11:36am. just finished eating, wrote on death penalty org, and fixing to write another.

1:34pm. wrote a death penalty org, then got to reading a legal case, which supports what I'm hoping to accomplish. I need to walk for a bit and then write another org.

3:17pm. wrote another org, then did some reading, soon as I eat dinner, which is a PBJ (Peanut butter and jelly sandwich) I may go to bed, or read until I do. I'm tired.

4:38pm. just finished eating, P.B.J. sandwiches. Going to do some reading and go to bed. I'm really tired. I don't know why, I haven't done much of anything.

7:02pm Going to bed. was reading for the last couple of hours. a book by Nora Roberts called Carnal Innocence. It's a good book, she's a good writer. Another day gone.

Sunday March 16, 2014 5:57 am. Been zcp since 5 am washed up, made the bunk cleaned the cage. Read for a few minutes, and now I'm fixing to do some writing. I'm going to write a couple of lawyer's, try to get them to represent our families in this matter of challenging the death penalty. I need to write the ACLU again, although I have no faith in them. Still want to try to motivate them.

6:57 am. Finished a letter to a legal group, ate breakfast 10z cereal, and a PBJ sandwich. Going to walk for a few minutes then write more.

8:15 am. Just finished another legal letter.

10:47 am. Wrote several request, dealing with the kitchen, and foot lockers, and wrote for some rules.

wrote a short letter and now just waiting on lunch. After which I hope to get a couple of my legal book's, and go through them to find some more organizations. Now, I'm going to read.

11:48 am. Finished eating lunch. Didn't get my book, still going to write a couple of other orgs.

1:35 pm. Just been reading and passing time. Got my book sent over, but the addresses that I was looking for aren't there. Oh well, still need to write another letter.

4:01 pm. Just finished eating dinner. Fish, not sure what kind it is, but it's good. Probably the best meal that we have. I'll no doubt do some more reading and maybe another blog

post, In fact, I want to do one on the ACLU.
5:05 PM: Finished up a blog post ACLU. maybe
it'll get some one's attention, and get them to
do some work down here. I'm about ready to
go to bed and wrap up another day on death row
and disciplinary confinement.

6:08 PM. Well I'm done writing. Fixing to lay down
and try to go to sleep. McCray is making a lot
of noise, so not sure that's going to work. I need
to get him moved. He's not on D.C. they just
don't know what to do with him. There's no
place for mentally ill death row inmates. And
that's because the state doesn't want to
acknowledge that they have mentally ill inmates
under the sentence of death. Robert Henry
has 96 hours left to live. sure hope he gets
a stay. I met him 23 years ago, February 1991.
now met him in the visiting park back in January.
His fate will be determined by the time this
is posted, he will have either gotten a stay, or
be murdered by the state. Hope for the best
expect the worst. And with that I close out
another day on death row.
