"WHETHER WRITING TO RONNIE AS A FRIEND, SENDING A MONEY ORDER OR BANKER'S CHECK AS DONATION, OR IF YOU WISH TO ORDER ONE OF HIS PERSONALIZED CROSSES." "THE FUNDS WILL GO TOWARD HIS FIGHTING FUND." ADMINISTRATIVE CONFINEMENT TIME REVIEWED AND CONSIDERED BY THE DISCIPLINARY HEARING TEAM AT THE TIME OF THE HEARING.
