ENSLAVEMENT; NEUTRALIZED
DEATH BY LONG-TERM INCARCERATION

RE: STOP THE LEGAL-LYNCHING OF BLACKS
BY WHITES. DOMESTIC WAR CRIMES OF
MALICIOUS/VINDICTIVE "RACE-HATE" PROSECUTION
WITHOUT JURISDICTIONAL "STANDING" OF
"PROBABLE CAUSE" OF A LEGITIMATE BONA FIDE
VICTIM. PLAINLY PUT: IN OPEN COURT UNDER
OATH, THE DRAFTED NAMED-VICTIM JOYCE RODERS
TESTIFIED REPUDIATING THE VICIOUS LIES OF THE
WHITE RACIST CORRUPT, VILE PROSECUTOR DEBORAH
ANN LUCKY OF HER VICTIMIZATION; DENYING THAT
SHE HAD BEEN THREATENED OR ABUSED BY ME.
PROSECUTORIAL WITNESS PERJURY, COMPLICITY
AND PROSECUTORIAL RICO CONSPIRITORY ACCESSORY
TO PERJURY; BY COSIGNING AND LYING TO THE JURY

MY NAME IS ELDER OTIS LEE RODGERS, SR., A
65 YEAR OLD AFRIKAN AMERIKAN BLACK AND THE
REASON FOR THE HEMORRHAGING OF MY SHARING
OF THIS IRREMISSIBLE TRAGEDY OF THE STORY OF

1 MY DEATH (RIP IN MARTYRDOM ELDER OTIS LEE
2 RODGERS) IS TO WARN OTHERS OF THE CONTIN-
3 UOUS LEGAL-LYNCHING OF BLACKS IN THE 21ST CENTURY

5 NEVER HAVE I RISEN WITH SUCH UNALTERABLE CERTAINTY
6 IN THE PASSION OF MY DUTY AND INTENSE OBLIGATION TO
7 EXPOSE AND ALERT THE RESPONSIBLE GENERAL MORALLY
8 CONSCIOUS PUBLIC OF A MOST GRIEVIOUS DESPICABLE CRIMES
9 BEING COMMITTED IN THEIR NAME BY SWORN PUBLIC
10 OFFICIALS, DOMESTIC WAR CRIMINALS. PROSECUTORIAL
11 RICO PERJURY CONSPIRACY COMMITTED AGAINST ME BY
12 4 MEMBERS OF THE RIVERSIDE COUNTY, CALIFORNIA DISTRICT
13 ATTORNEY'S OFFICE AND A CIVILIAN, AN ILLEGAL ALIEN.

15 I WAS UNJUSTLY AND WRONGFULLY TRIED AND CONVICTED INTER
16 ALIAS OF ASSAULT W/A FIREARM AND CRIMINAL THREATS;
17 CRIMES THAT NEVER EVEN HAPPENED ACCORDING TO THE
18 PRE-TRIAL (8-30-01) TESTIMONY OF THE ASSIGNED VICTIM, MY
19 BEAUTIFUL BLACK WIFE AND INITIALLY VERBALLY STATED BY THE
20 PROSECUTOR'S CHIEF PERCUPIENT WITNESS, SANDRA RODRIGUEZ
21 (ON 7-15-01) TO 911 DISPATCHER BARBARA LANG. BUT AFTER HAVING
22 BEEN SUBORNED UNDER THREAT OF DEPORTATION, WITH 3 ANCHOR
23 CHILDREN; WITH REWARD OF A U-VISA, ALONE IN HER HOME
24 (ON 8-27-01), FIVE-WEEKS AFTER THE FACT - BY A 21-YEAR L.A.P.D
25 DETECTIVE EDWARD G. RAMIREZ (RAMPART SCANDAL GANGSTA) HIDING
26 OUT IN RIVERSIDE AS AN INVESTIGATOR FOR THE D.A.'S OFFICE
27 TWO-YEARS THEREAFTER AT MY TRIAL (6-26-03), THE ALIEN
28 TESTIFIED INTER ALIAS THAT SHE HAD ALWAYS SAID THAT

1 SHE SAW A GUN PRESSED TO HER BLACK JANE DOE'S HEAD
2 (RT-151:11-12). ALTHOUGH, IN SELF-IMPEACHMENT THE ALIEN'S
3 HUSBAND FRANCISCO SANCHEZ (RT-169:11) CONTRADICTED HIS WIFE
4 ACCORDING TO HER TESTIMONY, TELLING HER TO GO TO SLEEP THE
5 COUPLE WAS "JUST ARGUING" (RT-176:4-5). THE PROSECUTOR BRIAN
6 D. KING STATED FOR THE RECORD: HE COULDN'T FIND THE HUSBAND A
7 MATERIAL WITNESS WHO HAD MADE EXCULPATORY STATEMENT (RT-
8 58:17-27, 63:22-24, 64:46, 71:14-27, 72:26-27). DID KING ADMITTED
9 HE WASN'T GOING TO CALL THIS MATERIAL WITNESS ANYWAYS (RT-66:17-27
10 TO CONTRAVENE CALIFORNIA'S CONSTITUTIONAL TENTH-IN-EVIDENCE STATUTE

12 MOREOVER, THE 911 SHERIFF'S DISPATCHER BARBARA LANG TESTIFIED
13 THAT THE ALIEN WAS A (PERJURIOUS-LIAR) BECAUSE SHE HAD INITIALLY
14 (ON 7-15-01) REPORTED INTER ALIAS TO HER THAT SHE HAD "NO VISUAL"
15 (RT-302:20) AND "SHE SAW NO WEAPONS" (RT-306:78). IN COLLABORATION
16 THE ARRESTING DEPUTY GARY BOWEN TESTIFIED THAT HE WASN'T TOLD
17 OF A WEAPON PRESENT, VISIBLE (RT-224:27-28, 225:1)
