My article details our failure here in the Commonwealth to have a compassionate medical release vehicle written into law and how this aging prison population is placing a truly uncecessary burden upon the taxpayer, while further working to create a prison system of hopelessness and failure. My hopes with this piece would be for some supporters from across the global community to take and interest in this truly social cause and help us with new and fresh ideas and plans toward bringing such a measure to fruition here in the Bay State. I am truly grateful to the Dodger for his work in making this happen. Bout time he grew a set for us!!!

We had a very special guest on Tuesday night April 8. Gordon E. from ESPN Boston was here. This is actually the third time he has come into the prison to worship with us and give us a presentation about his work as the Baseball Analyst for ESPN Boston. Gordon spoke to us about his experiences at this years Spring Training as well as his hopes and predictions for the team this year. He then had a question & answer period where the topics of the Ortiz/Obama "selfie", Jared Remy/Jerry Remy, Middlebrooks injury, rookie prospects, and other Red Sox Nation topics were thoroughly discussed. This man is unbelievable: such a great guy. The way he tells a story if so clear and entertaining. His temperment and lack of ego are quite rare in his business. The community

THE BAD

Well CO "MeSaid" really pulled a scumbag move on one of the juvenile offenders here who was simply trying to get what he has coming. Now I call this coward "MeSaid" as everything he wrote in his D-Report about the fantasy incident was a lie and the only thing that backs it up is that, as this fool would say, "MeSaid" it. The deal was that Stevie J. made some complaints about improper treatment of visitors and delays. He also complained that the visiting room guards, of which CO MeSaid is one, were setting clock ahead ten minutes so that they could get the visits out ten minutes earlier than they are supposed to. Stevie made them set the clocks correctly and then some oxygen waster, probably CO MeSaid, turned them ahead again. So Stevie Complained again. Now this fool, acting like a tough guy but knowing that the only reason he is "tough" is because he wears a "bitch button" on his hip. The captain and the sergeant take turns leaving their posts and "macking" on this clearly disturbed women; predators. Up in Lt. "Oh-Yea's" Property Department (we call him Lt. Oh-Yea because when they ask him, "Are you abusive?", he replies, "Oh Yea!" - typical ShirleyWorld fool) one of the property guards stole a pair of female panties from one

of the "transgendered" prisoners (that is a story for another time) and sent them over to the Health & Sanitation Officer CO Fornicator. This stellar employee Fornicator nailed them to the wall in his department for all cons and staff to see: brazen. The problem was that someone had written the name of one of the femaile guards on these bloomers, CO Hasbeen is not a bad guard as far as guards go, but she is naive as to just how cruel these ShirleyWorld layabouts are. We call her Hasbeen as she "Hasbeen" stalked by the captain, a litany of sergeants, and now CO Fornicator. When she found out about her supposed bloomers up in Fornicator's office she pitched a bitch and it got Fornicator reassigned. He lost his soft assignment as Health & Sanitation Officer (he was the one who allowed maggots to get into the diapers up in the HSU - you can't make this shit up) and was placed on some shit detail for a while. I'm sure the union will have him vindicated, but the pointis that that this place is way out of control. CO Handy is having sex with Lt. Comminher in the HSU. A nurse was carnally known by CO Sanhedrin in a back room in the SNF and the nurse is walked off the compound by investigators. Awe now as I am in awe of how he is trying to clean up the fact that he was part of the "Rat Squad" - internal affairs - and worked to have so many of his "brother" officers arrested and prosecuted) called me over to his office to "question" me about complaints being made in my block. He used his Sherlock Holme's like investigative skills to let me know he "knew" I was doing something, just so $ar{I}$ would agree. It's like saying, "I know you robbed that bank.", and the criminal saying, "Oh yea I did." Real high level "psychological interrogation" tactics. The problem with using it on me is that I don't give s shit. What I do is out in the open: I help men get problems solved. I am a prisoner rights activist. Now what really happened was that we had a really abusive guard assigned to our unit. Many, many men made written complaints, and Lt. Awe thinks I organized it: nothing could be further from the truth. But what they do is instead of addressing the abuse, the climate issue, they look for a con to persecute. On my unit I am a favorite target, operating this

blog helps with that, but I will never stop! They sent CO Hamburger (now I call him Hamburger because he and his cohorts are like the prosecutor in the Perry Mason TV show - Hamilton Burger - who never won a case. These fool IPS have 400 hundred guys taking suboxone in this camp and they are worried about me and my "complaints". Shame on them!) to tear up my paperwork. He actually was respectfull about it, it was his job and he was ordered to do it, but he also found nothing - because I did not have anything. This "investigation" is urged by Deputy mcCan't cause his thin skin and old ShirleyWorld hanger-on attitude got injured by some comments I made. I'd like to take this guy on a January fishing trip out of good old Gloucester. Maybe he would appreciate that free money he gets then. Four more years and I am out. No more McCan'ts, Urines, Denied-Ohs, etc. They got nothin for me. I could do the rest of this bid in the box and gain mega support doin it. It's not my "cell" its theirs. I have "rehabilitated" myself and will use what I learned to carry the fight outside of these walls. Lt. Awe will always be a rat. Captain Shebert will always be a stalker. Lt. Urine will always be a homewrecker, Lt. Peckerwood will always be a fool/coward, Lt. McHardly will always fight handcuffed opponents, and TIM UISE will ALWAYS be a prisoner rights activist! Viva La Revolucione!
