

THE FREEMASONS

The driving power behind the Revolution was, by their own admissions and boastings, the Freemasons. A lot of controversy and ambiguity surrounds the Masons, who they are, what they do, and when, exactly, they came about. But it is widely understood and admitted that they are one of the oldest secret fraternities in the world.

By reading their own literature, such as "A New Encyclopedia of Freemasonry" or (Ars Magna Latomorum) - 2 Volumes - Arthur Edward Waite - will give a lot of insight into who they are and how they operate. Coupling this with Our Lord's teaching that "By their fruits, you will know them", we can have an in-depth understanding into the driving spirit behind the organization. All Masons profess to be 'Luciferians' with a rivalry to, or outright hatred and opposition of, the Catholic Church. Indeed this is one of their avowed professed aims: the destruction of Catholicism and the Christian Religion from the minds of men.

Various rites comprised of varying set numbers of degrees that members must pass through in a hierarchical structure whereby lower degree initiates are restricted access to "secrets" which only higher degree members possess is the basic organizational framework they operate under. They pride themselves on deception, teaching an elaborate system of lies to lower level tiers that are refuted and exposed as false if and when a member progresses, at which point new lies are taught and indoctrinated into the initiates mind, later to be refuted, if he advances. In fact, in the labyrinthian maze of lies and contradictions, it is possible that none of them know the full truth of what the organization is about except their top leader, whoever he may be, if anyone knows at all. Yet they are expected to, and do, follow orders religiously from higher ranking members.

Their founding is also an enigma. Some Masonic authors claim they originated at the tower of Babel as stonemasons, others in ancient Greece, still others claim that they were the Biblical King of Tyre, Hiram's, Stoneworkers sent to work on the original Temple in Jerusalem for King Solomon. Others, of course, perhaps the most popular theory, trace their origin to the condemnation and burning of the leading Knights Templars in France on Friday, October 13, 1307. Officially, however, they were organized and formed publically in 1717. The rest may very well be deceptions, myths, and outright lies.

They are, however, very active in politics. Their ranks can be found in some of the highest levels of civil government, the banking world, and the media and educational industries. And though they have repeatedly been prohibited from receiving Communion in Holy Mother Church since their very inception through to modern times, and have been placed under a degree of excommunication if discovered, many Freemasons have still been able to secretly infiltrate the Church and rise to some of the highest echelons of the ecclesiastical hierarchy. Popes as recently as Benedict XVI have upheld this ban with statements such as the following, "The Churches negative judgement in regard to Masonic associations remains unchanged since their principles have always been considered irreconcilable with the doctrine of the Church, and, therefore, membership in them remains forbidden. The faithful who enroll in Masonic associations are in a state of grave sin and may not receive Holy Communion." - Joseph Cardinal Ratzinger in 'Unholy Craft: Freemasonry and the Roots of Christophobia - Arnaud de Lassus.

Several other Popes have denounced and lambasted their activity from of old, such as Pope Leo XIII, with his 1884 encyclical 'Humanum Genus' (on Freemasonry and Naturalism). In this work, Pope Leo XIII lays out the entire diabolical plan, as well as its deviations from the Truth, of the Masons that the Vatican was able to glean from several highly credible sources and investigations. One source of information was the scores of penitent, sorrowful and converted former Masons who returned like the

Prodigal Son, to the fold of Holy Mother Church in penance, confessing everything they did or knew about the aims and activities of the Freemasons. Another source was defected Masons who did not embrace the Catholic Faith, such as Captain William Morgan, who after more than 30 years of Masonic activity and learning, having become disgusted with the aims and goals of the Fraternity, went public with the Freemasons diabolical agenda by publishing his monumental work "Illustrations of Masonry". Captain Morgan was later abducted and killed by the Freemasons for his betrayal.

Several highly secret internal Masonic documents have also fallen into the hands of the Vatican, such as the "Alta Vendita", (which Pope Gregory XVI somehow obtained. This document, which lays out an intricate extensive plan for the infiltration, subversion and destruction of the Catholic Church, was guaranteed as authentic by such a highly placed and influential Prince of the Church as Pope Pius IX. Both Popes Leo XIII and Pius IX ordered the Alta Vendita documents to be published and widely disseminated so to thwart the Masons plans by 'ripping the mask off of Freemasonry'.

The Masons appear to want to destroy all religions by blending them into some interdenominational conglomerate capable of uniting all the various religious adherents of the world to unite into a one world church. Religions which teach exclusivity, such as Christianity, must be altered, or destroyed. The Alta Vendita documents lay out a plan whereby the Catholic Church will discard Her Holy, Traditional Dogmas in favor of a new, all-inclusive theology that accepts and encourages all religions in their paths to the One, True God. Except that this one true god is not the God taught by the Catholic Church, but a caricature. This new theology appears to have been implemented with the heretical 2nd Vatican Council. of 1962-65.

According to Albert Pike, arguably the most famous and learned of Masons known to the general public, the Masons are also also highly involved in social-engineering activities designed to blend all the races of the world into a conglomerate 'super-race' capable of forming one united world nation with one central governing body. Mr. Pike was a 33rd degree Mason, the highest known degree, and claimed that the US civil war was one such step in the wider goal of racial amalgamation'; he claimed integration was but a first step in that direction.

Of course, in the implementation of their plans, they rarely rely on the Truth, or even the willing complicity of, the human instruments through whom they effect their plans. In the above cited work by the Freemasonic author Edward Waite, they pride themselves that they had within their ranks almost all the nobility of the ancien regime, yet restricted them to the level of the 'Craft Degrees' and oblivious that any degrees or plans existed above their level. By such tactics of deception, they boast that they had the same individuals working against their own interests, undermining their own authority, and indeed, in the French Revolution, many of these nobility and their families, lost their heads and their lives as they were liquidated by the very Masonic masters they served. There can be no collaboration with



the Devil.

It may seem ironic that the Freemasons principle area of activity is in the Western, former nations of Christendom, but as the Japhetic nations were redeemed and transformed through the sanctifying Grace of Christ, it was inevitable that they came to dominate the geopolitical realities of the world. This becomes readily apparent with even a cursory glance at world history within the last 500 years. As much as the satanic serpent of old vented his rage and attacks formerly against the sanctified nation of ancient Israel, with an eye to destroying it to consolidate his control over the world, so now he must attack and erase the nations of the Christian West from the world to maintain his sway over the peoples of the world. No one people did as much to destroy his satanic reign through pagan religions over the souls of primitive peoples as the Christianized Japhetic missionaries and colonizers during the past 500 years.

Regarding the Masons subversive activities in the Christian nations of the West, the leader and founder of the Society of Saint Pius X, the Archbishop Marcel Lefebvre, who formed the Society to uphold the Traditional teachings of Holy Mother Church and combat the heretical new theology of Vatican II, taught that the Masons had three principle aims:

- 1) Secularization of the State; to make a state without Christ;
- 2) Secularization of the Church; a focus more on human goals; and
- 3) Secularization of souls; to make secularized souls indifferent to Jesus Christ and the life of sanctifying Grace.

Such are the aims of the Freemasons. So while it is true that certain Masons claim to be Christians, and all claim a profound respect for all religions, it is also documentedly proven that the hierarchy makes use of such 'useful idiots' working 'against their own interests' to destroy the very things they profess to love. Such is the glaring problem with secret societies in general where members take and carry out orders from individuals they do not know to work toward unknown goals that they may not agree with if they did know what they were. Such is the fate of prospective Masons who are willing to make any deal or perform any act for the promise and allure of riches, power, and influence that the Masons offer to their members. For those willing to sell their own souls, and the souls of others, the 'Luciferian' Freemasons are definitely in the business of negotiating for collaborators.

Original Sin, Actual Sin, and their effects on the Soul

The Church teaches the doctrine of 'Original Sin', whereby somehow with the very first sin in the garden of Eden, mankind's being was somehow altered and that alteration was somehow mysteriously, passed along to posterity. St. Augustine of Hippo (354-430), a brilliant Saint and Doctor of the Church, aided by the Grace and Charisms of the Holy Spirit, may have deepened and furthered our understanding of this dogma, but it's inherently been a basic teaching of Christianity from the very beginning, and indeed, since God explicitly told Eve that due to her sin, she would be driven by a "desire... to thy husband", Ge 3:16, it's been one of the mysteries of the fall from Grace taught since the very beginning.

Though Original Sin, the sin inherited from our ancestors, affects us and gives us a sinful disposition and a desire or urge to sin, we will not be judged or condemned for it. We will be judged and condemned for the Actual Sins we commit. The effects of Original Sin can be seen in Exodus 20:5, where the Lord states "for I the Lord your God am a jealous God, punishing children for the iniquity of parents, to the third and fourth generation of those who reject Me...", yet, although the sins of our ancestors affect us, we will not be condemned for them, as He states through His prophet Ezekiel 18:4, "Know that all lives are mine: the life of the parent as well as the life of the child is mine; it is only the person who sins that shall die."

Original Sin may create dispositions in us to be influenced to sin, but these influences can be fought against and overcome. Original Sin may corrupt a being who, in turn, passes that corrupted nature along to his offspring, "becoming the father of a son in his likeness, according to his image" (Gen 5:3), but with the Grace of God that comes through Christ, that corrupted image can be redeemed and restored. God instructed Cain to fight against these very inclinations at the moment he began to feel anger for his brother- "...sin is lurking at the door, its desire is for you, but you must master it." (Gen 4:7).

Protestants who have rejected the authority and teachings of the Church (Jude 8), and many recognize no authority other than their own understanding, scoff at the notion of 'Original Sin'. Naturalists and rationalists also, to a large extent deride the purely Catholic Christian teaching of this dogma. Yet the human experience alone, and even science, increasingly support the Truth of this dogma.

Science has recognized the fact that certain instincts and modes of apprehension are genetically hardwired into our DNA for some time. Absent a Faith in God's Grace and His power to redeem a fallen humanity, the application of this scientific truth has taken many sinister turns. Recognizing that certain malevolent dispositions to criminality, impulsiveness, sexual deviances, violence, and hosts of other social deformities inherent in hereditary dispositions, the U.S.A. launched the 'eugenics' program in the 1920's, seeking to sterilize and prevent the breeding of people with 'defective' genes. The Nazis went a step further, seeking to exterminate malevolent bloodlines altogether. The truth is that corrupted natures are passed along from parents to children, the error was the belief that no solution other than elimination existed. The error was a denial of Faith in God.

The original 'evolutionists' also noticed certain Truths evident in creation. Yet they filled in their faulty understanding with equally deadly untruths as well. Charles Darwin (1809-1882) in his 'Origin of the Species' and more overtly in his 'Descent of Man', noticed how natures were transmitted to posterity and how certain traits were more conglomerrated in races, tribes, nations, and families, the more conformity depending on the closeness of the relations. Yet he exceeded the mere observation of alterations in certain distinct natures by formulating his theory of evolution, that all natures inevidently arrived primarily from one nature. He observed a 'micro-evolution', yet he inferred a 'macro-evolution' occurred. Yet certain doctrines of Darwin are now widely discredited, and surely, evolutionary biologists today don't read Darwin except for satisfaction of historical curiosity.

A core discredited doctrine of Darwins was his theory of 'random genetic mutations' corrected through a 'natural selection' or a 'survival of the fittest' exerted by the environment. This defies the Reason that Darwin so highly valued and is now widely rejected. Reason demands that nothing is 'random' per se, every effect has some cause, even if unknown. A causeless effect is a logical impossibility. Even evolutionary biologists today concede the fact that genetic mutations are no longer considered random. The study of epigenetics is uncovering proof that events in an organisms life cause certain mutations to occur in the genes that organism passes along. These are known as 'Transgenerational Gene Permutations'.

The way Transgenerational gene permutations work is this: if an organism acts or reacts in a certain way for a certain amount of time, the action becomes habitual, then pathological. The 'mutations' that Darwin noted, far from being random, then mutate, change, or 'evolve' to make the behavior more easy to perform. It's a survival mechanism whereby necessary skills and instincts can be performed 'automatically' without a steady conscious effort being expended to complete them. This is a biological perspective, but holding Catholic Dogma up to the lense of modern science, we can see how it could also scientifically be understood that certain sins committed

by one or more of our ancestors could alter us physically to have certain genetic dispositions to "sin"; how depending on the actions of our first, and even subsequent, ancestors, could result in such 'blessings' or 'curses' being transmitted to posterity. Not that our scientific knowledge can ever come close to explaining a fraction of the Truth revealed to us by Supernatural, Divine Revelation, but I merely emphasize this fact to discredit the rationalistic scoffers accusations that our Faith is outdated and ignorant of modern facts that discredit it.

The Dogma will withstand a psychological evaluation as well. ~~and~~ Carl Gustav Jung, contemporary and associate of Sigmund Freud, devoted his life to the scientific inquiries into the mysteries of the human psyche. Though not a Catholic, nor setting out to prove or disprove Catholic Dogma, his results correlate with the teachings of the Church in this regard. He conclusively showed how our 'conscious' psyche, which comprises the part of our mind that we are aware of and control, is complemented with an equal yet counteracting 'unconscious' psyche. The unconscious, which we do not control, exerts an influence on what we choose to do and manifests itself most notably in phobias, attractions and aversions. It also subtly influences almost every thought and decision we make in our daily lives. Those least aware of the effects of the unconscious on the conscious psyche, Jung noted, are the ones most controlled by it. It is only when we attempt to do other than the unconscious 'suggests', such as when we attempt to scrupulously obey every one of the ten commandments, that the tension becomes acute and we become unmistakably aware that there is a side of our being that we have to vigorously fight against for control, sometimes hopelessly.

Jung divided the unconscious into two components: the 'personal unconscious' and the 'collective unconscious'. The contents of the 'personal unconscious' were thoughts and actions that were at one time consciously willed, but that, for some reason became pathological and 'pushed' into the unconscious, where they began to exert an influence on what we thereafter willed to do. This is similar to a habit that is formed, then has to be fought against to break.

The collective unconscious was a bigger mystery. It contained the entire ancestral history of a person. Every habit and content of ancestors' 'personal unconscious' were accumulated into it, so that some instincts and modes of apprehension were universally shared by all of humanity, while others were unique to specific races, tribes, nations, and families, depending on how many and closely individuals shared a common heritage and descent from the same individuals.

Again, nothing in the insights of modern scientific psychological inquiries contradicts or disproves the Catholic Dogma of original and actual sin. In fact, we can see again how Cain's anger and murder would create a breed of offspring unconsciously drawn and urged to 'give in' to an innate impulse to hate and to kill. Contrary to claims that Biblical and Church teachings are being discredited by modern science, they are actually being proved by it.

JAPHETIC ARCHETYPES

A lot of attention has been given to inherited instincts and behavioral characteristics. Yet equally interesting, though less widely known, are innate modes of apprehension. We all have acquired ways of looking at things, events or actions that lead us to certain feelings, thoughts, and reactions concerning them. For example, almost universally, humanity has an aversion and fear of snakes or even things that move like or resemble them. This is not a learned response. The same internal reaction exists even if an individual has never encountered a serpent before or been informed that they are dangerous or should be feared. Neither can the reaction be dismissed
