11:42 am. Ate Tuna sandwiches for lunch. Been writing some grievances. was reading a couple of legal cases. Unbelievable, the court's acknowledge the incompetence of attorneys here in Fla. in death penalty cases. acknowledges the problem, but doesn't want to do anything about it. Cause these judges and the American justice system - **SUCK'S!!** I'm going to be writing about it and putting it on the blog. Right now I need to exercise.

3:09 PM. just finished exercising. I didn't

4:21 PM. just finished eating a chicken sandwich. someone gave me a piece. a Brien wasn't selling any. He hasn't sold any over here. Guys are paying more money on 4 & 5 wings, so there's where all the chicken is going. money talks. I've got to finish washing clothes, bath and then work on this piece of art.

6:43 PM. clothes are done, bathed now going to bed. Tried to do some art work, just too hot.

wednesday May 28, 2014 6:17 am. Been up since 3:47. couldn't go back to sleep, so went ahead and got up, cleaned up, made the bunk, wrote 2 grievances. Didn't get any mail last night. Fixing to eat some oat meal and then do some art if they don't pull us for recreation.

7:13 am. sitting here waiting to see if they call rec, sure would like to get out of this cell.

7:34 am. The legal mail lady just came through, also found out that rec was called on the north side of the building. so I need to rewrite.

8:12 am. just sent out my grievances, and there's two birds in the window chirping at each other. I need to get back to this letter.

8:31 am. just stopped the captain and talked with him about recreation, rec yard water fountain and light covers, all of

which I have grievances on. Back is hurting
I need to get up and walk.

11:30am. They just called us for afternoon rec.

12:42pm. waiting on recreation. I need sun and
fresh air.

3:40pm. just got back in from rec. messed
around and played volleyball. That was
stupid! 'knee is killing me!' I'd rather it
hurt than my back. I need to wash clothes
and make a soup for dinner.

5:58pm. clothes are washed, ate a soup with
fish in it. knee is hurting like hell. Right
now waiting on the shower and then bed.
captain was on the rec yard talking about
we can't wear tank tops on the yard any
more. I'll file a grievance on that, and
having to wear shirts, no bathroom no
shade, and I'll figure what else to file on.

8:28pm. just got back from showers, going
to bed now.

Thursday May 29, 2014 7:12am. I'm in so much
pain, I can't hardly walk. Been up since 5am
was not a good night's sleep. I got one letter
in last night. still nothing from ANN. Got in
several grievances, which I need to file.

7:47am. Captain just came through. I'm sitting
here writing grievances.

8:38am. The grievance lady just picked up my
grievances. They also did cell clean up.

I'm making a soup for breakfast. Carleen should be here today. I need to finish a letter start another one, and finish some art work. 10:03am. Chaplain just come in, I'm getting off of this religious diet, it's not kosher any ways. The Food's open, and they have a gay guy feeling 2/3. which is against biblical regulations. 11:18am. Carleen just came. she is just killing me. The nurse also brought me some meds, which the Doctor should have discontinued. I bet I get 200 pain pills in my cell, most of which I can't use. Cause your not suppose to combine them. I'm trying to finish up a letter. 301pm. just finished writing some grievances. Now sitting back trying to deal with this pain. 4:30pm. just finished eating a beef stew over bread. Have some clothes soaking in the sink that I need to wash. I'm ready for this day to end. 6:30pm. Going to bed. been a very bad day I'm in pain. The Friday May 30, 2014 7:11am. Been up since 4am. Not a good start. I'm hurting. I turned the sick call in, but I've got to see the Doctor. I can't put any weight on my knee. 7:37am. They just called rec. I can't go. I'm trying to see the Doctor. Writing a letter now 8:52am. They picked up my grievances. I had to lay down. This pain is bad. Never had it hurt like this, to where I can't put pressure on it.

5:14 PM. Just finished eating a sausage sandwich, the sausage came from the canteen, and ate an orange. Waiting on showers and then bed.

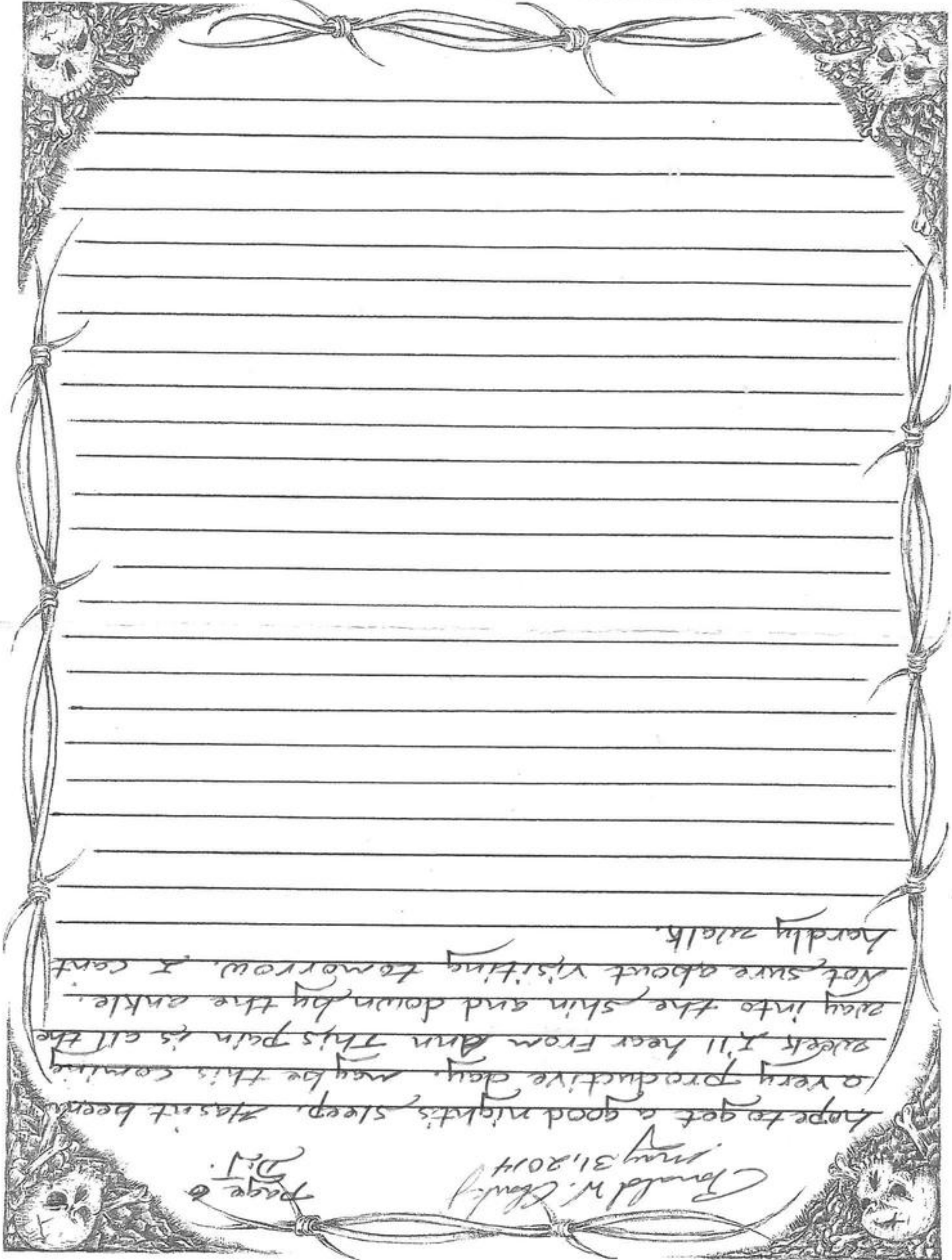
7:19 PM. Back from the shower. Going to bed. I played hell getting to the shower. Almost fell, knee is not doing good.

7:19 PM. Getting ready to go to bed. I



hope to get a good night's sleep. That's been
a very productive day. Maybe this coming
week I'll hear from Ann. This pain is all the
way into the shin and down by the ankle.
Not sure about visiting tomorrow. I can't
hardly walk.
