WHEN MAT WROTE ME AND ASKED ABOUT WHY DO I THINK THE GUY KILLED HIS NEIGHBORS. I'VE MET ALOT OF KILLERS, SOME OF THEM ARE VERY REMORSEFUL AND SOME TALK ABOUT KILLING MORE PEOPLE BUT SOME OF THEM JUST SAY IT TO STILL SOUND LIKE A TOUGH GUY. I KEEP TO MYSELF, I HAVE A FEW GUYS I HANG OUT WITH BUT I AVOID THE GANGS, I AVOID THE DRUGS, I AVOID THE HOMOSEXUALS, AND I USED TO AVOID THE CHURCH BUT THAT WAS A MISTAKE. THE CHURCH HAS HELPED ME. TODAY I GOT MY FIRST CATHOLIC STUDY BIBLE. I HAVE NEVER READ THE ENTIRE BIBLE YET BUT NOW I CAN. WE DIFFER, A LITTLE. I DON'T OPPOSE THE DEATH PENALTY.
