Case.

Let me moan about my case and the death penalty, The First week of January 1990, my co-defendant and child hood friend David stole a 380 automatic pistole From a woman name Mecca. on the night of Friday January 12, 1990 approx 9, 9:30 Pm. were walking south on U.S. 17 to Jacksonville Florida. David said were both shooting the gun at street signs as were walking. about a half mile From the Nassau Duval County line, Mr. Willis, a 38 year old white male, stops and picks us up. David said to Detective Jerry Jesonick, that I told him, the first person to stop, and pick us up, is going to get killed. Later David recanted that, and stated I said it in the truck, as Mr Willis is driving, not before we got in the truck. He changed this, realizing, that this story, was better for him. Now David was asked, "what did you say, when Clark said he was going to kill him?" David said, I told him "NO." Now David's in the middle, I'm in the seat next to the door. Mr. Willis is driving, and actually going to our destination Dunn Ave.

This is on record, all of it in sworn statements, Depositions and Trial Transcripts. We are coming up on Pecan Park Rd, and U.S 17, David who allegedly just told me "NO", to killing Mr. Willis, has Mr. Willis go pass Pecan Park Rd. maybe 50 yards and stop and let us out, in the most dark and isolated area there. No street lights. David said He wanted out to buy a Beer, it's probably 40 degrees out there

David's saying, no to killing MR. Willis, yet he doesn't have MR. Willis turn in at the Little Camp store, which is well light, and had MR. Willis dropped us OFF at that store front, there's no way David could have shot him. Which is why David had MR. Willis stop in the dark isolated area, and not at the store. I wasn't in control of the gun, or where we were stopping, IF anyone would like to see the depositions, sworn statements and trial transcripts, please leave a comment. I'll produce the documents so you can see.

My trial was a sham, I was appointed a lawyer that had never handled a death penalty trial. He was so incompetent that he didn't hire an investigator or go over to the jail and examine physical evidence. My trial lawyer current judge Henry Davis took incompetence to a whole nother level!!!
