subject: Revamping, unethical Classification staff

In 2012, inmates were being abused, beaten and murdered here at Union Correctional Institution (UCI) as a result of then warden Barry V. Reddish, and his Criminal Administration, secretary Crews broke the Administration up, with the exception of UCI's Classification, who was complicit with the Criminal activity that was taking place here from 2009-2012. Classification through 33-208.002 Rules of professional conduct and Florida statute 944, 945 had an obligation to report the inhumane treatment of the inmates, (from the assaults, strip cells, and falsifying of documents) to the secretary, the Florida Dept of Law Enforcement (FDLE) and the FBI our Classification staff never did this, and several occasions, alerted them -
