

THE KNIGHTS HOSPITALLERS

The Hospitaller Knights of St. John of Jerusalem, Cyprus, Rhodes, and Malta, known simply as the Knights Hospitallers, were one of the great medieval Crusading Orders. The Church has always had a variety of Orders to reflect the manifold Grace of God and the near limitless ways in which those gifts are used to meet the immediate temporal and spiritual needs of the sons of men. The Knights Hospitallers were one such Order of Religious Holy warriors sworn under the Traditional vows of poverty, chasity and obedience to serve and protect the people of God. An additional vow peculiar to the Hospitallers was that they would never retreat or surrender to an enemy unless outnumbered by odds greater than 3 to 1. Like Priests and Monks of other Traditional Orders, violation of these vows made acts into a mortal sin that would otherwise have been lawful to other believers.

The Knights Hospitallers had two chief ministries: one to protect the Christian people by engaging the Muslim agressor sent to attack them, and the other, formerly chief, ministry was to care for the sick, diseased or wounded in their extensive networks of hospitals and hospices. Hence the name "Hospitallers". The modern secularist world delights in issuing wave after wave of libelous attacks on the Hospitallers as bloodthirsty killers who killed indiscriminately in the name of God, but, like so many other deceptions poured forth from self-proclaiming "respectable" professions, nothing could be further from the Truth. The growth of the Order of the Hospitallers into a militant warrior Order grew out of necessity, not by choice.

The founder of the Hospitallers was a man beatified, though not cannonized, by the Church, "Blessed Gerard". He was a devout Catholic who renounced all worldly wealth and ambition and consecrated himself to the service of God. Journeying to the Holy land, he frequently made pilgrimages to the Holy sites of the Life of Our Lord such as the Church of the Holy Sepulcher where Jesus Christ was laid to rest in a tomb and where, 300 years later, the emporer Constantine the Great's mother Helena constructed a Church on the very site in commemoration of Our Lord. It was a common occurence for pilgrims from Christian Eurppe to make long journeys to the site to fulfill vows and perform pennances for sins committed against Our Lord.

Since the advent of Islam, the Arab hordes had been raping, burning and pillaging their way in concentric circles from the Middle east, forcing any and all to embrace the heathen religion of Muhammed. Forced conversion was an accepted part of the Islamic faith. Any non-Muslims who crossed their path could be expected to undergo little more than slavery or death. For Jews or Christians, however, concessions were made. As long as they renounced the commandment of Our Lord to make "disciples of all nations", swor not to proselitize, accepted muslim overlords and paid extortion fees in the form of a special 'Jazyia' tax, they were tolerated to exist. Any other religion was to convert or die.

As the Islamic Arabs fought and seized control of the Holy land from the Christian Byzantine Empire (who had controlled Palestine since New Testament times) pilgrims of Christians into the Holy land became increasingly perilous. Christian caravans were frequently attacked, beaten, robbed, or left for dead by Islamic bandits as they brought offerings to the Churches of Palestine. Their wives, daughters, or young sons were often captured by the Muslims and sold into slavery. Coming across such victims who were maimed, wounded, or unable to continue on, Blessed Gerard began to care for the waylaid Christians. Soon he was caring for so many victims that he had need for more and more space until his mission resembled a modern hospital filled with the dying, wounded and recovering victims. He attracted help and donations for his work. He charged none and turned noone away.

One day as he was dressing a patient that had, under his care, regained enough strength to return home into Christian Europe, Gerard was haunted with a vision of the Risen Christ who asked "Did you heal me only to turn me loose to be beaten and attacked again?" Horrified, Blessed Gerard understood Our Lord's words. Many of those he cared for were re-attacked and killed or enslaved by the same Muslim bandits who had initially attacked them as they journeyed unprotected on their way home. Hesitantly, but necessarily, Blessed Gerard picked up the Sword of Christ. He would no longer sit passively by as Christians were attacked.

His followers were henceforth trained in medicine and warfare. Large caravans of Christians were accompanied by guards of his Knights until they were safe from Muslim brigandage. When Blessed Gerard died, his followers continued his work. Unfortunately Muslim aggression only increased, and the need to protect defenseless Christians increased with it. In 1009 the Muslims attacked and looted the Church of the Holy Sepulcher, stealing everything, even the relic of the True Cross upon which Our Lord was crucified. It would take almost a hundred years and a Crusade to get it back.

The Christian Kingdoms of Europe turned a blind eye to Muslim aggression for hundreds of years to no avail. The Muslims disdained the long-sufferingness of the Christians as weakness and exercised absolutely no restraint on their atrocities they committed on any and all they could. Between 1096-1099, the Christians initiated and executed the First Crusade, finally, and the Hospitallers were at the forefront of the Christian victory, their battle tactics and skills in fighting the Islamic aggressor honed to perfection in over a hundred years of fighting Muslim abuse. In 1099 the Crusaders completely subdued Jerusalem, obliterating the Muslim occupiers who had subdued and enslaved or exterminated the previous inhabitants. Kneeling down, the Crusaders, and Hospitallers included, sang a "Te Deum" in unison to God, thanking Him for the victory. Absolutely amazingly, Islamic sources, along with a Zionist controlled Hollywood establishment and a Masonically indoctrinated American educational system, have never stopped lamenting how wrong the Christians were in launching such a counter-attack and reconquest after hundreds of years of abuse. The Great Deceiver, indeed, is alive and active in our world and nation today.

The Crusaders came and went but the Hospitaller Knights never did. They morphed into the elite of the elite of protecting Christian Europe from the advance of Islam. As the Crusaders became besieged and slowly left the Holy Land, the Knights Hospitallers dug in deeper. Their most impenetrable stronghold, the "Krak des Chevaliers" still exists today in the west coast of Syria. They fought until they could no longer fight, then withdrew to the island nation of Cyprus to fight some more and hold the line against Islam. Generation after generation of Hospitallers yielded up its martyrs, but the valiant Knights fought on to hold the line.

As they grew and became more disciplined, more stringent requirements were demanded to ensure that only the best of the best could serve. A man had to be descended from nobility for at least three generations before even the consideration of admittance was contemplated. Many noble families vowed a child at birth (not unlike Samuel of Old Testament fame) to the Order as a gift to God, whom the warrior monks then raised as a warrior from birth. The First Order were all ordained monks who followed the 5th century AD 'Rule of St. Benedict' that all of the Benedictine monks and nuns of the world still follow today. The Hospitaller Cross consisted of four equal arms on a cross in which the ends were inverted to yield two points on each arm, or eight points total. The eight outward facing points represented the 8 langues, or nations (languages), represented in the Order. As mentioned before, the First Order was composed solely of the children of the nobility of all the kingdoms of Catholic Europe and they were known as the 'Knights Crosses'. A third, lay, order existed in which membership requirements were less stringent. They

too embraced a religious lifestyle and fought alongside the Knights. But they were known as half-crosses. They were a less elite support group that may or may not have been married, were not ordained religious and served under varied conditions of obedience.

In time, after over a hundred years, the Muslim assaults against the Knights Cyprus stronghold again reached the point where it became undefendable. At this time the Knights retreated to the island of Rhodes to continue the struggle against the infidel Turks. They fought bravely and died resisting the Mongol hordes that overran Muslim and Christian alike only to regroup and regroup to continue the fight against Islam after the Mongol menace had come and went.

As the Ottoman (Muslim) Sultans consolidated their Anatolian conquests in what is today known as the Islamic nation of Turkey, the Hospitaller stronghold at Rhodes (which is an island off the S.W. coast of Turkey) became the focus of intense, concentrated Islamic attacks. The Islamic hordes had conquered all of the Balkans (modern Greece, Albania, Macedonia, Bulgaria etc) and modern Turkey that all were formerly a part of the Christian Byzantine Empire whose capital, Constantinople, remained in Christian hands. Constantinople fell to the Muslims in 1452, and they promptly enslaved the inhabitants and turned the world's greatest cathedral, the 'Hagia Sophia' into a mosque.

Yet the single outpost of Christian Rhodes remained a defiant speck in a Muslim Sea. The Sultan vowed to exterminate the Knights. On May 23, 1480, the Sultan sent Meshic Pasha with a 70,000 man Turkish army to assault the fortifications of Rhodes. The Knights, who had a mere few hundred defenders, refused to surrender and fought valiantly from their impregnable castle walls. Almost unbelievably, after 2 months of intense fighting, by the end of July 1480, the Turks left 25,000 of their men dead on the field and retreated. The Knights remained undefeated. The Sultan howled!

42 years later, the Turkish army returned with 300,000 men. After a prolonged siege and an intense fight, terms were offered by the Muslims that if the Knights surrendered their castle and territory they would be allowed to leave with their lives and treasure and all of their property. Any of the citizens of Rhodes not content to live under Islamic rule also had the right of free passage. Most Knights refused. The Grand master, however, accepted the terms and prepared the Knights evacuation. In June of 1522, Rhodes fell to the Muslims.

Homeless for a time, the Knights were finally granted the tiny islands of Malta, south of Sicily, by the King of Spain to hold as an outpost against Muslim attacks against Europe. The Knights immediately dug in, set up shop, and went to work. Running fleets of guerilla ships, they harried and plundered Islamic ships daring to venture into their proximity. The Muslims controlled all of North Africa at this point and conducted similar acts of piracy to disrupt European trade. They coveted the lands and women of Europe and made frequent forays to pillage and enslave them. The Knights were sent to stop them. The Sultan vowed to destroy Christendom and erect a mosque in Rome.

Malta soon became the target of Muslim conquest. They reasoned that since it occupied a pivotal point between Africa and Europe, if it fell, the Muslims could use it as a base of operations in their future campaign against Christendom. They didn't count on the Knights' stiff opposition.

In 1565, some of the most famous Muslim warriors of all time descended onto Maltese soil. The famous Muslim corsair Dragut arrived and would die there. The Knights, again outnumbered by 5 to 1 odds, retreated behind the hastily erected walls and mounted a stiff defense. The account of the battles are too horrific to be repeated in such a small article as this. But they have been extensively recounted by eyewitnesses in Islamic and Christian histories alike. The gist of it is that the Hospitallers, betrayed and abandoned by all, who considered their cause as

hopeless, fought against tremendous odds for 2 years against an enemy that Muslim and Christian alike thought impossible to defeat. Led by an unbreakable leader who absolutely refused to accept defeat, the Grand Master pushed his men beyond the point of breaking. They fought past the point considered humanly possible by themselves and others in strict obedience to La Vallete's orders.

And yet, after 2 years, the Islamic hordes, demoralized and defeated, after having paid a price they never expected to pay and unwilling to go on paying any more, were forced to limp home. The Knights Grand Master-La Vallete, died shortly afterwards and today, his body lies entombed in the Modern capital city of Malta, named in his honor, Valleta. One of the reasons given for his unparalleled durancy during the fight was that he was one of the Knights who was forced to evacuate Rhodes against his will under obedience to a previous Grand Master of the Order and he had determined beforehand to never again submit or retreat before a muslim enemy even if that meant the absolute destruction of the Hospitaller Order and a complete martyrdom of him and his men.

The story of the Knights is more glorious than such a small account as described here can describe, but they were one of the most valiant Orders of the Champions of Christianity. They showed what a truly militant, Chivalric Christianity consisted of when confronted not only by diabolical spiritual enemies but also flesh and bone men possessed of these entities intent on attacking and destroying the people of God.

Today, we also face enemies within and without. Today, men animated by some of the most satanic spirits of Communism, Liberalism, Zionism, and Freemasonry launch wave after wave of the wicked and deceived alike against our people. Today, as then, our people, alone and undefended, face slavery, degradation, or death. The Knights gave their lives consistently in the service of God. Will you give yours today?

"The lord saw it, and it displeased Him, that there was no justice. He saw that there was no one, and was appalled that there was no one to intervene, so His own arm brought Him victory...He put on garments of vengeance for clothing, and wrapped Himself in fury as in a mantle..."

CHIVALRY — A JAPHETICALLY CHRISTIAN CODE OF CONDUCT

Different cultures and nations throughout the history of the world have spontaneously generated accepted norms and standards of conduct. These are influenced and shaped in a variety of ways by almost limitless factors which spring forth from the collective soul of a people that identifies itself as a people. Peoples who are more closely genetically related share common modes of perception and apprehension which may have deviated and developed from the rest of humanity to create quite distinctly unique cultures and values. These values, in turn, have the potential to create cultural norms that further influence and shape members of that community. Of course, it is always possible for hostile sub-cultures to develop that reject and openly oppose the cultural norms that a society attempts to impose upon it, and, thereby, exert and project an opposite counter-cultural influence into the world at variance with the prevalent culture embedded in the souls of a populace. Nevertheless, these reactionary oppositional counter-cultures are also, in a way, pushed into a corner and shaped by the culture they rebel against, if for no other reason that that they adopt a kind of antithetical stance directly opposite to the culture they identify as the enemy's.

Honour codes emanate from these cultures. Ask a person in China what the perfectly ideal leader, or mother, or soldier would be, for example, and it may elicit a far different response than that generated if an African were similarly solicited to describe his idea of an archetypically "perfect" leader, or mother, or so on. This is because the

combined total of accepted norms of these cultures have been refined and reformatted to fit into changing and mutating circumstances to bring about a set standard of conduct that is the most efficiently capable of responding to and adhering to these environments. For a culture that places little to no emphasis in spiritual matters or in a supernatural post mortem judgement by an absolute Almighty God, what is acceptable and unacceptable may be radically different than standards adhered to by a people fervently believing in a certain judgement to occur immediately after ceath.

Cultures that developed in which the local population was oppressed and pillaged by wave after wave of foreign overlords, such as Sicily, for instance, developed such codes as Omerta, in which a covert implied solidarity was understood between members of the community that manifested itself by a common set of apprehensions such as loyalty to the community, subterfuge towards the governing powers and an absolute silence code in regard to those who communicated or collaborated with the universally recognized enemy who just happened to be too strong to openly oppose.

Bushido, the medieval Japanese feudalistic code, silently imposed it's own influence on the populace of it's adherents. It entailed the open confrontation and opposition of foreigners, an emphasis on courage in fulfilling ones martial duties and absolute fidelity and submission to the acknowledged leaders of the nation. Personal Honor was the main goal of ones life, to increase or preserve it motivated men to extraordinary feats, to face loss was worse than death, and often, if a choice between the two presented itself, the choice of death was chosen first. Each of these cultures, completely incompatible with each other, caused its adherents to aspire to comply with their cultural norms. The greater compliance an individual exhibited, led to a greater sense of self pride in an individual and the esteem he experienced from other members of the community. The greater deviance from these codes led to ostracization and rejection by the greater community and such an internal sense of shame experienced by the transgressor that he sometimes felt the only recourse to expiate such shame was to perform hari kari, or ritual suicide.

Every culture and subculture, from the Taliban's Pashtunwali to the ethical norms of an inner city gang banger, has such an inherent honor code, even if not explicitly named or formulated. There exist clear designations of right, wrong, and expected modes of conduct that bring about glory or shame depending on a members adherence or deviance from them. Sometimes, in a group that does not share such a universally understood behavioral code, and where a certain amount of ambiguity exists, people transgress their limits unwittingly and experience shame and rejection for doing what they felt they should have done, other times they are rejected, punished as criminals or otherwise persecuted for actions that they are immensely proud of and consider the punishment inflicted as little in comparison with the internal gratification they experienced from the compliance with expected modes of behavior.

We, the Japhetic peoples of former Christendom, having been stripped of our religious Catholic Faith by subversive enemies sent to sow poisonous doctrines in the minds and hearts of our children, have seemed to have lost such a universal honor code. What is right or wrong is an enigma to most of our people today. The laws aren't respected, because they, too, fail to represent a standard accepted code of honor and morality. Some people feel compelled to openly flaunt and break the law where it deviates from expected modes of behavior while others commit acts openly and with pride that cause still others to shake their heads in disgust and revulsion. We, the Japhetic peoples of the West, stripped of any cultural connection with our past, are, quite literally, living in the lands of confusion.

But this was not always the case. Before the advent of the Protestant Revolt in 1517, in which Martin Luther, the Catholic monk, rebelled against

the Catholic hierarchy and invented his own alternate version of Christianity, the peoples of catholic Europe had one Faith, one Mind, one Baptism. Shortly after Luther's defection, the Protestant sects again shattered and mutated, forging a thousand different views of what is right and wrong, what is accepted and expected and what is not. Today, in the modern Babylonian culture of the West in which literally thousands of contradictory and incompatible belief systems co-exist side by side, we have reached a point where we no longer can, or do, understand each other. A return to the sanity of unity is in order.

An honour code uniquely Japhetic in nature, albiet refined and sanctified through the indwelling presence of the Holy Spirit in the hearts of millions of catholic European Christians was the code of Chivalry. Under this code, which was embraced by the whole of the varied kingdoms of Christendom, from the lowly peasant to the noble aristocrat, certain modes of apprehension were forged onto the souls of men that governed their behavior more effectively than physical governments or laws ever could.

The respect and protection of a wife by a husband, the observance of marriage vows, Truthfulness, courage in defending kith and kin from any who might attempt to abuse them, showing mercy to a defeated and subdued foe who formally requested it, a disdain for the baseness of material wealth, a concern for the sick and the poor, an absolute fidelity to ones word and vows, such were but a few examples of the internal demands of the code of Chivalry placed on a member of the communities soul. Those who deviated from the dictates of the chivalrous honour code were desposed by the community. This indirect influence kept families together, spouses faithful, warriors valient and subjects obedient. Everyone knew what was and was not expected from them and struggled to build each other and themselves up in reaching an ideal of perfection molded straight out of the Gospels of Christianity.

An example is in order. During the numerous wars in which Christian Kingdom fought against Christian Kingdom, it was not uncommon at all for two generals who mortally hated each other and were finally pitted against each other for years to, upon the defeat and destruction of one sides forces, at the moment the coup de grace was about to be inflicted, forthe defeated to throw aside his arms and cry 'mercy'. At which point the victor was obliged to give it. The captive, dutifully obedient to hids word, surrendered his arms and bowed not to attempt escape or even to attack his captor(s) even when, as on numerous occasions, such an opportunity presented itself. In numerous particular instances it occured that an enemy Knight or General was offered a bounty for his release, and upon his inability to raise the entire amount, him being released upin the condition that he would not raise arms against his enemy until the entire bounty was paid. This condition was based soley upon his word and the shame he would suffer if he broke it. Years and decades might go by in which Kingdom and countrymen were perpetually engaged against other Kingdoms, yet bound by his word alone, a general, a Knight, or a footsoldier would not raise arms again until the last cent stipulated was repaid. The very day after such debt was satisfied and he was released from his vows would find him recovring his arms and re-engaging the same enemy again on the field of battle. Such conduct was expected and was the norm in Christian Europe.

Of course, when fighting the infidel Muslims, or later, the American Indian, who were notorious for breaking their word and practicing deception, different modes of conduct were required. No mercy or quarter was given to those who could not be trsuted at their word, intermarriages could not be made for those who disdained sacramental marriage vows, and generally the laws of chivalry did not apply. Chivalry governed Christian-Christian interactions, whether that interaction was between an enemy and an enemy, a king and subject, a husband and wife, or a commander and his Kinights, everyone, in every situation knew his duties and responsibilities. There was not the ingnorance and confusion that reigns today in the de-Christ-

ianized Freemasonic West. There were, to be sure, hierarchies of the esteemed and the reviled, but these hierarchies of social status relied more on the beauty of inner spiritual strengths and virtues than it did on the material wealth and accumulation of endless things that form the basis of social standing today.

The culture of Japhetic Christendom was rich and alive and produced a better class of men than the decadent and diseased culture of today which leads further and further into degradation and death. Whether he realizes it or not, Western man, somewhere deep in the collective unconscious of his soul, after having the souls of his ancestors touched and transformed by Divine Grace, inwardly yearns to embrace the principles of Chivalry. Something deep in his soul causes him to feel shame when his actions depart from such principles and somewhere else cause him to feel pride when he unconsciously cooperates with the suggestions imprinted Spiritually on his soul. For the confused and the identityless products of American Maonic society, a return to Catholic Chivalry is in order. It is a developed cultural code approved by a more faithful populace and tested by the trials of circumstance. Anyone interested in learning more about this unique Japhetic cultural honour code is encouraged to consult Erasmus of Rotterdam's "Handbook of a Christian Knight". Anyone else who is deeply moved by its demands and dictates is encouraged to implement it in small groups a Catholic Japhetic groups as its governing and defining communal spirit, and subculture.

THE SUPPRESSION OF THE TRUTH

Our lady of fatima warned us in 1917 that "if Russia is not converted, it will spread its errors abroad, resulting in wars and rumors of wars..." Since then, the "errors" of Russia have not only emanated from Russia and spread abroad, but have become firmly embedded in the minds and thinking of the nations of the West. But what exactly is an error, but a deviation from the Truth? And how do such errors cause death and destruction? Furthermore, how can we even identify such errors?

"That we should no longer be children, tossed to and fro and carried about with every wind of doctrine, by the trickery of men, in the cunning craftiness of deceitful plotting." Ephesians 4:14

There are all sorts of crafty lies that people advance to use, abuse and manipulate others into serving their own agenda and working against their own interests. Most people unacquainted with the modus operandi of the usurious banking world are shocked to discover that after all payments and fees are made and tallied, they learn that they may have paid upwards of \$450,000 or more on a measly \$100,000 home loan. The lender shows a carefully crafted payment plan of perhaps the minimum monthly fee possible to cover primarily the interest of the loan initially with a fraction as low as 5% or less of the payment going towards the satisfaction of the Principle of the loan. That way, over the life of the loan, a borrower is squeezed for the maximum amount of interest possible while still being led to believe he/she is making progress. A carefully crafted plot made to appear beneficial to the borrower, the system of usury denounced by Pope and Bible alike, is actually designed with the intent to enslave and defraud.

The political arena is fraught with even more carefully crafted deceptions, "by the trickery of men", designed to defraud and enslave, albeit in a subtle manner unperceived by the common man. One of the errors affecting 'Sons of Japheth' constituents so directly is the anti-European and anti-Christian character so prevalent in those most indoctrinated into the Communistic and Masonic worldviews.

The most affective way of implementing an atmosphere of anti-white and anti-Christian bias is through the use of carefully crafted propaganda. Anything a white person or a Christian does wrong or is even suspected or accused of doing wrong is highlighted and magnified, then brought

to the attention of as many people as possible for as long as possible. The actions of individuals are attributed to groups as a whole, such as the following example: instead of truthfully stating that a small portion of wealthy landowners owned slaves in colonial America and were opposed by the far majority who created and funded underground railroads and abolition movements, the crafty propagandist simply states (authoritatively) "White people enslaved the blacks." ; "Christians are guilty for the rape and plundering of Africa..." ; "Western civilization has been built and sustained on the oppression and exploitation of indigenous peoples..." These lies, which are distortions from the truth, have the effect that prolonged exposure to them cause masses of people to unconsciously associate "White person" or "Christian" with "bad", "evil", or "enemy". Thus the way is paved for more overtly hostile attacks.

Of course, the simple Truth puts the lie to flight. The sword of Truth, the Word of God, which comes out of the mouth of Christ at Armageddon to destroy and dissipate the armies of the deceived (Rev 19:15), is the most effective weapon against the ideologies and errors of our enemies.

The most effective way to combat such calculated and coordinated villifications of a targeted group of people or peoples marked for destruction is to expose such falsehoods when and where they occur. Another is by using the Truth to make counter-accusations so that a potential aggressor is no longer under the delusion that their side is all right and good and innocent while the other is all wrong, and evil, and guilty. The counter-accusatory approach also has the added benefit of discouraging and deterring mass defections of friendly forces who then sympathize with and identifying, aiding, and supporting the enemy. By opening the world's eyes to the atrocities committed by the other side and the correlated understanding that the actions of a few are not the actions of the whole, such enlightenment would have the potential consequence of directing righteous indignation at the specific act and action, rather than whole groups of people who look, sound, or behave like the aggressor. It breaks the carefully crafted psychological error of imputation.

Satan and his agents have always worked through psychological subtleties. The infamous Esau of biblical fame, the avowed enemy of Israel, both spiritual and physical, was a man thoroughly skilled in such diabolically dark arts of deception. "Esau was a designing and deceitful man, one who ~~was~~ hunted after the hearts of men and stole their minds." - apocryphal work of Jasher 29:20. So do the enemy agents today, such as the infamous George Soros, operate in modern times.

Christians are called upon to proclaim the Truth. Communists, Freemasons, Liberals and other sects exposed as satanic by our Sovereign pontiffs, the Popes, are called upon to suppress the Truth. This is the nature of the war in which we fight. Call it a Spiritual war if you like. Call it an ideological war if the term is more easily understood. Call it an extended "Cold War" if you recognize its correlation to, and as a prelude to, actual "Hot war", but war is exactly what it is. The Church militant, we who exist on earth, are called upon to fight it.

The suppression of the Truth, universally waged throughout the earth, takes many and varied forms depending upon the framework of the systems in which it is waged under. But the intent, the final goal, as can be easily discerned, is plain.

- Australia- under the framework of Australian politics, in which no freedom of speech or the press is explicitly protected in a "Bill of Rights" such as in the U.S.A., the only thing necessary for the suppression of the Truth is carefully crafted legislation. In the province of Victoria, Australia, legislation called the "Racial and Religious Tolerance Act 2001" was passed in 2002 in which violators can be fined up to \$6,000, sentenced to 6 months imprisonment or an organization fined up to \$30,000 if it was found to have vilified or made harmful generalizations of a targeted racial or religious group. Coupled with biased judges possessed

of demonic spiritual entities that comprise the Liberal/Commie/Masonic ranks, it takes little insight to see how much tools are used to attack and silence Christian Champions of the Truth.

One such case was the conviction of two Christian Pastors who run "Catch the Fire Ministries", which produces a newsletter, conducts seminars and other evangelical outreaches whereby they present the truth as they see it. They were convicted in Dec. 2004 by the Victorian Civil and Administrative Tribunal in Melbourne, Australia for breaching section 8 of the Racial and Religious Tolerance act of 2001 for conduct that "incites hatred against, serious contempt for, or revulsion or severe ridicule of, that other person or class of persons." A scrupulous scrutiny of the case reveals that "Catch the Fire Ministries" did no more villification of Islam than most rival sects within Islam (or even Christianity for that matter) conduct when engaging an logical dialectical debates searching for doctrinal and theological truth. In the seminar in question they stressed repeatedly that they did not hate muslims, look down on them or their beliefs, but rather, viewed them as potential brothers in need of conversion. They quoted the Quran and Islamic scholars extensively and have not been exposed as committing a single deviation from the Truth.

In fact, one can infer by the ruling and the arguments, that they were convicted for nothing more than using the truth as a weapon. Which is exactly what Christians are commanded to do. Much like St. John the Baptist, St. Peter and St. Paul, and countless other martyrs condemned by governmental authorities for their proclamation of the Truth, the law, as practiced in Australia, is being used to suppress the truth. Citing Islamic sources and numerous examples throughout Islamic history, as well as a series of "hadiths" or sayings confirmed by Islamic clerics as having been uttered by the Islamic prophet, Muhammed himself, the two Christian pastors explained in detail how jihad is a principle component of Islam, and how Muslims are called upon to intervene in and alter worldly politics as a central tenet of the Islamic faith.

Heroes of the Faith- St. George- Feast Day April 23

St. George was an early Christian martyr that is widely viewed as a Militant Saint and invoked by soldiers involved in physical battles with enemies possessed of or serving the interests of the forces of darkness. In his artistical representations he is usually represented as an armored knight on a war horse spearing or attacking a dragon representing the devil. An ancient Church built in his honor exists in Constantinople, which is one of only five Patriarchal Sees throughout the Catholic world and ranks second only to Rome. The Greeks have ever since referred to St. George as the "Great Martyr."

St. George is the official Patron Saint of the nation of England today, after the first Norman Kings who conquered and occupied England in 1066 entrusted to him the Kingdoms defense. Today, the Union Jack, Britains official flag, is comprised of three crosses- St. Georges Cross, St. Andrew's Cross, and St. Patrick's Cross, representing the three nations- England, Scotland, and Ireland- existing on Great Britain.
