I WANT TO GRIEVE / QUIERO QUEJARME DE:
 Lt. D. [redacted] is guilty of threatening, intimidation and staff misconduct. On Jan. 24, 2013 at approx. 9 AM this Lt. finished my major hearing RE a staff assault, then he yells at a passing C/O (outside the conference room) to "Get Troupe out of here." He then says in a threatening voice to me, "Before I come over to this table and strangle him." I told Lt. M. [redacted] he wasn't going to bust a grape so stop acting like a tough guy. The Lt. gave me a dirty look and said he wished he could strangle me. This is a Staff Conduct Grievance. Lt. M. [redacted] threats and intimidation tactics are unprofessional and highly inflammatory. This is a reflection of not on the individual but also reflects on the SCCC attitude. They're scared to be assaulted yet seem to think its okay to provoke violence.

 Remove Lt. M. [redacted] from doing disciplinary hearings. Reprimand on his official record.

Your complaint was investigated and Lt. M. [redacted] was interviewed. You were not interviewed due to your transfer from SCCC and your IMS Status. Lt. M. [redacted] admitted that he did raise his voice in order to be heard by staff through the conference room wall/window and he did direct them to "Get Troupe out of Here" Lt. M. [redacted] also admits that he made the statement to those same staff, " Before I come over the table and strangle him" This comment was made to staff to stress his desire for them to remove you immediately and was not made to you or with threatening intent, however Lt. M. [redacted] agrees that this was not a good choice of verbiage and he will be more cognizant of what he says in the future
