- 1) I John D Hatch give the following statement
- 2) freely to and without promises having been given
- 3) by Det. JESONEK, J.
- 4) ON 01-09-90 while working at 1165 Owen Rd
- 5) with Dan Lee remodeling the house I John D Hatch
- 6) took a .380 caliber pistol from the headboard of a
- 7) bed. that Friday night (01-12-90) Ronald Wayne Clark
- 8) got the gun from me. I John D Hatch had returned
- 9) home after work at about 7pm. I washed and dried
- 10) some cloths (Clark was with me). After that Clark
- 11) and I went to the Country store and bought some beer.
- 12) At about 1030PM Clark and I John D Hatch were
- 13) walking south on US. 17 (about at Cady's Lake) when
- 14) Ronald Willis picked us up and gave us a ride. We
- 15) ^{P.D. went} south on US. 17 just south of Pecon Park Rd. where
He made a mistake admitting this.
- 16) I told the driver that we wanted to get out. Mr
- 17) Willis stopped the truck on the west shoulder of the
- 18) road and I got out. As I John D Hatch was
- 19) taking a leak I heard 7 or 8 gun shots. I John D
- 20) Hatch saw Mr. Willis slump over and Clark
- 21) was shouting "let's go.. let's go" I John D Hatch

returned to the truck. Clark drove the truck to the east end of Bird Road onto the dirt portion. I John D Hatch saw Clark ~~had removed~~ ^{J.D.H.} Mr. Willis our of the truck through the driver's side door. Mr. Willis was placed in the north ditch. Clark rummaged Mr. Willis' pockets and removed some folding money, his wallet, and a ring from off of the key ring. After that I John D Hatch drove the truck (with Clark with me) to Jackie's Seafood. (That was at about midnight Friday night going into Saturday morning) we each had a drink and then left there and went back to Bird Rd. We (Clark and I) had discussed concealing the body. I John D Hatch drove to Bird Road. Clark loaded Mr. Willis into the back of the pickup truck. I John D Hatch never drove to the residence of Clark's parents (716 Trinity Cir, Yulee, Fl.) where we got two concrete blocks and some rope. We drove to the bridge on AIA which connects Nassau and Duval Counties, by way of Amelia Island Parkway. We crossed the bridge to the Duval County side and backed the truck into the woods. Clark tied the rope around Mr. Willis' body. (He was dead at that time, I John D Hatch know because all of the bullet wounds were to the head, as far as I know). Clark tied one concrete block on each end of the rope which was attached to Mr. Willis. Clark rode in the back of the truck with ~~Mr.~~ Willis.

while I John D Hatch drove back on the bridge
2) (north bound). When we got to the highest point
3) on the bridge I John D Hatch pulled up on the

7) over the side of the bridge. After that we drove
8) back to US 17 on AIA and then north on US 17 to
9) Interstate 16 in Georgia. We were going to Tenn. but
10) when we got to Macon ^{He} ~~we~~ decided to go back to
11) Jacksonville, Fl. we went south on I-75 to I 10 and
12) back to town. Somewhere on I-75 (still in Georgia)
13) we stopped at a WALL MART and bought some
14) cloths and also washed the truck at a self car wash.
15) We got back to Jacksonville at about 3:00 PM Saturday
16) (01-13-90). I John D Hatch drove to ~~9:00 H.~~ Rosemont
17) Apartments to see my ex-wife but she wasn't there.
18) I John D Hatch drove to Jackie's Seafood where
19) Clark and I ordered some food but we left before
20) eating. We went to Joseph Strickland's house and
21) talked to him awhile and he ~~9:00 H.~~ went with us
22) to the Oasis Motel so that we could get a place to
23) stay. We had discussed that when we got the room
24) Clark was going to take Mr. Willis' truck to Pecan Park
25) Road, break out the windows and burn the inside.

~~Hatch's idea cause the gun & clothing was in the truck south but Clark went back because our cloths~~
 And the gun was still in the truck. He grabbed one of the women and they fought her over the truck keys. Clark told me that he thought that he had broke one of the women's wrist. When she kicked him in the groin^{J.O.H.} he ran away. We fled being captured by the police that night. J.O.H.

The attempted contact with my exwife (at Rosemonte Apts) was on Saturday (1-13-90) at about 1AM ~~Blog Followers~~. Hatch admits to having Mr. Willis stop in the dark isolated area. Page 1, also he states he's taking a leak. That's not what he said in trial, he testified he was walking down beside the truck. Hatch got away with murder. yes, I did some idiotic stuff! But I was following Hatch's lead, whatever he said, I went along with it. I was a stupid 21 year old kid drunk. I'll share more later. Ronald W. Clark J.O.H.
