Hello again "SOC81;

"Profound Greeting's..."

Received your (Feb.17, 2014) "comments" on: June 23, 2014. Thank You! for them. I was really in the dumps when I got your comments. Our Father really knows how to deliver us. and this deliverance, is to, his throne/himself.

"Loving your neighbor and loving G'd (YHWH), is the fulfilment of the law of Righteousness." However, what does "Loving your neighbor and G'd" entail? The answer to this question is found no other place then in G'ds word.

Yahshua Massiach/Jesus Christ stated:

"The words that I speak to you I do not speak on My own authority; But the ,Father who dwells in Me does the works."

From here, we are able to see that, Yahshua did not come spreading his own word. and dispelling the Commands of G'd (YHWH). He was in fact, preaching and teaching the word(s) of the Father from the beginning. See, Jn.14:10 - 15. Within the same line scripture, Yahshua stated: "If you love Me, Keep My commandments." Hence, we see that, "loving G'd," requires obedience to his word(s). Again Yahshua states: "I am in My Father, and you in Me, and I in you. He who has My commandments and kekeps them, it is he who loves Me. And he who loves Me will be loved by My Father, and I will love him." Further proof that, obedience to G'ds word, is proof of our love for the Father. In fact, in Deuteronomy 11:22 it is written:

"For if you carefully keep all these commandments which I command you to do--to love the LORD your G'd, to walk in all His ways, and to hold fast to Him."

From here we are able to see that, G'd intimates our obedience to his word(s) with our love for him. Yahshua again stated: "The Father is always with Me and hears Me for I always do those things that please Him." See, Jn.8:28 - 30.

The above is but a few scriptures that decree the fact that, "obedience" to our father, proves as it does in human nature that, we love our Father. and, his instructions are not burdensom. at least to those that, have his spirit which is Grace.

Yahshua, is the spirit of Grace, See, Zech 12:10; Heb.10:29. The father told a praying Paul: "My Spirit/Grace, is sufficient for you. For I wax strong, in your weekness." But as to this "grace" of which you speak. We are under Grace/Spirit of G'd. and, If we are to correctly understasnd what it was that Paul was teaching the Romans at, Rom.9:30 - 33. and, 10:1 - 12. We must embrace or, be embraced by, the Jewish believers there were expressing their inability to embrace Yahshua as the one and only sacrafice for sin. See, Rom.9:32 -33. They stumbled at the stumbling stone. Which is Masshiach, the atonement for sin. Thus, putting to death their ritual of temple sacrafice. The Jewish believers thought that, a lamb must need still be offered up for their sin(s). To which Paul aptly stated: "Masshiach is the end of

the law, of sacrifices, to everyone that believes." Thus, obliterating the disqualification of the Gentiles, Jews, Male and female. for now through Massiach, all had salvation at a fingertip through (belief) in Massiach as a sin sacrifice (Praise-YHWH)!!!! So, the Jewish believers could no longer require that the greek and other believers be circumcised to partake in the commonwealth of israel. We are in fact, GLORIFYING (YHWH) when we obey his word, and he blesses us for doing so, this becomes a testimony to the on-looker's of the power of our G'd. When we eat as he prescribes and are healthy; Dress as He has instructed and are respected and respectable; correspond with one-another as prescribed and so on, we bring GLORY to our God and his great wisdom. and declare to the world that, our G'd created all thing's. and, his prescriptions for there care shows this. See please, Deut.4:- 5 - 8; Deut. 7:9 - 10. Please read PSALM 119, regarding true thoughts on G'ds (YHWHs') commandments/instructions. and how beautiful they are. and how worthy they are to be obeyed., But remember, there are many laws contained in the TORAH. Some of which, have been completed/fulfilled in our Massiach like "the law of Sacrifices." "The law -of physically punishing sin's." "The law of temple worship as they once knew it." But, the laws/instructions regarding what to put in our bodies is everlasting as long as we are in this body. If you were able to purchase a ROLLS Royce automoboooper:) wouldn't you pay close attention to the manufactures details for care? If the BIBLE is to be believed then, we must too follow the owners manual for care.

If we did not pay attention to the owners manual. We would not know that, Sexual sin is against the individuals own body. We need G'ds instructions and the commentary of those G'd has given revelation/understanding.

Many of these T.V. preachers, as I call them, do not understand what they are teaching other's. and, are going to have to give an account to our Father for misleading G'ds Children. Yahshua, a trustworthy teacher taught, "those who do and teach to obey the Fathers Commandments/instructions shall be considered great in the Kingdom." See, Matthew 5:17 - 20. Oh, SOC81, you make Me talk too much:) You see (SOC81) how you accept some of what Yahshua taught (Matt.22:36 - 40) while, rejecting other's from the same master/Rabb. See, Matt.5:17 - 20; This is what the T.V. preachers and preachers of today, have taught you. and, it is deeply engrained in us. They are doing the same things that the pharisees andn sadducees of old. Reject what of G'ds word they don't like while harping on what of it they do. and teaching that which they do accept according to their own (made-up) or, handed-down way. See, Is.29:13.

There is a true saying among them however, "Dead people don't care what they eat, how they dress nor, how stupid they are made to look." If we are dead in Massiach, Wearing a long dress that covers your beauty and assets. and, loose fitting clothes if you are a male. is not a problem. These things only become a problem to people that are alive and still owning their own lives. "i Like eating pork and shellfish, Ect." Dead people however, do not.

The prison people have informed Me that, I will be released at the end of the year. I do not trust them. They have removed Me date at least, three times already. So, I have no confidence in thier word(s). My last release date was: May 25, 2014. But, they took it based on a lie that, I struck a fellow inmate with My walker. and, took My walker also, leaving Me confined to a cell (24) hours a day. While the inmates

and staff members steal and defile My kosher meals. I've applied to the Los Angeles Superior court for relief from the removal of My needed assistive device to no avail. Though the prison is clearly in violation of the Statutes under the Americans with Disabilities Act - Amended (ADAA). and their own, Armstrong Remedial Plan (ARP.) Which holds:

"Once the disability of any inmate has been verified on CDC 1845 disability verification form. That diagnosis may not be changed absent scientific medical evidence proving that, the verified condition has ameliorated/changed for the better."

In my case, there absolutely no evidence that, My verified condition changed from that verified in year 2012 and 2013. It has now been alleged that, the prison officials have a videotape showing My exercising and walking with My walker as if I did not need it, as the basis to remove it from Me (how subjective). I believe that, all that choose to live G'dly in Massiach will suffer persecution. and, as with Our master/Rabb, the state and its Governors were the persecutor's. America, is not. and has never been, a G'd fearing country. From its inception, it has enslaved non-whites. Totally unG'dly behavior. and, even now, promotes Go'dless behavior in the disobedience of laws and rules when in furtherance of the illegalities it desires to perpetrate on its citizens and other's, Also, G'dless behavior. We the american public daily vote in people that do not even believe in the 'The G'd (YHWH) of the TORAH. Then expect them to perform G'dliness from the positions We've placed them.

Finally (SOC81) I pray for you that, all is well with you. and that, you are richly blessed by our Mutual Father (YHWH) G'd. Oh yeah, though I was found not guilty of having struck that fellow inmate with My walker. They nevertheless found Me guilty of "participation in the riot." though there is no nexus of activities to support such a finding. The only allegation against Me was that I hit someone with My walker. Since I was found not guilty of that, There is no nexus of activity to support the "participation" finding. Also, according to their own rules, Tit.15, CCr § 3315(f)(3). One May only be found guilty of the offense as charged. Or, a lesser included offense. I don't have to tell you that, "participaiton in a riot is not a lesser included offense -- of "Battery with a weapon."" But, they do what they want to whom they want. They know that no court will decide against them for Me. It is not a matter of right and wrong, truth and error. But rather, them against us. We should be able to rely on our Government officials to be honest and just. But, oddly enough, they are not. They are corrupt. and, because lawlessness shall abound, the love of many will grow cold. See, Matt. 24:12.

My Family, sought to hire a lawyer to help Me against these corrupt officials. But, according to the report given to Me, they ran off with the money after delivering nothing. and, were scared off by the corrupt officials of the prison and state.

Unfortunately, I have no income. No money of My own and am totally reliant upon other for My support. and, am in need almost constantly. I wish I were able to handle My own affairs. People are so busy that, they are unable to profidiently do for other's. I do however, appreciate their attempts. Now, My family has blown an enormous amount of money on lawyer's who have gotten us no where. I initially requested the videotape. So that, we could proceed from there. This request was made as far back as (09/24/2013) Todate, we have been unsuccessful in that endeavor. Attorney's telling My family one thing, and, Me another. I need some prayer. and, legitimate help. I am looking for any ProBono Legal Assistance for an (ADA) disability case. and perhaps someone who could assist Me in vindicating My rights respecting the removal of My release dates over the year's re-peatedly. I miss My SOn's so much!
