Committee Comments

Retention in medium custody at RGCI is recommended. The subject has a significant length of projected time to serve as he has not yet reached his PED. Offense precludes ERP/CIP eligibility. Subject has maintained adjustment consistent with the expectations of being managed in medium custody. Enrollment in AODA remains unlikely at this time due to timeframe to release. There are no compelling DOC 302 supported reasons for transfer at this time; however, committee member Ruck will follow with subject with information on the DCI hospice program, if he is able to apply. Committee advised it is not a typical request, though an interesting one, but is not within committee discretion. Expectations are to maintain positive adjustment. A 12 month recall will be set.
