But in Georgia it flys. Not many ~~attorneys~~ defendants' attorneys(s) investigate who these witnesses really are. Sometimes that witness can be a person who is jealous of that person. Are that particular witness is trying to destroy the defendant character because they don't like that person.

The state of Georgia keeps on compiling all these inmates' with life and mandatory sentences up in the penal system. They are head for a disaster in government finances, even though it's a multi-million dollar industry. When I came to prison we had three meals a day. Question: why continue to hold the inmates if you can't take care of their medical needs and feed them. pause and think about what I am saying. you go to medical they say nothing wrong with you at Pulaski State Prison. Send you back to die. It's not just at this prison. But all over Georgia, in the penal system.

Now we are down to nothing to eat. We only get fed just enough to survive. They feed us two meals on Friday, Saturday, Sunday and holidays in Georgia. Our commissary store is so high. If your family don't have the money, your out of gas. Then their are inmates who on medicine that cause they appetite to increase, if you don't have no money your out of gas. They have a AM ~~snack~~ or PM snack but it's not much for those inmates who are on medication that has to eat with they med. It's awful, Question their is a lot of money is going into the prison industry. But where is it going, it's not going on our food and medical because those are two most unsuccessful department of the prison.

sentence with the possibility of parole. For something I have no knowledge about. According to the law everyone is entitled to a fair trial and due process of the law. But not in Georgia; they will go through any channel to destroy a person character. Whether it's true or not; they do not care. Their needs to be a international investigation of how the judges are handling these criminal case. Especially in Georgia but mainly Bainbridge, Georgia Decatur Co Judge A. Wallace Cato. Because of his habit of sentenced people harshly, that is not risk in society. But according to him they are.
