8:45 am. Finished a letter. need to write another one here shortly. Right now I'm going to have a cup of coffee, make a soup, and watch RTM. Rec was pulled on the north side, so they should be down here this afternoon. I just hope they get us.

10:58 They just called recreation. I'll be glad to get out there. I was writing a letter, then

stopped to look for legal documents. Didn't eat a soup ate a bag of Cheetos. I've got to put every thing away for rec. They won't be calling it, or getting us until 1245 100 PM. But I like to get ready before its time.

11:49am, Finished eating, the inmate picked up the trash I had set out, before giving me my tray. I said, your not suppose to touch trash, or dirty food trays like you did this morning (they got Martin cell 4102 dirty tray from dinner) before you finish passing out the food, your contaminating the food trays and your gloves. Both the inmate and officer said if you seen that kitchen and what goes on, you wouldn't eat that food, I know its dirty because theres mold under the food tray on the bottom between the slots.

12:58 PM. They just came by doing re count. That'll screw the yard up. No recreation today. That's so stupid. I think they mess the count up to avoid working. well guess I'll get back to what I was doing, writing this letter.

5:43 PM. Here's dinner, sure late tonight.

5:46 PM. wasn't even worth waiting on. I dumped it in the toilet. Wasn't prepared right and it smelled bad. I'm waiting on the shower, then I'm going to bed.

7:01 PM. Back from the shower. Going to lay down.

9:30 PM. They did master count and mail call. I got one letter. I'm going to bed.

Tuesday October 21, 2014 5:02 am. Been up since 4. The OFFICERS came through at 4:50 checking the doors with the keys which they do every week to make sure the doors work. They've never come this early. I heard they have a 6am STAFF meeting. My guess is they're going to be doing shake downs. 5:48 am. Finished eating breakfast. Cell's cleaned. I should be going to the law library today. Need to write one letter.

6:44 am. I'm number 8 on the law library list. This guy Mike O in cell P-4103 is asking questions about that meeting that was at 6 am. He handed the Administrative Sgt. some paper work yesterday. And he's known for writing notes to the OFFICERS telling them that such and such is smoking weed, or doing this or that. So there's no telling what he's done done. 11:02 am. I'm back from the law library. now I've got a lot of work to do. also found out about another canteen company that we can order from. This looks like some better items.

7:07 am. Legal mail lady just picked up my mail one letter to the Miami Herald, one to Inspector Arentino and four letters to lawyers about assisting our families. I'm writing Judge Bayer and then Father Conrad.

8:09 am. Grievance Lady just picked up the grievances. Wrote Judge Bayer and Father Conrad. I need to lay down and rest my back. Hurting!!!

11:02 am. Been working on this formal complaint. But officers just did a major shake down and destroyed my cell, now I've got to clean it up.

1:38 PM. Cell's cleaned back up. I've been working on this formal complaint. I'm almost done.

2:08 PM, just heard that Don DuFor has died. He's had cancer for years. They moved him in cell P-4121 yesterday. I heard he was in bad shape. someone who came over to use our showers last night told me that. He had been on death row since the 80s was in mississippi. He came here in 2000.

3:07 PM, word is, he's not dead, he's in bad shape on death's door at the outside hospital. But they are saying he's not going to make it. I'm sending four letters out to churches tonight.

3:12 PM They just did cell clean up passing out the supplies. I need to do some more work on this formal complaint.

4:40 PM, I gave the dinner tray away. I ate a soup.

I also figured out the officer and sgt that shook my cell down stole over \$5 worth of canteen. When you know you can get away with it, you might as well steal it. That's their philosophy.

7:42 PM, going to bed.

Friday October 24, 2014 7:10 am. just finished that formal complaint. I've been up since 3:44. I didn't get out of bed until 5 am. Then worked on this formal complaint that I'll be mailing out first thing Monday morning. also will send a copy to be placed up on my blog. It's

6:48 P.M. Back from the shower. I'm going to bed. Saturday October 25, 2014 8:53am. Been up since 5am. Wrote a letter then a formal complaint against Mahoney, for what she did yesterday.

2:14 PM. Back from the visit, I was not expecting it.

I was writing when they showed up to get me.

I'm going to watch this Dolphin game now.

4:49 PM. watched the Dolphins win. Been getting my property ready for DC. Figure I'll go to DR court in the morning. Not that it'll matter. I'll be found guilty. A black man would stand more chance in a KKK rally than an inmate would in this kangaroo red neck DR court. And that's for real. This is set up to rail road, to find guilty, not the facts. one Lt. one Classification officer, a Classification officer
