The individual who Forged this signature, knew they had no right to sign this, according to 33-601.309(2) and (4) she knows these rules, Classification who I suspect Forged her signature knows these rules. The DR #213-141428 was written by Classification. The Classification supervisor instructed my Classification officer to write the DR. The grievance response was typed by a member of Classification, which is within
