Obama calls on nations to confront extremists

UNITED NATIONS — The world is making progress on items ranging from human rights to global warming, President Obama said Wednesday, but all of that could be undone by the largest threat: extremist violence.

In his annual address to the United Nations, Obama urged all countries and religions — especially Islam — to reject the extremist ideologies that fuel bloodshed and threaten global stability.

"As we look to the future, one issue risks a cycle of conflict that could derail so much progress," Obama said. "And that is the cancer of violent extremism that has ravaged so many parts of the Muslim world."

The president's annual visit to the United Nations came the same week the United States began airstrikes in Syria against the Islamic State, one of the extremist groups cited by Obama. Attacks continued Wednesday. Last month, the president authorized similar strikes against the militant group in Iraq.

The United States has assembled "a broad coalition" to defeat the militants, including Arab states, Obama said. He cited plans to train forces in Iraq and Syria to carry the fight on the ground against the Islamic State and other jihadists. He said, "We will neither tolerate terrorist safe havens, nor act as an occupying power."

In calling on Muslims to denounce extremist ideology, Obama said a lethal group of terrorists "have perverted one of the world's great religions."

Thomas McDonnell, a professor of international law at Pace Law School in White Plains, N.Y., said it's commendable for Obama to speak out against global extremism. The challenge, he said, is that many people around the world see the United States as a longtime backer of repressive regimes, especially in the Middle East.

"We are not exactly a neutral arbiter," McDonnell said. "It's a complicated situation."

Obama's speech was in sharp contrast to his U.N. address last year. Then, he spoke of ending "a decade of war" that included Iraq and Afghanistan and having the United States shift away "from a perpetual war footing."

Citing criticism of the United States, Obama acknowledged the nation's faults, specifically last month's fatal shooting by police in Ferguson, Mo.

Though "we have our own racial and ethnic tensions," Obama said, the United States has "worked to address our problems, to make our union more perfect."

Noting hopeful signs around the world, Obama said the prospects of major wars between global powers are reduced, poverty rates are falling and the Internet is helping to educate millions.

But Obama also spoke of a "pervasive unease in our world" about events such as the Ebola epidemic in West Africa and Russian aggression in Ukraine — and terrorism.

"We come together at a crossroads," he said. "Between war and peace, between disorder and integration, between fear and hope."

U.S., Canadian jets intercept 8 Russian aircraft

U.S. and Canadian jets intercepted eight Russian military aircraft as they neared American and Canadian airspace in two separate incidents, officials confirmed Saturday.

In both incidents the Russian aircraft never penetrated U.S. or Canadian airspace and appeared non-threatening, military officials said.

"They just continued on with their mission," said Army Lt Col. Michael Jazdyk, a spokesman for NORAD, the North American Aerospace Defense Command. "We were monitoring the situation to make sure they weren't going to go in our airspace."

On Wednesday at about 7 p.m. Pacific time two Alaska-based F-22 fighters were sent to identify six Russian military flying off the coast of Alaska. The Russian aircraft included two MiG-31 fighters, two long range bombers and two refueling tankers.

The aircraft turned south and headed back toward Russia.

Hours later, two Russian long range bombers were intercepted and identified by two Canadian CF-18 fighters off the coast of Canada.

"We suspect it was nothing more than a training exercise," Jazdyk said.

Sovereign airspace extends about 12 miles off the coastline, but an identification zone extends out 200 miles, allowing nations to identify aircraft before they become a threat.

Officials say such intercepts are not unusual. They occur on average nearly once a month, according to NORAD.

Justice Ruth Bader Ginsburg says she has no plans to retire soon

Supreme Court Justice Ruth Bader Ginsburg has a message she'd like to make loud and clear to anyone wondering if she plans on stepping down any time soon: In a word, the answer is no.

Her reason, she explained in an interview with Elle, comes down to the Senate. While Democrats currently control the chamber, they do not have the 60 votes needed to

defeat a likely Republican filibuster to get a left-leaning justice onto the court.

"Anybody who thinks that if I step down, Obama could appoint someone like me, they're misguided," Justice Ginsburg said.

Her comments come as a pointed reply to left-wing critics who believe she should step down now so President Obama can appoint another liberal-leaning judge in her place. If not, critics contend, the 81-year-old justice could die with a Republican president in office, paving the way for the pendulum of the Court to tilt further to the right. And while Obama may have two years left in office, critics worry that if the Democrats lose the Senate come November, getting a left-leaning judge onto the court becomes a monumental, if not impossible, task to achieve.

"[Ginsburg] is dead wrong about something big," wrote the New Republic's Marc Tracy in December of last year. "And the big thing she is wrong about is insisting that she should not consider retiring soon, while she knows that a Democratic president and a Democratic-leaning Senate will be in-charge of replacing her."

But Ginsburg is holding to her already stated intention to maintain her position — justices have lifetime appointments.

"As long as I can do the job full steam.... I think I'll recognize when the time comes that I can't any longer. But now I can," she said.

"Who do you think President Obama could appoint at this very day, given the boundaries that we have?" she said in the interview. "If I resign any time this year, he could not successfully appoint anyone I would like to see in the Court."

A key topic in the interview excerpt was the court's shift to the political right in recent years, particularly on women's issues, and what Ginsburg sees as the primary catalyst in that shift: Justice Anthony Kennedy.

"To be frank, it's one person who made the difference: Justice [Anthony] Kennedy," she said in the interview. "He was a member of the triumvirate used to [reaffirm] *Roe v. Wade* in the Casey case, but since then, his decisions have been on upholding restrictions on access to abortion."

She also commented on her now-famous dissent she wrote after the court's 5-4 ruling in the Hobby Lobby case, which said the government cannot require closely held companies to provide employees with insurance that would cover birth control and emergency contraception, if they conflict with the employers' religious beliefs.

In the dissent, Ginsburg notably wrote, "The exemption sought by Hobby Lobby and Conestoga would override significant interests of the corporations' employees and

She added that, in her opinion, a reason for a lack of "pro-choice activity" in the country today is because the brunt of decisions restricting access to contraceptives and abortions, is felt primarily by poor women.

"The impact of all these restrictions is on poor women, because women who have means, if their state doesn't provide access, another state does."

New details in fence-jumping reveal failures in security rings around White House

As an intruder sprinted for the White House door Friday, a Secret Service officer ran to get in his way — but the intruder barreled past the officer and kept going, officials familiar with the incident said Tuesday.

A few yards farther on, the intruder, Omar Jose Gonzalez, reached the White House door. A guard was supposed to be posted directly in front, but no one was blocking the door at that moment.

Those new details help explain how the Secret Service's plan for guarding the White House — which envisioned five different rings of protection between the public sidewalk and the president's front door — failed so completely.

A plainclothes surveillance team was on duty that night outside the fence, meant to spot jumpers and give early warning before they made it over. When that team didn't notice Gonzalez, there was an officer in a guard booth on the North Lawn. When that officer couldn't stop him, there was supposed to be an attack dog, a SWAT team and a guard at the front door — all at the ready.

But the attack dog wasn't released.

The SWAT team, which didn't react in time, was trailing Gonzalez as he dove through some bushes ringing the White House's front entrance.

And when Gonzalez reached the door, he found his path clear and the door unlocked.

"One after another unit failed," said a former high-ranking Secret Service official who spoke on the condition of anonymity to describe White House security protocols. "This guy has now crossed 70-some yards of restricted area. If he has [an explosive] device on him and he gets in, he controls the White House. He could have anything on him."

Inside, Gonzalez was subdued by a plainclothes agent — the sixth ring of security that night. That agent's job is to patrol a place that intruders are never supposed to reach: the interior of the executive mansion.

Questions for agency

Gonzalez, 42, did not express an intent to harm anyone at the White House. He was carrying only a folding knife, authorities say, and said he wanted to warn President Obama that the "atmosphere was collapsing."

But the fact that he breached the White House's legendary security perimeter — and did it using the unsophisticated method of jumping the fence and running for the door — has raised serious questions about the Secret Service's preparation.

The agency is conducting an internal review of the incident. Officials will also face questions from the House Oversight and Government Reform Committee at a hearing next week.

Secret Service spokesman Ed Donovan declined to describe the details of Gonzalez's path. Asked about the criticism that the system failed at several levels to stop the intruder, Donovan said it was not appropriate to respond during an ongoing internal review.

"Any conversation prior to the completion of the review is speculation or merely erroneous judgments provided by anonymous sources who are not in a position to know all the facts and whose experience and level are unknown," Donovan said.

Already, Friday's intrusion has altered the look of the White House grounds. Monday evening, the Secret Service put up a second fence along the mansion's north side. About eight feet in front of the White House's iconic, 49-year-old wrought-iron fence, there is now a line of metal barricades that look like bike racks linked end to end.

The Secret Service said that the new fence creates "a temporary buffer zone" and that it will stay up while officials conduct their review of Friday's intrusion.

Four days after the incident, a look back shows that Gonzalez had come to the Secret Service's attention twice earlier this year. This summer, he was interviewed by the agency after raising suspicions during a traffic stop on an interstate highway in rural Wythe County, Va.

The Virginia State Police allegedly found a number of weapons in Gonzalez's car, including a sawed-off shotgun, two sniper rifles, an assault rifle, a bolt-action rifle, one intact shotgun and five handguns. Police also found a map of the Washington area with a circle around the Masonic temple in Alexandria, Va., and a line that pointed

toward the White House, police and prosecutors said.

A Secret Service official, speaking on behalf of the agency, said Tuesday that agents had interviewed Gonzalez afterward, and found no reason to charge him with threatening the president or to refer him for mental health treatment.

Then, in late August, a Secret Service officer spotted Gonzalez walking along the White House's south fence, carrying a hatchet in his waistband. Officers interviewed him and searched his car, finding camping gear but no evidence that he posed a threat.

The Secret Service official said that, at the time, officers were aware of the earlier contact with Gonzalez in Virginia. But, the official said, "he did not exhibit any mental-health issues at that point. He had not engaged in any criminal activity." Gonzalez was let go.

On Friday, less than a month later, he returned to the White House and climbed the fence.

Some may have relocated to the South Lawn, where the president's helicopter had lifted off 10 minutes before the intruder appeared. In a video of the incident, black-clad figures with guns are seen following Gonzalez, but at that point he was already close to the door.

"Who do you think President Obama could appoint at this very day, given the boundaries that we have?" she said in the interview. "If I resign any time this year, he could not successfully appoint anyone I would like to see in the Court."

A key topic in the interview excerpt was the court's shift to the political right in recent years, particularly on women's issues, and what Ginsburg sees as the primary catalyst in that shift: Justice Anthony Kennedy.

"To be frank, it's one person who made the difference: Justice [Anthony] Kennedy," she said in the interview. "He was a member of the triumvirate used to [reaffirm] *Roe v. Wade* in the Casey case, but since then, his decisions have been on upholding restrictions on access to abortion."

She also commented on her now-famous dissent she wrote after the court's 5-4 ruling in the Hobby Lobby case, which said the government cannot require closely held companies to provide employees with insurance that would cover birth control and emergency contraception, if they conflict with the employers' religious beliefs.

In the dissent, Ginsburg notably wrote, "The exemption sought by Hobby Lobby and Conestoga would override significant interests of the corporations' employees and
