No, I think I'll go through the ACA book on standards for adult correctional institutions and see what I can find in non-compliance that I can write grievances on.

11:39am. Been slinging ink all morning. Wrote Law Breakers just now. Fixing to eat lunch. It's coming down right now.

12:03pm. Finished eating, that was nasty, but I had to eat it. Now I've got to figure out what to do next. Would be watching some football, but that's not going to happen. Thanks to my Classification Officer and her Fraudulent DIR.

3:01pm. Finished a letter to mom. I need to write another letter.

4:10pm. Finished eating, now it's time to write

5:51 PM. Just finished another blog post. "UNLAWFUL USE OF Disciplinary Confinement." They screwed up by messing with me. Cause now I'm exposing everything! I'm going to lay down. I heard the Fla. Gators are winning 21-7

7:08 PM. Gators won, sick that I didn't get to see the game. I'm going to bed.

Sunday November 2, 2014 9:30 am. I've been writing all morning. I got a six page letter going to the judge in my church. pointing out the Forged signature, how their using DC. in a way its not designed and what they are doing to McCray. I've got to write Father Conrad. see if they wouldn't have been stupid and wrote that DR. I'd have been visiting with my mom not exposing their lawlessness. I need to get back to writing.

10:14 am Finished a letter to Father Conrad. need to rest my back, then I will do some more writing.

11:43 am. Finished eating. not got to figure out what I will do next.

3:09 PM. wrote an Emergency to Tallahassee I'll file that grievance tomorrow. just to try to protect myself. Cause they are probably going to come after me. with these grievances, the e-mails the judges phone calls they may not do anything stupid

then again you just never know how stupid they will be. I seen that 2 years ago, the assaults, strip cells, DR's surprised me with that, so never underestimate what they will do, cause they have murdered inmates here in Florida for far less than what I'm doing.

4:40PM. My Dolphins won 37-0. wow! just finished eating, that was a nasty meal. I'm going to try to go to sleep early tonight. In fact I'm going to lay down right now and rest my back.

6:39PM. Going to try to go to sleep. Been a busy day of writing.

Monday November 3, 2014 6:50am. Been up since about 3am. This guy Martin in cell 4102 was talking to his self. My back and hip has been hurting all night effecting my sleep. McCray started in about 4am. "were screwed!" "were all screwed!" I wonder if he had a TV in his cell and it was playing all the time, if that would give him the distraction that he needs? Never know. Mr. Connor down here, when he was off of D.C. they never would give him a TV. so he was in a cell with nothing to do, and they had him on the wrong side of the building. If he would have been on the other end, he would have been better off, the officer's down here harass him and play sex games with him. knowing that will get to him. This is an unkind environment. There is very little compassion

Why can't people just be respectable and civil? oh well.

10:03am. Ate me a soup that I was blessed

11:54 AM. Finished eating lunch, nasty crap, you read that menu southern BBQ, you think wow that's going to be a meal. you look at whats on that tray and shake your head, whats that? Just nasty crap. I've got some more writing to do, getting people to call and write MR. Eric Lane SR. the regional director.

1:30 PM. Laid back and did some reading on this book I am Troy Davis. Martins talking to his self Mike Oyola is tapping on the desk, between the two of them, they are about to drive me crazy. I'll be glad to get my shower and go to bed. I did not sleep good last night. The pain in my back and hip kept waking me up then martin over here talking to his self. I need to write another letter and then go from there.

4:33 PM. Finished eating. I wrote a request to the psychologist demanding that he write a report on the illegal housing of Mike McCray to Regional Director Eric Lane SR. I'm still working on it. Oh I'm going to stop this right now! They started it, and I can show them better than I can tell them.

5:24 PM. Finished that request. Got my stuff ready for the shower. I'm going to read some rules. would be watching the news but now I'm planning for my next grievance.

6:48 PM. I'm back from the shower, and I'm going to lay down and call it a day.

Tuesday Nov 4, 2014 6:36 AM. Nother bad night, Pain McCray, screaming, Martin talking to his self. I just Filed two Formal Grievances. I got the Informals back last night, and one's on McCray being housed down here. I've got this letter ready to go to Eric Lane, SR. The Regional Director. I have a letter I now need to rewrite. I hope to go to the law library today.

7:32 AM. Got the letter out to Eric Lane, SR. I'm not on the law library list. I know what their doing, keep me out of there and away from the materials that I need to fight them. I know that's what their doing. They are dirty like that. I need to finish a letter to Jean-Marie, and then go from there.

8:52 AM. They are doing cell clean up now. I almost fell grabbed the stand and pulled something in my left shoulder.

9:01 AM. My classification officer just picked up two of my grievances, no sly comments or talking. I guess some one up top told her "leave him alone". I'm glad of that.

11:45 AM. Wrote up 2 e-mails for people to send to the regional director and assistant secretary concerning 3 of the inmates on this wing being abused. Hey I'm on a roll, but I need to lay down. I am hurting so bad.

12:59PM. I ate lunch earlier, but I was in so much pain, that I had to lay down. My back and hip is hurting, so bad, now pain in my left shoulder. I'm falling apart. I need to do some more writing.

1:59PM. just finished another letter, I'm trying to think of that officer's name that worked on 2-north, who killed his girl friend in stark last year to hide the fact that he was dealing drugs. He hasn't went to trial. He killed her and burned her body. I can't remember his name and it's driving me nuts! Right now I need to lay down for a few minutes. rest my back.

3:26PM. Been laying back reading this book, "I Am Troy Davis" His family went through hell with these execution dates and the stress of him being killed.

4:25PM. wrote another short letter. I'm trying to build me an e-mail empire to attack the immoral unethical acts in this hellhole. Dinner should be here shortly. They just went over to 5-wing. I have the guy above me trying to keep me up with the Governors race. Wish I had a TV. But because of the unethical classification team, I can thank them for not having a TV.

But they can thank me, for the e-mails and complaints their going to receive due

5:02 PM. Finished eating, now I'm going to lay back and read some more of this book.

6:35 PM. Been reading the polls close in 25 minutes, I then should start getting some zip dates from up stairs. I'm going to lay down and rest for a while.

9:30 PM. They just did master count. I wrote two grievances. I'm going to bed and Rick Scott's winning.

Wednesday NOV. 5, 2014 6:04 am. Just finished eating breakfast. I already started writing grievances. Wrote 2 of them. I've got a couple of letters to write. Heard Scott won, 4 more years. I won't be around to see it. I think that's why Ann stopped writing, this got way to real for her, realizing I will die.

10:14 am. Been writing all morning long, I'm trying to get e-mails sent to the Regional Director. And I'm not done. But I've got to rest for a few minutes.

12:11 PM. Finished eating, that is one NASTY meal. A hungry dog would search a trash can before eating that. I finished one more letter, was reading some more of this book. I'm almost done with it. I tried to stretch it out as long as I could. Very sad story, death penalty Fearing the whole family apart.

12:52 PM. This Sgt. just come through harassing Martin here in cell 4102. Calling him a F---

Talking and degrading him like that is a violation
of 33-208.002 section (8) But whose going
to enforce the rules? No one! They screw with
Sebert Connor down there play sex games and
make sexual comments, why? Because in
this case Valdez v. Crosby 450 F.3d 1231 at
1243 (11th Cir 2006) you'll see Sebert Connors letter
published in case law, that's in the law library
in the prisons and the officers read it and
share it with each other, where Connors warns
that inmate Frank Valdez is fixing to be killed
by correctional officers, and several weeks later
it happened. But because of this published
letter in case law, Mr. Connor suffers at
the hands of criminal correctional officers.
I'm trying to get him some help now.

inary confinement, staff violates Fla Admin. codes which is governed by law, and oh its a

mistake. I don't think so. IF they don't take action in this grievance, I'll have some people

on the street file formal complaints. This is the only grievance that I have going out

today.

8:37am. They just picked up my grievance. she was talking to the officer about we can't get

any help. no one wants to work for a place the media is attacking all the time. I thought

that was funny. The Captain came through a few minutes ago. I'm writing e-mails for people

to send to the regional director. mom laid down. I wish I had someone who would really fight

these people and wouldn't take no for an answer. Those types are rare. man just

9:33am. Just came back from sick call, seeing the nurse. I'm suppose to see the Doctor next Wednesday. I was in the middle of writing a letter which I need to get back to. Blood pressure was 166/90.

11:40am. Wrote a letter a Blog titled "No Accountability and Food is coming around. I will stop and eat, and decide what to do next.

11:58am. Ate that was nasty. I'm going to lay down for a while and read some rules.

2:56 PM. I read over some rules and Florida statutes and then took a nap. I took several pain pills and the back and hip pain did easy up.

4:32 PM. Finished eating, wrote up 2 more e-mails to have sent to the Regional director.

I'm going to lay down and rest for a bit.

7:00 PM. Been laying down, but I'm about ready to go to sleep. Hopefully the officer will wake me up with some mail.

Friday Nov. 7, 2014 7:25am. Just finished three grievances. I have a letter to write and at 1 PM.

I go out to see Father Conrad I've got to get my stuff ready for that. which is what I'm going to do right now.

7:58am. I got one letter from an Attorney this morning and another letter from a Senator who said she's forwarding my complaint

10:00am my Classification Officer came by stopped and asked if I'm okay and if I needed anything I said "no thank you" she then went down and did that all the way down the hall. Never did that before. Mike yelled down and said "you got them running" I need to get back to this letter.

11:23am. Just finished a 3 page letter to the senator dealing with several issues one is the illegal housing of Mike McCray in a DC solitary confinement cell. I'm fixing to bring about some change.

11:57am Finished eating that nasty lunch for some reason I'm cold. I'm ready to go see Father Conrad. I hope he will send an e-mail for me as well to the Regional Director. I need to lay down and rest my back, it's hurting bad! I'm going to hurt myself with these garbage pain pills.

2:09PM. I'm back from seeing Father Conrad we had a nice visit. They ran him out early. That was that Sgt. out there. Seen the DR. Investigator come down this way. I got back and

4:42 PM. Finished eating, I think I'm going to lay down and wait on showers. This I'll work on the Formal Complaint for awhile.

5:09 PM. The warden Assistant warden and some white shirt just came up to my cell. She was like what's this all about? We talked for 15 minutes. She says I've got the Governor's Office and everyone else calling and I've got to respond to these people. I told her I wanted the DR. Threw out, but she made it clear that that's not happening. And I'm not going to stop doing what I'm doing. Motivation. Wait till this senator gets this letter that I wrote today. Oh

boy it's going to hit the Fan. I know they would like to kill me.

6:43 PM. Back from the shower. I'm going to lay down and call it a day. Hope for some mail tonight.

saturday Nov. 8, 2014 7:47 am. I did not feel like getting up this morning. Back is hurting and I don't feel good. But I need to get to work. I've got to finish this formal complaint, write one letter which I got from an organization last night. Then I'll write Anne, mom and go from there.

8:09 am. Well Martin is refusing to come out for a hair cut and shave, so they're bringing the Lt. down. If he refuses to come out, they will spray him with gas, chemical agents. I'll wind up breathing that in, because I'm right next door, 3 feet at most away from his foot flap, so I'm going to catch a lot of gas. Need to get back to this letter.

8:39 am. Miguel Oyola has now snapped, cause their messing with Martin. It's going to be a damn mess down here today.

11:34 am. Things calmed down, I'm glad of that. I'm waiting on lunch trying to figure out what to do to pass the day. I'm thinking about another formal complaint.

12:02 PM. Just finished eating. Oyola done sent me a crazy note about contacting a Federal judge. He's mentally ill, and I'm not

about to do that. I'm going to do some writing now.

3:08 PM. Mike Lambrix just got back from visit. They allowed him his visit, since they had already been scheduled and it was from overseas. Officers tore his cell zip, took his coffee, extra stamps and he's not at all happy right now. I laid down earlier and fell asleep. I need to figure out what I'm going to do next.

4:55 PM. Just got the food tray, all of it's ice cold so I'm having to warm it up. I'm going to go to bed early.

Sunday November 9, 2014 10:07 am. I've been awake since 3 am listening to Martin talk to his self. I wrote a 4 page letter to Regional Director Eric Lane, SR, on the abuse of these mentally ill inmates. I also wrote a 4 page request to the warden about it. She asked Friday what I'm trying to accomplish, so I shared it with her. Martin has been talking on and off since about 3 am little before. When he talks, he stops, and it's like some one responds and then he rants about the response. They are mentally destroying this human being! I heard he was fine, staff set him up with a bogus DR they sent him over here put him in that closed in cell P-4102 and he fell apart. I did six months in there. I know what it's like. Not everyone can take it. I've still got a lot of writing to do.

11:04 am. Just got the flu shot. I'm writing a

11:52 am. Finished eating lunch, it was nasty. I'm being housed in a "mental institution." Every body back here is CRAZY! I got to get these guys some help. Right now I'm going lay down for about 30 minutes and rest my back and my hand, then go at it again.

2:36 PM yelled up stairs for the Miami Dolphins score. Their losing 10-3, start of the 3rd Quarter. Wrote a letter and a grievance. I could start on a Formal Complaint. I still need to finish this other one. That's what I'll do. I'd be back from visit watching my Dolphins. Thanks to them I'm fighting the evil powers of the EDOC.

3:49 PM. Finished a letter to Momma Bear that's Anne sent her the Formal Complaint to copy dealing with the structure of P-Dorm and health issues. Heard Miami is winning 16-13. I had been watching that and not writing had I not been on D.C.

4:20 PM. Ate hot dog's, one of the better meals. My Miami Dolphins lost. Guess I'll lay down for awhile.

5:27 PM. I'm fixing to call it a day get in bed, hope to get to sleep early. Martins talking to thin air. Been at it since 3 am. Hopefully he will go to sleep, so I can sleep. I am tired. We need some people to speak out and fight for change. And I've got to lead the charge. Cause if not me, then who. Sometimes doing the right thing is the hardest thing of all.
