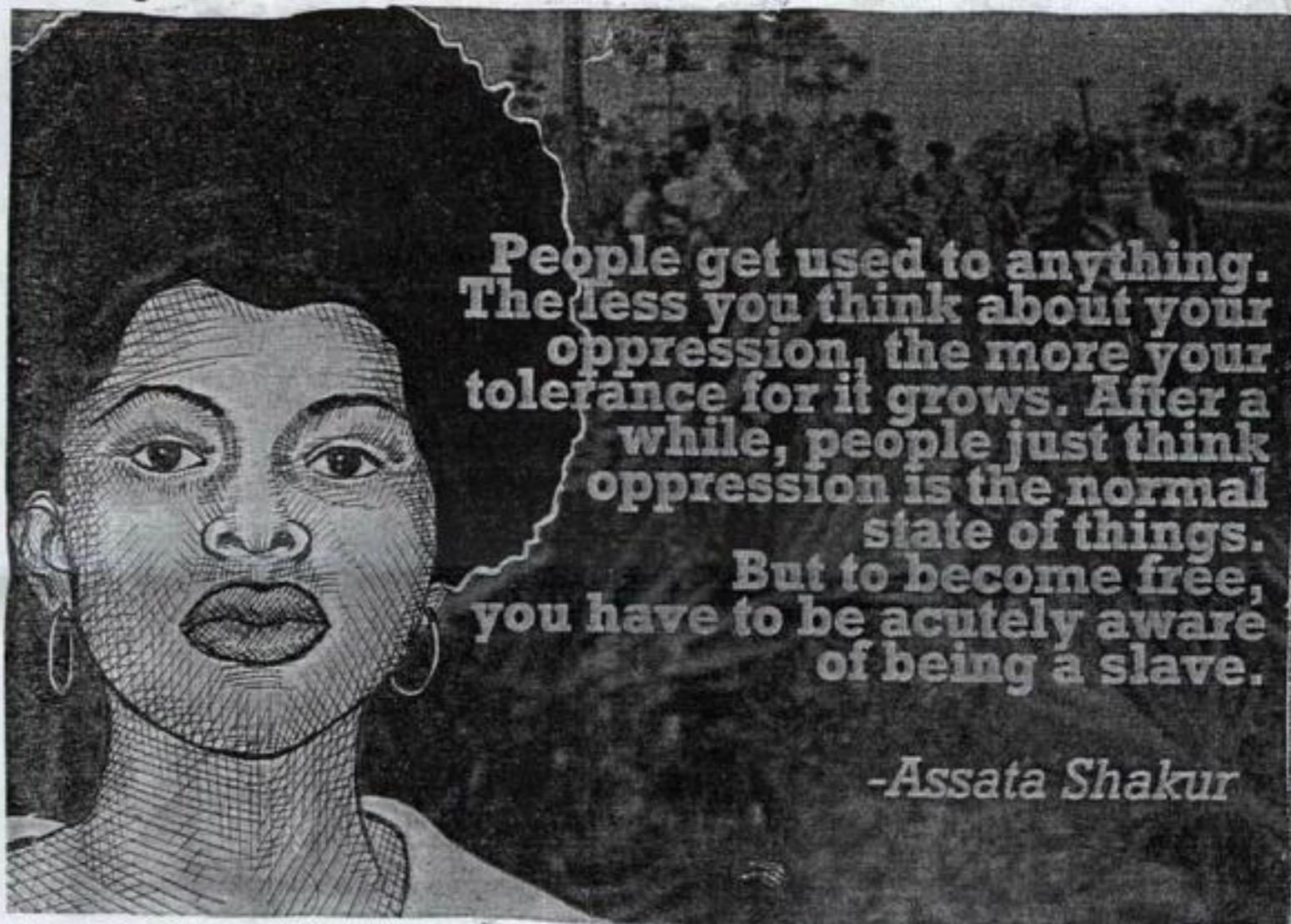


Working to Bring Justice to the Unjustly Imprisoned

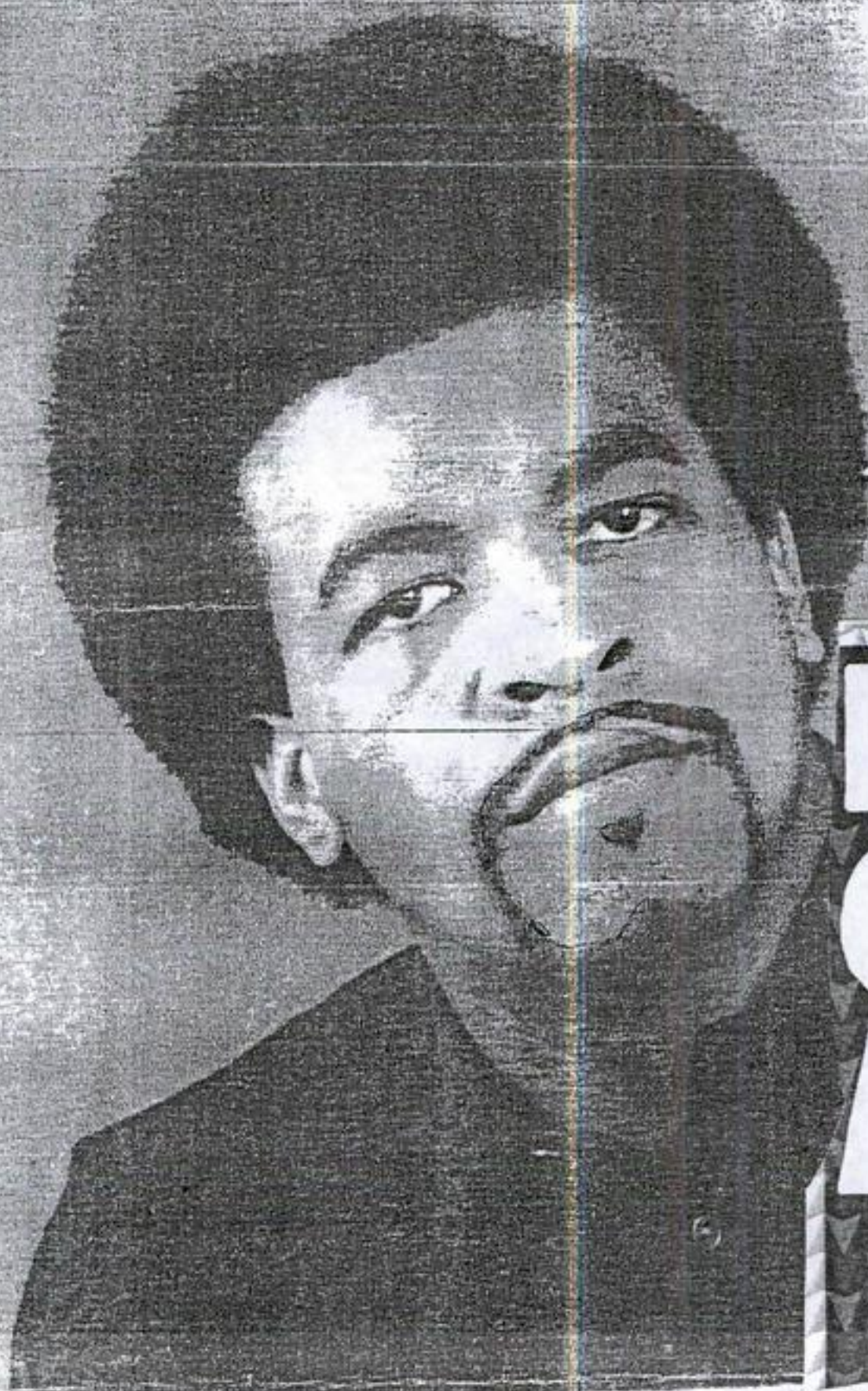

ORDER OF JUDGMENT AND DISSOLUTION **Wrongfully Convicted.**

Black ameriKans SHALL no longer tolerate systematic discrimination, injustice(fascist/Anglo-Saxon jurisprudence), corruption, denial of equal access and opportunities, racism(The psychosocial disease of many whites), by leader-less-ship pathological imperialist white ameriKans.

The defendants, past and present, individually and/or collectively through action or inaction are guilty of a long train of horrendous atrocities committed against the occupied nation of New Afrika. The history of the defendant's oppression of the plaintiff has been one of: Theft, genocide, gross & select murder, rape, racism, fascism, socio-pathological, economic and psychological terrorism. Neo-slavery(current enslavement of over seven hundred thousand blacks in commercial concentration camps called prison) and innumerable, grievous war crimes against the black people of the oppressed nation of New Afrika. ameriKKKa owes the people of the oppressed black nation for labor stolen over the last 500 hundred years - estimated between 3-9 trillion dollars. The existing white amerikan state defends the interest of the fascist/imperialist/capitalist, so it cannot consistently carry out REPARATION. amerika has reneged on its promise to the black nation of "40 acres and a mule".
THEREFORE:

- 1). The plaintiffs are granted permanent and total separation from the defendants.
- 2). The plaintiffs takes its population-percentage of ALL u.s.a., property, here and abroad by virtue of citizenship rights, in part and in particular the once slave states of Louisiana, Alabama, Mississippi, Georgia & South Carolina.
- 3). The same percentage of all assets here and abroad; to assume the same percentage of all liabilities.
- 4). The same percentage of all u.s. Military hardware and logistics, to include nuclear weapons.
- 5). The same percentage of all investments and projected developments for the next twenty years;

WITH DEMANDS FOR:

- 6). The safe return of ALL political/P.O.W.s(All blacks and their allies being held in the whiteman's prisons).

This symbolic decree is in essence a divorce, a peaceful, "fair" and equitable settlement to the age-old, nearly insurmountable problem of racism, by a majority of all parties involved. This decree will in effect END the BLACK vs. WHITE, issue in Northern amerika(u.s.a.). This courageous generation of ameriKans have taken this decisive and bold step to end the "UGLY" scourge of racism and all its despicable-ills that has plagued amerika during the parties lifetime and REFUSE(like prior generations) to cowardly pass this cancerous issue on to the next generation unaddressed and unresolved. Finality of this agreement requiring a majority of signatures/votes of all parties involved. Let "us" end the black/white issue during our lifetime.
