- SGT. YOUNG-UN INVESTIGATED BY I.R.S. / UNREPORTED INCOME

SUCCESSFUL VETERANS DAY CELEBRATION

The American Veterans In Prison (AVIP) Chapter at MCI Shirley held a very successful Veteran's Day Celebration, even with the efforts of the prison administration to chill the free speech of the honored group.

Keynote speaker, State Representative Benjamin Swan, praised the group as being "the most important in the Department of Correction" and assured the AVIP Board that he and some of his associates in the General Court would be coming back to hear what "we" had to say. This was in response to the fact that the MCI Shirley prison administration, Deputy Karen DiNardo in particular, had barred the Veterans and non-Veteran (associate) members from speaking at the event in light of an event we held two (2) years ago in which we presented the facts of failure of the DOC to state legislators. The prison administration is doing all it can to stop us from doing it again, but we have a plan and will have our voices heard again. Most troubling this time was that the administration did not allow the Commander of the AVIP, Joseph Labriola, to give a brief speech on his Vietnam experience. Joe was awarded the Bronze Star with Battle "V" for Valor and The Purple Heart for his Vietnam combat service but the prison administration feels it has the right to discount that sacrifice and silence Joe's voice: trust and believe that it WILL NOT happen and they have just confirmed to many of our supporters (their numbers are growing each and everyday!) just how much of tyrants and fascists they are! Joe bled for them, so they could have these layabout jobs, but they choose to chill his free expression, and the free expression of the whole group. That story is long from over.
