When they do that, I hear the madness, Oyola splashing in the water, Martin talking to his self. I just thought of away to get ahold of his mother. I need to find out who his attorney is, then I can write the attorney. I spoke with a guy in the visiting park who said Martin's mom use to visit him every weekend. Now he's so mentally messed up that he can't even write her. I'm going to try to walk for a bit listen to some music and go from there.

8:02 am. Legal mail lady came by, nothing for me. They did come for rec, I didn't go. I needed to get these grievances out. Plus I don't feel real good. It maybe this blood pressure.

8:20 am. Grievance lady came through picked

up the 2 grievance appeals on the DR 13-141571 and the appeal to Tallahassee on the mentally-ill. Well I'm going to walk for a bit, then watch RTM and do some writing.

10:58am. Well I haven't done a thing, my legs are swelling my foot right one is completely numb. And I was just laying down. I need to write. I need to get the Fax # for the secretary of the DOC.

12:43 PM. Showed the nurse the swelling, she took my blood pressure 154/97, still not that good. Better than 2 weeks back when it was 164/108. I wrote one letter earlier, I need to write another letter.

1:39 PM. I was sitting here writing when the officers showed up and said, they want to see you in the hall way. I was thinking this isn't good. But it was the DR hearing they found me guilty, but with 23 days gave me time served, which surprised me. I've got like 6 or 7 grievances in on this already. At least I don't have to worry about this one, but I don't think it's over. I expect more retaliation. I'm going to lay back and watch TMZ.

4:18 PM. Ate dinner, rice with gravy and meat over it. One of the better meals. Going to lay down.

4:48 PM. Canteen just came I didn't get much and nothing that I really wanted. No canteen next week. That new company is coming in. Well

I'm going to lay down, watch the news and wait for them to get the showers started.

6:47 PM. Back from the shower, I'm going to lay down and call it a day.

Tuesday Dec. 2, 2014 7:06 am. Was sitting here reading some mail. Been up since 4:30 ate breakfast at 5:30 washed up cleaned up made the bunk I'll be going out to see the nurse later. I've got to do some writing, right now I'm going to listen to some music and walk.

10:12 am. I started a letter that I need to finish. I stopped at 9 am to watch RTM. I'm waiting to go see the nurse for this sick call.

10:36 am. They will pull me for sick call tomorrow. They don't have my file.

12:58 PM. The DR investigator just brought Martin another DR and said, "you have any more grievances that you want to write against me. I seen the four grievances that was f---ed up!" see if you ever get my help again. It was McCalvin. He never did nothing to help me. What he did was to make his job easier not mine. If he did his job the right way he wouldn't get a grievance written on him. It's an easy job, but they're too sorry and lazy to do it.

3:30 PM. Finished a letter to someone over seas dealing with the death penalty, and wrote the Regional Director about what happened earlier.

4:45 PM. I got chicken for dinner, was under

8:02 PM. I'm going to bed.

Wednesday Dec 3, 2014 9:30 am. I've been up writing all morning. Wrote 3 letters. I found out that I'm back on DC for seven days. Although the D.R. team gave me time served, someone changed it to make sure I served the last 7 days. These are some sorry excuse for human beings that are in our classification. But I already knew that I need to get back to writing.

11:47 am. I took the bread off the tray made a PB & J sandwich. I heard the canteen is empty. Keeffe removed all of their stock this morning. I'm not seeing the doctor today. I'll be seeing the nurse for sick call. I wrote 5 letters.

3:55 PM. I just hooked up my dinner, beans and rice, they had what they call "Pizza on the tray. It's just extremely nasty!" so I couldn't eat it. I'm have a lot of back pain today. I'm hoping the nurse shows up soon with my pill. I'm going to eat, watch some news wait on the shower come back watch survivor 2 hours tonight then go to bed.

6:57 PM. Going to lay down, just got back from the shower, watch survivor and go to sleep.

Thursday December 4, 2014 7:28 am. Been up since 4:30 cleaned up ate and started writing. Wrote that regional director and then 2 grievances. They have an officer down here today.

11:49 am. Finished eating, wasn't very good. I need to walk for awhile, and listen to music.

3:51 PM. Finished eating dinner. I gave up the cake. I'm going on a diet. Well I'm going to walk for a bit then watch some news.

7:39 PM. Going to bed I'm tired.

Friday December 5, 2014 6:30 am. Been up since 4 am.

Woke up with cramps in my legs, ate breakfast at 5:30 made the bunk washed up. I'm going to listen to some music and do some walking, then write a letter.

8:50 am. My Classification Officer just came by saying I get OFF DC on Monday not Sunday, so Mom can't visit this weekend. I'm going to fight to change this, I'm going to stop them. I've just got to build an army to do it.

10:01 am. Just came back from seeing the nurse. I'll see the Doctor on Wednesday. At 1 PM I go to see Father Conrad. I wrote one letter this morning. I need to write another one.

11:47 am. They served lunch, I ate a couple of bites. That stuff was nasty. I need to do some writing.

2:38 PM Back from seeing Father Conrad. We had a really nice visit. I seen this little six year

old girl on the news whose dying, the doctor said this is her last Christmas, all she wants is Christmas cards. I'm getting Father Conrad to get the church behind it, and I gave the information to officers who are going to get behind that as well. Hopefully she will get millions of cards. I'll send her one Sunday night. I walked out there on my own, no wheel chair. 4:20 PM. Ate dinner hot dogs. Sgt. said Mahoney contacted him and said remove me from D.C. something strange is going on there, she didn't remove me because she wanted to, someone told her to.

6:43 PM. Back from the shower, calling it a day. Saturday Dec. 6, 2014 7:04 am. Beer up since 5 am I didn't go to sleep until 10:30 PM. I ate breakfast at 5:30 then washed sheets they are drying right now. I need to do some writing. 11:15 am. Just finished some exercises. Wrote one letter this morning, I've got a bad headache. That little girl Addie has tore my heart out. I'm trying to get as many people as I can to send her Christmas cards. I'd gladly give my life so she could live. Brings tears every time I think about her last Christmas. I need that off my mind. I've got the sheets dried and made the bunk, my cell's cleaned. I'm going to lay down at 12:00 PM and watch football.

11:49 am. Finished eating lunch. Need to wash these clothes and watch football.


5:33 AM. Finished eating, that's the best breakfast we have eggs potatoes biscuits and grits. Going to walk for a while.

with acting Assistant Warden T. Dick's above it. My DR, 213-141428 was written by Mary Mahoney, authorized by Mike Davis's Classification. T. Key typed the appeal response 1400-213-294 with Warden Diane Andrews name on it, and it looks like T. Dick's deceptively signed it. Some one here knowingly and willingly violated the rules and regulations and forged the signature under Warden Diane Andrews typed name. That is a violation of 33-208.002 section (12) and (19). When there is any knowledge of any violations of the law, rules, directives or procedures of the Dept according with 33-208.002 (3) (A) 4, section (b) is to be the next step. Since the Warden's signature is involved, I'm calling for a submitted report to be filed to the Regional Director. The forging of this signature and unauthorized signing is not only a violation of 33-208.002 12 + 19 but Fla. Statutes 944.09, 944.14, 944.35, 36, 37, 38, 39 and 47. Classification is the issue of this investigation of this grievance and therefore should not partake in it. Thank you for your time and hopefully your help in approving this grievance and filing a report in this matter.
