Your Ladyship.

Hi Lynne. Thank you for introducing yourself here. This blog site certainly has proven to be a blessing — in so many ways!

How much postage does it take to cross the border into the great white north anyway? For now I will answer your query right here ... welcoming All readers to add their comments if they wish to as well.

To your: ... "What exactly you are running into", I reply:
Down here in the Land of the Free, we have become the Land of Imprisonment, with near 2 million incarcerated — and counting! God Bless America.

In Califelony, we have approx. 180 thousand in the Dept. of Corrections and Rehabilitation, ironically producing an 85% recidivism fail rate. The vast majority of prisoners parole no better equipped to function in society than when they entered this dept. of Corruption!

Upon that premise I've long been endeavoring to be a proponent of self-help, and provocatively point out the responsibility one must take for one's own condition.

Unfortunately, it seems to me that the Dept. of Corruption is allied with a cabal of high ranking Psych's who've determined to alter our very genetic disposition and chemically castrate the prison population. Aside from their sponsored self help groups, which fundamentally promote victimhood mentalities, there is a pandemic of gender re-orientation in here ... no doubt stimulated by an exceptionally high phyto estrogen - hormonal effecting - Soy product diet. In the past 17 yrs I've watched the Cal.
