Plus wrong officer's working the wing, he may come in and destroy my property. Only thing I did this morning was get Christmas cards out asking other's to send cards to Addie. I need to write a couple of letters.

11:53am. Lunch came. I'm making some beans and rice that peanut butter they bring us on the tray is nasty, not something I can eat unless I am very hungry. I need to eat and then write.

4:20pm. Finished eating going to lay back down now. www.davidpierce.org/deathrow

7:02 PM. Got back from the shower. I'm going to lay down and call it a day.

Tuesday December 9, 2014 3:29 PM. I haven't felt like writing today, but it's been an interesting day I've been up since 8:30 McCreay was screaming out. At 9:30 I went to the Law library.

Came back around 10:30 ate lunch at 11:30 then was taking a nap. At around 1:30 the Food package showed up. I put that in my locker. No sooner did I do that then I seen two men walk by, they were inspectors, I went out and talked to them. For over an hour dealing with a Formal Complaint that I filed. Then they left and the Assistant warden came in to talk to me. We talked about 15 minutes. He and I reached an understanding. He assured me there would be no retaliation. Now I want to lay back down for a while.

Wednesday Dec 10, 2014 6:05 am. Been up since 3:30. Washed up cleaned the cell made the bunk. something every morning, seen the nurse she was telling me what I would need to do to get out of this cell. But I don't want to move out of this cell. This is a bigger cell and the two empty cells down here are not cells that I want to be in. 6:15 my old cell right on the back door and with Doug next to me, no way!" Guy's don't want to live around him. The other cell is behind me on this wing. again its

a smaller cell. Well I need to do some writing. I'll go to see the Doctor this morning.

10:40 am Back From seeing the Doctor. My blood pressure was 128/82 so it's better than it's been since May. Nothing else has changed. I got some Christmas cards ready to go out and wrote one letter to Ann.

11:09 am MP3-guy just picked up my player. said he's taking them over to Lake Butler. Cause he can't get into the room down there because he no longer works for TeeFe. I just want to get my music back on my player.

2:54 PM sent another Christmas card to Addie. Breaks my heart that she's going to die 6 yrs old and this is her last Christmas. Life is so unfair.

4:39 PM Ate hot dogs for dinner I'm going to walk for a few minutes then lay back and watch the news.

6:51 PM Back from the shower going to lay down watch TV. Survivor at 8 PM then I'm going to bed.

Thursday December 11, 2014 7:02 am. Been up since 5 am. My stomach is burning. I've been throwing up. I feel bad.

Friday Dec 12, 2014 6:53 am. I just finished writing a blog post common stupidity. I was suppose to go to Rmc. but this Sgt whose too brain dead to do his job resulted in my not going. so wrote that blog.

post and 2 grievances. yesterday I was sick as a dog. stomach was on fire. I may have gotten Food poisoning. I ate some chicken on wednesday that we were served on Tuesday. First time I ever tried that. and its the last time I'll ever try it. Not sure if that's what it was, but I was sick as a dog yesterday. They have that Christmas party today. They will not allow them to come over here. D.C. wing. I need to walk for a bit then do some writing.

9:43am. watching RTM. was told to get dressed in Class A visitors in the building. Its the Christmas party visitors. I'm dressed. I wrote one letter this morning. my stomach is burning again. I dont know what's going on with this. wish it would have started on wednesday morning when I went to see the Doctor. Now its going to cost \$5. to see the nurse.

1:48 PM. Back From seeing Father Conrad He couldnt stay very long. They had the Christmas party thing, they did not come down here on this wing. why? Because this is a D.C. wing. which I'm going to address in a request and then send it to the Inspector. to prove my point that this is a D.C. wing. which he tried to say it wasnt.

2:31 PM. Sgt. just brought down the canteen/Christmas bag. wasnt anything special in there other than a block of cheese. I'd love to have more of that cheese. But they didnt

4:39 PM. Ate sausage and cheese for dinner I'm going to walk for a bit then watch the news and wait on the shower.

7:11 PM. Back from the shower. I'm going to lay down and call it a day.

SATURDAY December 13, 2014 6:40 am. Finished washing my sheets. got them drying. my stomach is still hurting. well I need to walk for a bit, then do some writing, and maybe exercise.

8:46 am. sheets are dry beds made wrote a couple of cards, to try to get Addie more cards.

7:40 PM. Been along day, stomach is still hurting. I'm going to be up until 10 PM. watching UFC on Fox.

Sunday Dec 14, 2014 8:04 am. Finished bathing. Going to watch GMA and wait on the visits.

2:43 PM. Back from the visits, had a good one. The canteen out there was the same, except they now have salades. I'm going to lay down and watch Football.

It was really nice outside. But standing up for 3 hours is rough on my back. I hope this pain eases up. I'm going to lay down, watch some TV, and then go to sleep. Hope for some mail tonight.

Tuesday December 16, 2014 5:00PM. Been a very interesting day. I went to the law library. That crap that was Filed in the Court was not Filed by the person I thought it was. This idiot Miguel Oyola in cell P-4103 placed my name and two other inmates names in this document calling the warden a bitch and making all types of threats. He's trying to get us all screwed up. So I've got to write the Court, warden and Inspector General to get this crap straightened out. When I got back to my cell I comp-

Thursday December 18, 2014 5:00 PM. Went to recreation today. Came back in and the sgt told me that he spoke with the Assistant warden and they're going to move me tomorrow.

Friday December 19, 2014. 7:22 PM. Just got back from the shower. I went to RMC medical center in Lake Butler today. Woke me up at 1 am. Didn't leave out of here until 6 am.

Stayed over there until about 11:00 got back and sgt had moved me to cell P-6126. I was hoping to go to P-4119. Oh well. This guy next to me I don't care for, he's loud. I had to start cleaning this nasty cell. I have a lot of work to do. This cell is nasty!" I seen

Father Conrad at 1 PM. I want see him for 3 weeks. I'm tired and going to sleep right now.

Saturday Dec 20, 2014. Been along day. Been cleaning this cage. My back is hurting really bad. I about have the cell walls cleaned.

Sunday December 21, 2014. Had a good visit with mom today. Came back and watched some football. My back has been hurting all day. I did way too much yesterday. I'm going to call it a day.

Wednesday, December 24, 2014 went to recreation and came back in and exercised. All I did outside was watch them play basketball. Just got back from the shower, now I'm going to bed.

Thursday, December 25, 2014. 8:15 AM. Been up since 2:30 Got out of bed at 4 AM. Sheets are washed. Clothes, everything's dry, beds made Floor and walls are cleaned as well as the bars. I need to do some writing and exercise. I've been on a strict diet. I stay hungry. Been drinking a lot of water. 7:50 PM. Watched Basketball both the teams I like won. OKC and The Heat. Going to bed.

December 26, 2014 Friday. Been an uneventful day. I exercised there's no mail today. Just got back from the shower. I'm going to bed.

Saturday, December 27, 2014 This day 27 years ago Paul, Dana Lisa and I was going to the DeF Leppard Concert. That was the last time we all hung out together.

Paul and Dan broke up a day or two after that. I've been watching some football. I haven't done much writing. I exercised, bathed, now going to bed.

Sunday, December 28, 2014 seen man today had a nice visit, one guy and his mother did some nasty crap, told on another inmate who got some good food. The Dolphins lost the last game, hopefully they will fire the coach and hire Jim Harbaugh. I'm tired, I've been up since 3:15am I'm going to bed.

Monday, December 29, 2014 just got back from the shower. I exercised this morning. Wrote one letter. Was hoping for rec going to sleep at 7:35pm.

Tuesday, December 30, 2014 went to the law library today and was suppose to see the nurse for sick call, she never showed. They called recreation this morning. I couldn't go because I was waiting to see the nurse. Canteen showed up this morning, HALF OF the items people ordered wasn't even there. I exercised wrote a piece for the blog "NO more comments". I wrote B.T.B. back in Nov. when I sent in please no more, and ask they shut the comment section down. It wasn't productive. Well I'm going to call it a day. Tomorrow will be my last daily journal.

wednesday December 31, 2014 4:30 am I got up at 3 am. washed up made my bunk. Cleaned the floor with a wet rag. Now I'm listening to music waiting on breakfast. Going to do some walking until it gets here.

5:24 am. Breakfast came I put the oat meal in a bowl. I'll eat it after I heat it up. I gave the coffee cakes away. I'm going to do some more walking. I didn't get any mail last night. This will be the last day for mail until next Monday. They have a 4 day weekend.

5:44 am. Here's the nurse with my baclofen. Just walking.

7:08 am. stopped walking about 15 minutes ago. wiped down the cell bars. I have a doctor call out at 1:30 pm. to see the psychiatrist. I'm hoping they call recreation this morning.

7:19 am They just called recreation, so I need to get ready to go.

10:51 am. Back in from rec, I'm the only one on this side that went out. I went out with 4 & 5 wing. I did some dips and pull ups. a lot of guys are sick right now.

11:13 am. Lunch just came. I ate oat meal. I don't care for them processed patties. I need to lay down. my back is hurting!

201 PM. Back from seeing the doctor. won't need to see him again for 6 months. Going

to eat a Tuna sandwich and take some meds.

4:15 PM. Dinner came about 3:55 I took the rice OFF the tray. I'm making a stew. I ate the salade. Foods cooking right now should be done about 4:45, 5 PM I'll eat then walk for 30 minutes. My back is hurting. Not like it use to. I'm going to have to get the meds raised. I hate being on this wing. Half the wing is idiots and their conversations speak for it. I've got to get OFF OF this wing.

5:08 PM. Finished eating, it was really good. Now need to do some walking for at least 30 minutes, which is difficult my back is seriously hurting. Pain level is at a 7 and staying there. Three hours standing on the rec yard and being out of the pain OFF is the problem.

5:47 PM. Walked for just over 30 minutes while listening to the music. then wiped the floor down. I'm going to watch some news then wait on the shower.

8:12 PM. Just got back from the shower. Going to lay down and go to bed. I haven't stayed up for new years since the mid 90s. Nothing special about it. Well this is the end of my daily journals. From here on out it will just be blog post. with that I say good bye to 2014.
