Friday 13th Nov. 1998 I was victimized by a racial profile stereotype hoax. Paula M. Koehn 17 dob 3/29/81 708 S. Spring St. Beaver Dam WI. Ph: 920-885-4847 lied filing a false police report. She claimed stranger abduction by pimp off State St. Madison WI. for 12 hour period midnight Nov. 8 Sunday until noon Nov. 9 Monday with an act of fellatio. Events which never occurred. Due to an alleged 5 day delayed reaction in reporting it prevents dna swab, sexual assault kit sample of her mouth.

University of Wisconsin Innocence Project refuses assistance because no dna evidence and thus far Paula Koehns unwillingness to tell the truth and recant her lies.

Chronology

Oct. 29, 1998 from Des Moines Iowa I arrived to Madison WI. Saturday Nov. 7 5:30 pm Jayson Brown and myself were on State St. when Paula Koehn would approach us and request \$10 to suck both of our dicks. I asked her how old she was. She said 19. I carded her. She was 17. I stated actually 17 is the age of consent. (which it is. see count 1).

We walked behind some buildings and she performed fellatio on each seperately.

The 3 of us separate individually leaving in our own directions. Later that evening while on State St. approximately 10:30 pm I'm walking with 2 UW students when Paula Koehn and Nicholas Winters a b/m friend of hers approaches us. Winters starts talking to both w/m's and Paula Koehn asked me if I wanted to cruise with her in her car.

I had never witness a cruise in Madison and to date I'm not aware of where, if any street, theres cruising in Madison.

I digress. I said Yes. She parked on East side near a soccer field. We talked. She told me about her son, father and sister. I was wearing 2 pairs of socks which made my shoes fit tight plus it had started snowing. I took off socks put back on shoes and placed socks under ventilation heat/air conditioner duct. She climbed over from drivers seat into my lap and arms for warmth. She asked me twice if I would marry her, both times I said, no because I don't even know you.

Keep in mind I recently seen her perform acts of fellatio on 2 penis, I'm not about to kiss her or anything else. We fall asleep. In the morning Sunday Nov. 8, 1998 my socks are wet because of leaking ventilation. I ask her to take me to laundry.

She takes me to East Washington laundry. I go in with her and with additional clothes in my back pack I wash a load. We go across the street to Burger King until clothes need to be placed in the drier. After dried she drops me off downtown Sunday Nov. 8 around 10:30am. I go to UW student Union and watch almost both games of NFL football. 6pm I left and walked up State St.

I hear Hay! My Nigger! I look in crowd. I'm walking with noticing I'm the only black man. So, I cross the street and it's 2 white guys. The main one being Steve Lewis who says he wants to sell me a \$10 bag of marijuana. Getting his partner in crime says it's a \$20 bag. I said "No it's a \$10 bag" and Steve goes into the alley. I follow mentioning that his coat is nice and I'll give him my coat; \$20 for the bag of weed plus his coat. We trade. I notice his shoulders will never fit into my coat so I speed up transaction.

I go to a homeless shelter sign in spending the night. Nov 3 I acquired a job at Professional Speaking Inc. needing to be at work 9am Monday Nov. 9. I arrive on time to work.

Nov. 12 100 block State St. Paula Koehns friends Kristin Durak Flw dab 11/23/81 318 Mohican Pass, Deforest WI. and Christopher L. Irons m/b dab 8/7/80 210 E. Badger Road Madison WI. were

arguing. Kristin called him a nigger. I didn't know they were Paula Koehns friends. I called Irons to the side making him aware that if your woman is publicly exercising racism against you rationally the relationship is doomed for failure.

Kristin Jurak Friday 13, 98 walks into Madison Police Dept files I false police report against me. Rides with an officer to Taco Bell on State St. where they find Paula Koehn who files report. Steve Lewis was approached Sunday Nov. 8 by police asking why he and Gatlin were arguing. That's when he filed his.

All three cases consolidated. At bench trial Judge was overzealous and myopic due to racist hyperbole. Verdict was credibility determination.
