On January 22 ,2015, the Executive office of Public Safety referred a letter to the Department of Correction from inmate Timothy Muise W65927, dated January 5, 2015. The content of the letter addressed to Governor Charles Baker included this statement: ?What I am suggesting is that you (Charlie Baker) come here to MCI Shirley and speak to a panel of prisoners about the corrections system. I can assist you in putting the panel together.? ?Thank you for your time and anticipated serious consideration in coming here to the prison to meet with a panel of prisoners. Please let me know what I can do to assist you in making it happen.?

Inmate Muise has been spoken with on May 24, 2013, and October 23, 2014, byDeputy Dinardo and Deputy Notice and/or Daputy. McCann respectively in regards to him not have the authority to invite community members into the facility. The process of extending invitations has also been reviewed with inmate Muise during these conversations. inmate Mulse Indicated that he understood this directive upon the conclusion of both of these meetings. above noted letter violates the direct order given to Inmete Mulse.
