down. an inmate, stabbed an inmate about 2 weeks
ago. Then last week another inmate pulled out
another shank. Then inmates over there are
just stupid! They are the worst of the worst.
not death row.

12:13 PM. It's raining outside, said there was 40% chance. OFFICER said canteen will not be coming today.

1:09 PM. They did recount, someone messed the count up. I'm washing some clothes. I heard the OFFICER are in V-Dorm now. I and V-Dorm are the worst two dorms here.

3:55 PM. Raining again. I'm not sure what to do next. I'm ready for this day to end. But I'm last in shower tonight, so I want get out of the shower until after 8 PM. Hope to get some mail tonight. I really need to get back to exercising.

4:24 PM. They are moving Hitchcock down to cell 5116. McCary went back to Disciplinary Confinement last Thursday, I knew that was going to happen.

4:56 PM just finished eating dinner, hot dogs. been watching criminal justice committee, nothing on the EDOC so far.

6:24 PM. They just started showers.

8:03 PM. Just got back from shower. I went over to 4 Right for shower. Going to bed now.

Tuesday April 14, 2015 4:58 am. Got up at 4 am. Washed up made the bunk cleaned the cell.

5:29 am Ate breakfast grits a sausage and a biscuit. The nurse just picked up my sick call slip. I'm writing a letter.

6:16 am. Been doing some walking. They should be coming around with cleaning supplies soon. I'll be glad when they fix my cell light. It's been

out for about 3 weeks now. The officers are opening the doors with the keys. They check them once a week, every Tuesday morning. I'm going to walk some more as I listen to music.

7:58am Did some walking, wiped the floor down again. Hard to see with no cell light. 4-wing is on the yard. I'm going to go back to this letter. Hopefully canteen will show up this morning. Was suppose to be here yesterday.

9:00am. Was writing. I'm going to watch RTM. then decide what to do next.

10:21am. They just came and fixed my light. so I now have a cell light after being without it for 3 weeks. I had started another letter.

10:51am. Canteen just showed up. was writing then went to do some reading.

11:39am ate, put the canteen items up. they haven't called us for recreation. I guess 6 wings going out. That means this will be 6 days without recreation. need to change that. This guy down the hall is driving me crazy. he cries about everything. when an officer comes by he has something to complain about. I've never seen anyone like this in my life. I'm really tired. Think I'm going to lay down for about an hour.

11:35PM. Laid down for awhile, then washed some clothes. just talked to the Christian volunteers not followers of Christ, just believers. Goats Mt 25:41-46

Tried to talk to them about contacting their

senator and House Representative one said no, the other was reluctant as well. one God one savior one church, the Catholic Church all these others are Satan's counterfeit Christian churches spread by false prophets who broke off from the Catholic churches.

4:02 PM. Just been laying here. Clothes are still drying, waiting for them to bring dinner. I'm ready to go to bed. I'll probably go to sleep by 6 PM.

4:50 PM. Finished eating going to lay down now.

6:48 PM. Going to sleep. I'm tired.

Wednesday April 15, 2015 5:11 AM. Been up since 3:30. It's been raining all morning. I made the bunk, washed up cleaned the cell. Made me two chicken onion and cheese sandwiches. We have coffee cakes for breakfast which I don't really care for. Should be seeing Father Conrad today, if he's feeling better. Also should have sick call this morning.

7:16 AM. Finished a letter I had started two weeks ago. I'm ready for recreation if they call us this morning. I'm going to walk for now.

7:30 AM They just called recreation. Need to get ready.

10:52 AM. Back in from rec just walked around and talked to a few guys. I've got to wash up. I'm going out to see Father Conrad at 1 PM. I need to finish a letter I'll do that when I get

back at 2PM. I'm going to fix a chicken sandwich for lunch.

2:39PM. Back from seeing Father Conrad, he's doing really well. He's no longer sick. I'm going to eat me a chicken sandwich now.

4:32PM. Dinner came I kept the bread rest of it went down the toilet.

5:18PM. Jose just came back from medical. He went up front for diabetes. I'm waiting on the showers now.

7:02PM. Back from the shower. I'm going to bed.

Thursday April 16, 2015 5:38am. Got up at 3:57 washed up made the bunk cleaned the cell, had a cup of coffee, watched the news, wrote a grievance.

7:46am just finished writing an article "The Golden Rule" for a Christian news paper. Not sure what I'm going to do to pass the day.

10:20am. Sgt. just came over the intercom and said get in our class A's that secretary Julie Jones is coming around.

11:25am. They just called us for afternoon rec. We still haven't seen Julie Jones. The Captain came through about 30 minutes ago. Looking in our cells. I hear the food cart over on 6-wing right now. I'm making a soup. Checking the weather to see if it's going to rain. And it looks like it's going to hit this area between 1PM and 3PM.

3:47PM. Just got back in from recreation. It drizzled but nothing serious. I was glad to

get out OF this cage for a while. I need to wash clothes. Fix something to eat. wash up. I heard Julie Jones never came on this side OF the building.

4:40 PM. Ate dinner, washed clothes and bathed, going to lay down now.

6:17 PM. I'm going to sleep.

Friday April 17, 2015 5:02 am. Got up at 3:48 washed up, cleaned the cell, made the bunk Filled out another sick call slip. I need to do some writing. This afternoon I'll be going to the law library.

5:42 am Here's breakfast. I've already started writing. The nurse came through said that I was being put into see the Doctor, so no need to put in a sick call slip. Back to breakfast then writing.

8:14 am. I'm number 12 on the law library. I cleaned the walls and bars then made a tuna sandwich which I'm eating right now. I heard I am on the sick call list this morning, so waiting for them to call me for that.

9:26 am. They moved Hitchcock over to 4-wing cell P-4126. Chase had a good neighbor and lost him. I'm watching RTM and writing a letter.

11:01 am just watched the rerun OF the House sub committee on CS/HR-7131 From 9:00 am on April 14, 2015 you can watch it by going over to The FLORIDA Channel.org and typing in the date or Bill I'm going to write them about that.

6:30pm. They just started showers.

8:13pm. Got back from the shower. I'm going to sleep. I've got a lot of work to do tomorrow.

Saturday April 18, 2015 4:53am. Been up since 3:23 washed up cleaned the cell, had a cup of coffee made the bunk, it's too humid to wash sheets in here today. I still have clothes that I washed yesterday that I haven't dried.

8:47am. Been writing all morning trying to get people to contact their senator and House Representative. I've got so much more to do on this.

10:53am. Been writing to the Bishops a judge and several other people. I stopped and cleaned the floor. I'm going to do some walking here

shortly. I've got the Fan blowing on the Floor trying to get it to dry. Humidity in here is really bad. I'm not sure what I'm going to eat today, both of the meals are nasty.

12:02 PM. Had tuna sandwiches for lunch. need to do some art work today and get some more of these letters going out.

3:28 PM. Did some work on a picture. I'm going to watch some basket ball.


6:03 PM. The UFC/MMA Fights are about to start. I'm going to watch them. I made a bean's + Rice (Canteen) for dinner. I don't care for that tray. Well Fights are starting.

10:08 PM. The Fights just ended. I'm going to bed.

Sunday April 19, 2015 4:43 am. Been up since 3:30. washed up had a cup of coffee, made the bunk cleaned the cell. The hall lights just came on. They don't usually come on until after 5am.

5:06 am. was trying to watch Father Cedric but digital break up. This whole T.V. system is just garbage. 21.1 is also out, so no mass this morning. we need EWTN. I've got so much going on that I'm trying to do.

6:26 am. wrote two request slips to the warden one about getting the cables fixed, the other about getting EWTN Catholic Net work you can see that on line at ewtn.com. I then shaved, 21.1 is coming in and out. I'm going to try to watch the mass. you can see
