A little more stupidity by FDOC staff. where I'm facing verbal assaults, because I'm trying to change the rules, to better the conditions here on death row, and through out the Florida Dept of "corruption." well, I look forward to SB-7020 taking place and the Pilot program here at Union Correctional Institution (UCI) taking place and putting these Body Cameras on these staff members. cause then, and only then will they begin to act like professionals. only then will they follow the rules of conduct. only then will they stop this verbal assault. yes - body cameras is going to change this place for the better.

Not sure if you know my history, but in 2011 I was blogging on another site exposing the unethical immoral Correctional Officers here. From the warden all the way down. This resulted in me being placed in strip cells on three different occasions. No mattress no blanket nothing but a pair of underwear. on one of those I was in R-Dorm medical, they turned the air conditioning up full blast, I was freezing cold. you talk about torture, that was cruel and inhuman, but the warden B.V. Reddish was a cold blooded heartless hum-

an being. men were beaten and killed under his watch. In May 2012 I was assaulted by Correctional Officers twice. The first assault I was handcuffed behind the back, and my head was rammed into the concrete wall. The 2nd assault that happened a couple of weeks later, I was handcuffed behind the back waist chain black box shackles on my legs. It was 1:30 am I was taken out to see the nurse, when they brought me back, there was 3 or 4 Sgt. half dozen Officers and an Lt. When they got me in the cell, one of the Sgt's said, "Blog about this!" And they began throwing punches beating me down. The Lt then said, "That's enough." They stopped the assault picked me up took me to the door and took all the chains off. I reported these assaults to the Inspector General F.S. 944.31. They sent an Inspector here, who was our property Room Sgt. in 2009-10 and who Warden Reddish had promoted to Lt. so this was Cronism at its best. The Inspector rubber stamped the investigation. Never interviewed the inmates on the wing who heard the punches being thrown. Never examined the video and asked why it took a dozen staff members to pull a sick inmate out for medical. For the camera would have also shown only 2 Officers pulling me for call outs, before the assault and after

the assault. so then sgt's CO's and the Lt. would have had no explanation to why they were all there. To why it took so long in my cell to get the shackles OFF. And why they were gathered around my door looking in. For not all the OFFICER'S could get in the little cell. But they in the hallway, wanted to see what was taking place. A bunch of low life criminals posing as law enforcement. And I didn't get assaulted because of my mouth. I got assaulted over what I was writing. I also was set up with 9 DRS two of which staff smuggled Razor Blades, weapons into P-Dorm Death Row Housing and used them to falsify a state document. Two crimes they jeopardized the security of death row bringing a weapon in, and falsified a state document. to keep me on D.C. I stayed on D.C. From May 20, 2011 until Dec 2011. They let me OFF and then in late April 2012 wrote another fraudulent D.R. saying they found cigarette tobacco. which was bull! so they kept me on D.C. From May until Oct 2012. I tried to get a polygraph test or voice stress analysis, to prove these staff members were a bunch of lying low life criminals that lacked any type of honor and integrity.

Lately I'm just dealing with treats and verbal assault's. one sgt. said I better fear him and

every one else better Fear him as he made reference to the three KKK OFFICERS who was going to kill the inmate who was now released you can read about this and the other prison abuse at <http://www.miamiheard.com>. you can read about inmate's being burned to death in a scalding hot shower, gased to death, beat to death. This place is no joke, which is why I'm Fight For Change cause God Knows we need it!" we need staff to take annual polygraph test/Voice stress analysis to ensure they are abiding by the rules of conduct 33-208.002. And the law abiding staff which we do have, will have no problem taking a test stating that they abide by the rules. That they have not smuggled drugs or weapons into the prison, and that they have not abused inmates. It's only the lowlife Criminals in brown who will protest. For this will stop the illegal profit off of Contraband.

yes - I'm expecting more verbal attacks possibly I.R.'s. For standing against this corruption. And I'll continue to write about it, because that's what I do.

I am looking forward to the implementation of these body cameras. For it's a good start, but not nearly enough. Annual Polygraphs is the key. God bless you. And Fight the good Fight, For Christ was about action, not words.
