also ensure body cameras are on all officers
here at UCI even P-Dorm. I need to stop
and eat.

9:23 am Doctor just came through I stopped her
and spoke with her. she said she would see me
on Wednesday. I'm still writing as I
watch RTM.

11:00am Lunch came peanut butter sandwich I gave it away. Fixing to write to a senator about these body camera.

11:20am. They just called us for afternoon recreation. so I need to get this letter written and then eat.

11:55am Finished the letter to senator Joyner. now need to eat.

12:40 PM Writing on recreation should be here soon.

1:17 PM. I was getting ready for recreation this sgt whose been harassing me shows up and starts sexually harassing me. so I just stopped to write a grievance. Now I'm going to have people send e-mails. This has got to be stopped.

3:49 PM. The guys came back in from recreation I've written two grievance's, 2 e-mails for friends to send and a letter to the Chief Inspector General. I'm going to stop this once and for all. I'm tired of this sgt. sexually harassing me, threatening me and acting like an idiot. just like I said, the hiring of staff for the EDOC, the bar is extremely low! "all you have to do is breath, and more, you qualify, your morals, your integrity, means nothing!"

4:30 PM. Canteen just showed up. Dinner came by 20 minutes ago. was really nasty. a processed patty. I ate a piece of it, the rest went down the toilet.

5:50 PM. Just waiting on the shower now. Canteens put up. I heard the sgt's and cos were sleeping on the yard today, that's why they didn't want me out there. Sgt. Blue ate a bag of corn chips and had a soda was sitting on the left hand side of the bench had his sunglasses on and was dead a sleep with the other sgt and a co. all the death row inmate's was left unsupervised. They should have known I was going to find out. I find out all types of stuff. There's a staff member in here who has established an outside relationship with an inmate's family member. And the stupid thing is, there's a record of it, of text messages. Which is a serious violation 33-208.002 (26) It an offense that will get you fired!" some of the things they do, to risk their jobs, such as stealing from inmate's usually 3 \$15 in canteen. or charging us for extra rec yards among other things is just really stupid. one staff member charge's for cell change's among other things. The corruption just here in P-Dorm is deep. But this is the Florida Dept of Corruption.

8:13 PM. Back from the shower. went to 4-left which is the DC wing had oven. I'm going to bed.

Tuesday April 28, 2015 5:04 am. woke up at 4am. Didn't sleep good last night. woke up several times. Plus I got a letter in, that disappointed me, my own fault. I listened to some one else then

7:33am. Legal mail lady just picked up my letter to the Chief Inspector General and senator Joyner wrote 2 letters and rewrote the grievance. I need to do some more writing.

8:43am. My Classification Officer just picked up the grievances. The C.O. with her whose a yard officer said, "The usual suspect." I'm writing.

10:02am. Watched RTM I got a couple of cards ready to go out. I'm going over to watch some of the House or senate. I need to do some more writing also have to wash some clothes.

11:01am. Lunch is here I'm not eating it. Working on a letter to House Rep Rowson.

11:38am just finished this letter to Rep Rowson. I'm determined to bring change. I need to rest, my eyes hurt, my hand hurts I just need a break.

1:12 PM. They just did recount, some officer messed up the count once again.

4:23 PM. Just had a piece of chicken + rice and seen the House of Reps has shut down killing SB. 7020. Politics is real garbage. We need the health care and the body cameras ect. This is bull leave it to the Republicans to mess everything up. This is Republicans shutting the House down because their not

I heard all cell moves have come to a halt because of this blog post from Feb 6. Also while I was out there, sgt Blue come out there ranting and raving about me filing grievances on him. Their going to wind up beating my butt. warden Andrews is keeping it from happening right now, but these sgt's are getting mad, and their going to step over the line and assaulting me. one of the assaults from 2012 may, was by a sgt who lost his temper over this blog and ran me head first into a concrete wall. so it's only a matter of time before it happens again. Yeah I should be concerned. Cause it's getting very heated around here.

2:34 PM. was writing a blog called Attention secretary Julie Jones. when the senate brought forth SB-9020 and killed it, the House had messed it up any ways. so no protection for another year. And right now I need some protection, Cause they are seriously mad with me. I'm expecting them to set me up any day now with a DR. Their looking for anything to get me on.

4:32 PM. Had hotdogs for dinner. Now just waiting on the showers. I may stay up and watch survivor.

5:48 am. wrote two grievances and my statement for this disciplinary report that I know their going to bring. Breakfast is just coming down

9:20 am. spoke with the Sgt. called a truce. all this stuff I've been writing will now go in the trash. I need to write the Bishop about the body cameras ect.

10:34 am. wrote the Bishop about that stuff I'm trying to get into a senate or house Bill.

12:01 PM. just finished eating Rice & beans. Lunch was late. I was listening to music walking. still wondering if they will come with a DR. I was told that the Captain has ordered them officers to leave me alone. That's the word.

4:25 PM. They just brought dinner, only thing I ate was beans. I was really tired. I fell asleep at around 2 PM. I only got about 5 hours sleep last night. I watched survivor, stayed up for master count at 9:30 and then laid down. That's why I'm so tired today. I didn't get half
