In their infinite wisdom here at the gulag the powers-that-be have decided to cut costs by eliminating Potter's Field and initiating the Kinder-Garden Garden Program.

This innovative initiative will allow the bodies of the dying aging prisoner population to be buried and used as fertilizer for a new vegetable garden outside the Lifers and Long-Termers Death Chamber: Unit D-1.

The reduced cost from eliminating caskets and grave markers will be used to purchase magic beans for the cost of one cow; quite a bargain by anyones standards. A Giant Deputy and Giant asshole will oversee the planting of both bodies and seeds.

What follows is a true and accurate copy of the "contract" the poor dying lifers in the Death Chamber will have to sign if they want sliced tomato on their humble pie.

Public Safety has moved forward by leaps and bounds, too bad it leaped and bounded right over commonsense and rehabilitation. Long Term Unit Garden and Outside Area Procedure MCI-Shirley

General Procedure: Place head between legs - kiss ass goodbye

The Garden Program is intended to provide D-1 inmates with an opportunity to learn responsibility and gardening skills while fostering positive self-esteem through teamwork with a group of inmates working towards a common purpose of planting and growing vegetables. It will also serve as a cemetery.

1. Access to the garden and outside area will begin June 8, 2015. D-1 inmates only. (Death Chamber)
2. The garden plots will be on the west side of D-Building in the authorized area. 3-4 inmates per plot. Those inmates will also be buried there when they die (no charge).
3. The garden area is OUT OF BOUNDS for inmates not participating in the program and for all inmates when the program is not active. Only exception is if you are dead and buried.
4. Inmates are not authorized to enter into any garden plot not assigned to them penalty of castration.
5. Items grown in the gardens are for personal consumption of the inmate participants and not to be given away, sold or traded. Storage of plants or seeds in the cell is prohibited and will be considered contraband. Please try not to consume the bodies of the dead lifers.
6. Gardens will be closed and all cleaned up is to be completed by October 15<sup>th</sup>. Clean up includes removal of debris and recycling dead plants back into garden soil. No compost piles. No headstones.
7. The Walks & Grounds Officer assigned to the garden program will issue the program rules to all participants. Participants are responsible for knowing the rules and to sign a garden agreement form with the Officer. You must also kiss his ring and open his beer cans (Natty Ice)
8. A list of inmates involved in the garden program will be compiled and provided to the D-1 Unit green thumb Officers, Shift Commanders, Walks & Grounds Officer, Unit Team and D-1 unit bulletin board. (Death Notice)
9. The Walks & Grounds Officer shall distribute authorized plants/seeds equally among the garden kiss ass participants. These are the only items allowed to be grown. With the exception of Cannabis Sativa.
10. The use of fertilizers or insecticides not specifically issued by the Walks & Grounds Officer for use in the garden is prohibited. You can use the dead bodies as fertilizer and tomato posts.
11. All items grown are provided at no cost to the inmate participants. There will be no restitution of any kind for any item lost or damaged as part of MCI-Shirley's operational process, (searches, anal probes, segregation placements, etc.) or due to theft by other inmates. Please chew the cucumbers.
12. No inmate will keep an abundance of vegetables in their room, they should be consumed as picked (within 24 hours) during the growing season. Use as a dilda/dildo is prohibited.
13. The Walks & Grounds Officer assigned shall inspect the garden no less than weekly. No plant is to grow over 4 ft. in height. Security issues shall be documented. The King will author reports.
14. No items may be left or hidden in any garden plot, nor may items be used that were not specifically issued for gardening purposes. No plants taller than Sgt. Young or wider than deputy DiNardo will be allowed. Free suboxone will be issued to address hay fever and "antibuse" will be distributed to King of Walks & Grounds for sobriety.

- 14(a). We have assigned the biggest con hating guard to be in charge of the program so expect to get lugged over some tomato plants. We have <sup>des</sup> destined the program to failure and anticipate the "lifer" cemetery to be the most successful aspect.
15. Tools and watering cans may be drawn in the unit by leaving the inmate ID. One tool or watering can per inmate only. You will be responsible for returning the tool or watering can, no handing off to others. These cans are dangerous and there must be accountability.
16. Inmates will be removed from the gardening program upon a guilty finding from a disciplinary report or violation of the garden program rules. Participation in the garden program is a privilege and the Administration may use its discretion to remove any inmate from the program at any time whether or not a disciplinary report has been issued. You may though sign a statement which states, "Shove this fucking garden program where the sun don't shine you abusive and twisted Nazis. I ain't drinking the kool aid and put away the Pixie Dust."

I understand the procedure and rules of the program: and that I will die in prison and be burried in the garden for all eternity. I agree to be used as fertilizer.
