

PREGNANT IN PRISON, CAN BE A DEATH SENTENCE

HI, I HAVE A DIFFERENT TOPIC TO TALK ABOUT TODAY. ONE THAT DOES NOT GET ENOUGH ATTENTION. PREGNANT WOMEN IN PRISON. NOW I DON'T CARE WHAT THEY DID TO GO TO JAIL, IT SHOULD NOT BE A DEATH SENTENCE FOR THEM OR THEIR UNBORN BABY. WE ALL MAKE MISTAKES AND I AM SICK TO DEATH OF ALL THE JUDGMENTAL PEOPLE ACTING SO HOLIER THAN THOU. I WANT YOU CHECK OUT THIS SITE, RHREALITYCHECK.ORG

READ UP ON IT. PREGNANT WOMEN GO TO PRISON EVERY DAY AND SOME LOSE THEIR LIVES DUE TO POOR MEDICAL TREATMENT IN PRISON. ALOT OF BABIES END UP DYING TOO. ALL SO SOME MULTI-BILLION DOLLAR PRISON MEDICAL CARE COMPANY CAN SAVE MONEY. MY HOME STATE, PENNSYLVANIA, THE PRISON MEDICAL CONTRACTOR HAS A POLICY CALLED "THE ONE GOOD EYE POLICY". THEY ARE CURRENTLY BEING SUED ABOUT IT RIGHT NOW. IF YOU HAVE 1 GOOD EYE, THEY DO NOT CARE WHAT HAPPENS TO THE OTHER ONE. A MAN HAD CATARACT SURGERY, THAT EYE WAS OKAY NOW BUT STILL DAMAGED, THEN THE OTHER EYE GOT CATARACTS AND HE WAS ALMOST COMPLETELY BLIND. SO A BUNCH OF LAWYERS STEPPED IN AND FILED A LAWSUIT OVER THIS MAN GOING LEGALLY BLIND BECAUSE SOME PRISON MEDICAL COMPANY WANTED TO SAVE MONEY TO MAKE THE RICH EVEN RICHER.

THE WOMAN I WANT TO TALK ABOUT THOUGH, HER NAME IS LAILA BATTS. SHE WAS LOCKED UP FOR 10 DAYS IN A WOMENS JAIL FOR WRITING BAD CHECKS IN ORDER TO PAY SOME OF HER HOUSE BILLS. READ HER STORY ON THE ABOVE MENTIONED WEBSITE. LAILA RECEIVED THE WORST MEDICAL CARE POSSIBLE AND SHE ALMOST DIED, AND HER BABY DEFINITELY DIED. NO AMOUNT OF MONEY FROM A LAWSUIT CAN REPLACE THE CHILD THAT SHE LOST. MY OWN COUSIN DESIREE, HER BABY BOY WAS BORN DEAD. THE DOCTORS CRUSHED HIM WHILE PULLING HIM OUT. HER INFANT SON WAS KILLED AFTER BEING CRUSHED BY DOCTORS. SURE SHE RECEIVED A LAWSUIT SETTLEMENT BUT THAT MONEY DOES NOT BRING BACK HER SON WHO WOULD BE 9 TODAY.

LET ME TALK ABOUT TRACY LEE VEIRA. IN SEPT. 2009 SHE TURNED HERSELF IN FOR A WARRANT. WANTING TO FIX HER LIFE AFTER YEARS OF DRUG ADDICTION. TRACY WAS ADDICTED TO A EXTREMELY POWERFUL PAIN KILLER, OXYCODONE. THE JAIL REFUSED TO GIVE HER ANYTHING FOR HER WITHDRAWAL SYMPTOMS. FOR DAYS SHE DID NOTHING BUT THROW UP. SHE COULDN'T EAT OR DRINK ANYTHING., MEDICAL REFUSED TO HELP HER. AFTER 3 DAYS OF NO FOOD OR WATER, THEY MOVED HER TO THE HOLE. THIS STORY IS HEARTBREAKING. FOR THE NEXT 4 DAYS TRACY BEGGED GUARDS AND MEDICAL TO HELP HER. TRACY WAS UNDERGOING A VERY DANGEROUS DETOX. ON SEPT. 16, TRACY WAS FOUND DEAD IN HER CELL IN THE HOLE. AN AUTOPSY LATER FOUND THAT SHE DIED BECAUSE HER DIGESTIVE SYSTEM WAS SO DEHYDRATED, IT SHUT DOWN. TRACY LOST 20 POUNDS IN 1 WEEKS IN THAT PRISON THAT MURDERED HER. TRACY LEFT BEHIND A 7 YEAR OLD SON WHO ASKED WHY DID MY MOMMY LEAVE ME AND GO TO HEAVEN? IN PRISON WE ARE GIVEN THE WORST MEDICAL CARE POSSIBLE. BUT I DO BELIEVE THE WOMEN HAVE IT EVEN WORSE THEN THE MEN. RHREALITYCHECK.ORG HAS SO MANY OTHER HEARTBREAKING STORIES TO READ UP ON AND LEARN. WE MAY BE IN PRISON BUT WE STILL DESERVE TO HAVE DECENT MEDICAL CARE. I DON'T AUTOMATICALLY DESERVE TO DIE JUST BECAUSE I'M IN PRISON. HERE'S A FEW: TENNESSEE, 2004,

MEREDITH MANNING, 23 YEARS OLD, BEGAN TO MISCARRY. MEDICAL STAFF REFUSED TO TREAT HER FOR 2 DAYS. SHE CONTINUED TO BLEED & BLEED. THEN SHE WAS TAKEN TO THE HOSPITAL WHERE HER SON WAS BORN & THEN DIED. SHE RECEIVED \$250,000. SO THATS SAYING YOUR SON'S LIFE WAS WORTH \$250,000. THATS IT.

SHELA WILLIAMS, TEXAS 2014. 4 1/2 MONTHS PREGNANT. SHE HAD A HIGH RISK PREGNANCY BUT RECEIVED LESS THEN ADEQUATE MEDICAL CARE. WHEN S DOCTOR FINALLY SEEN HER, HE SAID YOUR CHILD WILL NOT SURVIVE, IT'S BEEN TOO LATE. HER CHILD WAS BORN DEAD AND THEY DIDN'T EVEN ALLOW HER TO GO TO THE FUNERAL.

TIFFANY POLLITT, PENNSYLVANIA 2010, TIFFANY WAS PUNCHED IN HER PREGNANT STOMACH BY ANOTHER PRISONER, SHE REPORTED THIS ASSAULT TO STAFF & MEDICAL BUT WAS NOT TAKEN SERIOUSLY DESPITE THE FACT THAT SHE WAS IN SERIOUS PAIN. PRISON STAFF TOLD HER TO "GROW THE FUCK UP". SHE WAS RUSHED TO A NEARBY HOSPITAL AFTER HOURS OF NON-STOP BLEEDING WHERE HER BABY WAS BORN DEAD.

THE FINAL ONE I WANT TO MENTION IS 18 YEAR OLD COUNTESS CLEMONS, SHE WAS IN A TENNESSEE COUNTY JAIL WHERE SHE STARTED TO MISCARRY. 3 HOURS AFTER INFORMING MEDICAL STAFF, THEY DECIDED TO TAKE HER TO A HOSPITAL WHERE HER BABY WAS BORN DEAD. SHE SETTLED THIS LAWSUIT FOR \$690,000 & THE PRISON CORPORATION, CORRECTIONS CORP. OF AMERICA WAS SANCTIONED FOR DESTROYING VALUABLE VIDEO EVIDENCE WHICH WOULD HAVE SHOWN NEGLECT IN THE DELAYING OF TREATMENT WHICH COULD HAVE SAVED THE BABY'S LIFE.

BUT WE'RE IN PRISON & OUR LIVES AREN'T WORTH MUCH. THINK WHAT YOU WANT BUT PEOPLE DON'T DESERVE TO DIE JUST BECAUSE THEY MADE A MISTAKE & WENT TO PRISON. ESPECIALLY UNBORN BABIES. BUT NO ONE SEEMS TO CARE BECAUSE IT'S NOT THEIR BABY, IT'S JUST THE BABY OF SOME GIRL IN PRISON. THATS THE WRONG WAY OF THINKING.

ON ANOTHER NOTE, MY MOM CONTINUES HER FIGHT AGAINST CANCER. MY MOM, BEVERLY BROWN, COULD SURELY USE SOME EXTRA PRAYERS FOR HER HEALING & RECOVERY. MY MOM IS NOT ME & SHE DOES NOT DESERVE THIS. SHE IS A WONDERFUL WOMAN WHO WANTS NOTHING BUT TO ENJOY HER GRANDCHILDREN, FEED THE DEER & SHE LOVES FEEDING THE HUMMINGBIRDS & SHE IS ALWAYS HELPING SOMEONE. I PRAY FOR HER HEALING MANY TIMES EACH & EVERY DAY.

WELL I GUESS THATS ALL FOR NOW. CONGRATS TO THE WOMENS USA SOCCER TEAM WINNING THE WORLD CUP. I WATCHED EVERY MATCH & CHEERED FOR THEM THE WHOLE WAY. MY PHILLIES STINK SO I GOTTA HAVE SOMEONE TO CHEER FOR. TAKE CARE, ENJOY THE SUMMER, FALL WILL BE HERE BEFORE WE KNOW IT. GOD BLESS, CIAO.
